

GRAND MASTER'S ADDRESS.

Officers and Brethren of Grand Lodge:

Another year has passed, it may be too quickly with some of us, and we meet at this Thirty-eighth Annual Communication of the Grand Lodge of New Brunswick, to which I extend to you a most cordial welcome, with my sincere desire that in all our deliberations for the prosperity of the Craft in this jurisdiction we may have the guidance and direction of the Supreme Ruler of the Universe, so that all may be done to His honor and the advancement of the true principles of Freemasonry.

The year just passed has been an uneventful one in the history of Freemasonry in this province.

It is very satisfactory to be enabled to report that no complaint has been received from any Lodge or Brother: Peace, Harmony and Brotherly Love prevail throughout the jurisdiction; a condition for which we cannot, indeed, be too thankful.

From the reports of the Grand Treasurer and Grand Secretary, you will find that the Private Lodges are in a vigorous and healthy state, and that Grand Lodge financially and otherwise is prosperous.

Our relations with the other Grand Lodges with whom we are in correspondence continue to be of the most friendly nature.

FRATERNAL REMEMBRANCE.

It is not to be expected that a year will pass without Death—that grand leveller of human greatness—entering our ranks and taking from our midst some beloved Brothers, to gain admission, we trust, into that Celestial Lodge above where the Supreme Architect of the Universe presides.

The past year, like most of those preceding it, leaves us to mourn in sorrow the loss of some whom we were wont to meet annually in Grand Lodge, but whose places are now vacant forever

Brother Granville Chase, Past Master of Alley Lodge, No. 14, died at his home in Baring, Me., on November 24th, 1904, aged 53 years. In his death, the brethren of Alley Lodge have sustained a great loss; for he was deeply interested in its welfare, an earnest worker in its interests at home and its courteous representative abroad. He was amiable in intercourse, generous in charity and patient in the long illness that ended his useful life. To his business enterprise and ability, the little border towns of Upper Mills, N. B., where the Lodge is situated, and Baring, Me., where he had established his business and made his home, and where others of its members live, owe their present prosperity, to a very large extent; for he furnished employment to men who must otherwise have left their homes to look for work, and brought in others to make new homes among them. His funeral was conducted under the auspices of Alley Lodge, and many members of the Craft from other places were present to pay their last tribute of esteem to so worthy a brother.

The roll of Carleton Union Lodge is reduced by the death of two members, who were members of Grand Lodge. Worshipful Brother Richard N. Knight died February 4th, 1905, at the age of 73 years. The son of Rev. Dr. Knight, a well known Methodist clergyman in these Maritime Provinces, Brother Knight had received careful training and a good education, and when in the prime of life was a man of considerable intellectual vigor. For years he was an active citizen in St. John West, and was much interested in public undertakings. He was initiated in Carleton Union Lodge in October, 1859; was its Master in 1869, and was Assistant Grand Director of Ceremonies of Grand Lodge in 1870. He

took great interest in his Lodge, which he attended constantly for many years, until indeed failing health prevented him. His membership was retained until his death. The fine hall which is owned by Carleton Union Lodge was erected during the time Worshipful Brother Knight was Master and otherwise active in the Lodge. As Chairman of the Building Committee, he gave the work most constant attention, and the structure is a memorial to his memory.

Right Worshipful Brother Samuel L. Brittain was initiated in Carleton Union Lodge in 1848, and was its Master in 1857. He died June 2nd, 1905, at the age of 84 years, and in the fifty-seventh of his membership. Brother Brittain was a constant attendant at his Lodge, and was devoted to its interests. In 1886 Grand Lodge conferred on him the rank of Past Junior Grand Warden in acknowledgment of his services to the Craft. Brother Brittain had served in the city government as Alderman on two or three occasions, and was held in high esteem by all who knew him, for his honesty and for his fidelity to his friends. He was a man of much originality and kind hearted to a degree. The memory of both of these Brethren may well be cherished by us all. They were both excellent citizens, who discharged faithfully their duties to their families, and to the community, earning the approval of their fellow men, and reflecting in their lives the teachings and principles of our fraternity.

At St. George on the 17th of April last, Past Master James Dodds, of St. George Lodge, No. 12, departed this life in faith and hope, leaving to his sorrowing family and friends the consolation that he had led an exemplary life, and had done much good in his native town. He was a member of the firm of Epps, Dodds & Co., granite workers, and was cut off in the midst of his usefulness, for he had only reached the age of forty-six years. Brother Dodds was initiated in St. George Lodge in 1883, and was its Master in 1891. He was an energetic worker, an affectionate friend and a faith-

ful Brother, who commanded the love of Masons, and the respect of the whole community.

Albion Lodge, No. 1, mourns the loss of one of its active Past Masters. Right Worshipful Brother George D. Frost passed away at his home in St. John on May 17th, 1905, cut off in the midst of his usefulness. Right Worshipful Brother Frost was initiated in Albion Lodge in 1884; was its Master in 1892, and was elected Junior Grand Warden of this Grand Lodge in 1897. Very early in his Masonic life, Brother Frost evinced a great interest in his Lodge and the fraternity, filling a number of offices, including that of Master, in a manner highly creditable to himself. He was a good ritualist, and in his visits to all parts of the province was ever ready to instruct and assist the Lodges. In all the sections to which I have made official visits, the members of the fraternity have expressed their sorrow and regret for his death, and the loss to their Lodges of the kind and valuable assistance he so frequently and cheerfully gave them. Brother Frost was a regular attendant at all communications of Grand Lodge. By his death the fraternity lose a respected and valuable member. At the time of his death, Brother Frost was the representative near this Grand Lodge, of the Grand Lodge of Tennessee.

Woodstock Lodge, No. 11, has suffered a loss in the death of Past Master Charles W. Jenner, who died on June 14th, last, at Eastport, Me., where he had his residence for the past seven years, previous to which he had resided in Woodstock, N. B., for about seventeen years, and continued his membership in Woodstock Lodge up to the time of his death. Past Master Jenner was a most zealous Mason, filling every office in his Lodge; and was one of the brethren who accompanied Right Worshipful Brother James Vroom on his visit in March last to Grand Manan for the purpose of conveying my dispensation to Mananook Lodge. He was also regular in his attendance at Grand Lodge. He was buried at Calais,

Me., under the auspices of the St. Stephen Encampment, of which he was a member. Woodstock Lodge sent a delegation to attend the funeral.

I recommend that Memorial pages be placed (in our proceedings) in respect and honor of these departed brethren.

APPOINTMENT OF REPRESENTATIVE.

A communication has been received, dated Christiania, November 24th, 1904, announcing the death of Brother Johan Ernest Thorwald Ellingsen, representative of this Grand Lodge near the Grand Lodge of Norway, which sad event took place on 3rd October last; accompanying it were the names of three distinguished brethren, whom the Grand Master of the Grand Lodge of Norway, King Oscar II., was pleased to recommend, from whom to choose a successor to our late Brother Ellingsen.

A commission was accordingly issued to Brother Carl Marlin Hanson, of Christiania, as the representative of this Grand Lodge near the Grand Lodge of Norway.

VISITATIONS.

The time at my disposal did not permit me to make as many visits to the private lodges as I had hoped for.

My first official visit was made November 10th, when, accompanied by Past Grand Masters Walker and Forbes, Thomas A. Godsoe, Past Deputy Grand Master, and a full corps of Grand Lodge officers, I visited New Brunswick Lodge, No. 22. There was a large gathering of the members of the Lodge and visitors. With Worshipful Brother Alex.

H. Campbell in the East, the Entered Apprentice degree was conferred on four candidates in a correct, pleasing and solemn manner, which reflected much credit on the Master and officers of New Brunswick Lodge. The Rev. Brother Charles D. Schofield, Grand Chaplain-elect, being present, I duly installed him into his office. During the meeting refreshments were served and a very pleasant evening was spent.

On December 27th at the invitation of Worshipful Brother W. L. Ellis, M. D., I visited Albion Lodge, No. 1, accompanied by Past Grand Master Trueman and a full attendance of present and past officers of Grand Lodge, and with full ceremonial installed Brother Stewart Skinner, M. D., as Worshipful Master, and at his request also installed the Wardens and other officers of the Lodge. It was a great satisfaction to make my second visit as Grand Master to my Mother Lodge, and to learn officially of its continued prosperity and good Masonic works.

January 3rd, accompanied by Past Grand Masters Wedderburn, Ellis, Walker and Trueman, with a very large number of Grand Lodge officers and members, I visited St. John's Lodge, No. 2, and on the invitation of Worshipful Brother Dunbrack installed Brother Harry L. Ganter as Worshipful Master, and at his request installed the other officers of his Lodge. Although St. John's Lodge has passed the century mark of its existence, it is still in a most vigorous and prosperous state, with its officers and members ever ready to keep it in that foremost place which it has always held among the Lodges in this province. After lodge was closed a couple of hours were very pleasantly spent in the banquet hall.

January 4th, at the request of Worshipful Brother J. Edgar March, M. D., I, this evening, accompanied by Past Grand Masters Walker and Trueman and a full quota of Grand Lodge officers, visited the Union Lodge of Portland and received a most cordial welcome. Brother Bowyer S.

Smith was duly installed as Worshipful Master, and at his request I also installed the other officers of the Lodge. A very agreeable evening was spent. The officers and members of The Union Lodge of Portland are full of activity and Masonic zeal, and a year of prosperity may be looked for under the rule of Worshipful Master Smith.

January 10th. This evening, accompanied by Past Grand Masters Trueman and Walker, with full ranks of Grand Lodge officers, at the request of Worshipful Brother Fred C. Jones, I visited Hibernia Lodge, No. 3, and installed Past Master W. Alex. Porter, Past Grand Sword Bearer, as Worshipful Master, and at his request installed the Wardens and other officers. There was a very large attendance, and we were received in a hearty and cordial manner. It was a great satisfaction to me to see so many of the past officers and members of the Lodge present, and I predict for Hibernia Lodge a harmonious and prosperous year under the skilful guidance of Worshipful Master Porter. After closing the Lodge the remainder of the evening was agreeably spent at the festal board.

On the evening of January 12th, accompanied by Past Grand Master Walker and a full staff of Grand Lodge officers, I, at the request of Worshipful Brother Alexander H. Campbell, visited New Brunswick Lodge, No. 22, and installed Brother George Boggs as Worshipful Master, and also installed the Wardens and other officers. The cordial and brotherly manner in which we were received by the officers and brethren of New Brunswick Lodge on my former official visit, as also this evening, left nothing to be wished for; and from the activity and zeal of both the older and younger members I have no doubt this Lodge will continue to hold that high rank which it has justly held for so many years. Here we were also courteously entertained, and a couple of hours happily spent in speeches and songs.

Accompanied by the Very Worshipful Grand Secretary

and the Grand Director of Ceremonies, with Brothers George B. Hegan, Past Grand Warden, and H. S. Bridges, Past Grand Director of Ceremonies, I, on the evening of January 17th last, visited Lebanon Lodge, No. 28, at Sackville, and was cordially received by Worshipful Brother Thomas Murray and nearly all the members of the Lodge, as well as by brethren from Sussex Lodge, Dorchester, and Acacia Lodge, of Amherst, N. S. I installed with full ritual Brother A. B. Copp as Worshipful Master, and also the Wardens and other officers. Lebanon Lodge is now a live and active Lodge, with a goodly number of young members who are anxious to learn, and it speaks well for its future that every officer was present for installation. It was a great pleasure to again meet Right Worshipful Brother Daniel Jordan, P. G. W., who still continues that active work to which we are indebted for the present efficient state of Lebanon Lodge. We also had the honor of the company on this visitation of Right Worshipful Brother Duncan, Past Deputy Grand Master of the Grand Lodge of Nova Scotia, whom we were very pleased to welcome, and who gave us a most pleasing and helpful address. We were entertained in a royal manner at the Alexandria Hotel, with a banquet that would have been a credit to any city hostel.

February 23rd—This afternoon, with Past Grand Master Walker and Brother G. Gordon Boyne, Grand Pursuivant, I left by railway to visit Ashlar Lodge, No. 36, but in consequence of a drifting snow storm did not reach McAdam until 10 p. m. At that late hour we found Worshipful Brother G. W. Rothwell and other brethren waiting for us; accompanied by Worshipful Brother John W. Hoyt, District Deputy Grand Master, and Worshipful Brother John D. Chipman, Past Grand Deacon, we repaired to the Lodge room, where the officers of Ashlar Lodge conferred the Entered Apprentice degree in a most creditable and satisfactory manner.

After the business was completed the Grand Officers, with about twenty-five brethren from different parts of the State of Maine, who were guests of Ashlar Lodge, were escorted by the members of that Lodge to the Depot Hotel, where an admirable dinner was served, and with speeches and songs the very stormy night was spent in a most agreeable manner. Ashlar is an active Lodge and for it I anticipate a brilliant future.

April 6th—With an escort of eighteen officers and members of Grand Lodge, I, this evening visited Carleton Union Lodge, No. 8, and was cordially welcomed by W. Bro. W. J. Watson, and other officers and members of that Lodge. The Fellow Craft degree, Worshipful Master Watson being in the East, was conferred in a manner which left nothing to be wished for in correctness of ritual and in the effective character of the floor work. One of the many pleasing incidents of this visit was that of meeting as members of Carleton Union Lodge three generations of one family, in our esteemed Brother Jarvis Wilson, P. G. D., and his son and grandson. May Brother Wilson be long spared to sit in Lodge with his son and grandson, and may they all continue their good Masonic work. The hours of that very enjoyable evening passed too quickly, and we had to cut short the time of refreshment in order to regain the East side. Carleton Union Lodge is in excellent condition, and under the watchful care of its many active and zealous members I have no fear for its continued prosperity.

On the evening of May 5th, with Past Grand Masters Trueman and Walker and a full corps of Grand Lodge officers, I officially visited Albion Lodge, No. 1, and was received in the kindest manner by the officers and members of my mother Lodge on the forty-sixth anniversary of my receiving Masonic Light. It was an additional pleasure to have with me as acting Grand Chaplain, Brother William S. Marvin, the oldest active member of Albion Lodge, who that

evening celebrated his eighty-third birthday. He has been a member of the Lodge for over fifty-five years. Worshipful Master Skinner presided in the East, and with the assistance of his officers conferred the Master Masons degree in that correct and impressive manner in which Albion Lodge always does its work. Afterwards we were most hospitably entertained.

Accompanied by Past Grand Masters Ellis, Walker and Trueman, with present and past officers of Grand Lodge, on the evening of May 30th I visited The Union Lodge of Portland, No. 10, when we received a most cordial welcome from Worshipful Brother Bowyer S. Smith and the members of his Lodge. Worshipful Master Smith and his officers conferred the Master Masons' degree in a manner never excelled in this jurisdiction; the beauty of the degree was greatly enhanced by the excellence of the music furnished by Brother Fox, the Organist of the Lodge, and the choir who assisted him. The Union Lodge of Portland is in good hands and meeting with great prosperity. The rest of the evening was pleasantly spent in refreshments, to which was added one of those musical entertainments for which The Union Lodge of Portland is so celebrated.

June 5th—With the Very Worshipful Grand Secretary, the Grand Director of Ceremonies and nine other brethren, I visited Zion Lodge, No. 21, at Sussex, where we were joined by Right Worshipful Brother Robert Morison, Junior Grand Warden, Very Worshipful Brother Rev. Charles D. Schofield, Grand Chaplain, and Right Worshipful Brother George Coggon, Past Grand Warden. We were received by Worshipful Brother Harvey Mitchell and a large number of the members of the Lodge in the kindest manner. The Master's degree was conferred in such an excellent manner as to reflect great credit on the officers of Zion Lodge. An excellent supper, supplied and served by the wives and daughters of the members of the Lodge was greatly enjoyed by all.

On the evening of June 27th, with a number of the members of Grand Lodge, I accompanied the members of Carleton Union Lodge, No. 8, in procession to attend Divine service at the Free Baptist church, West, when an eloquent and instructive sermon was delivered by Rev. R. W. Ferguson, Rev. H. R. Reid and Rev. H. D. Marr assisting in the service. Rev. R. W. Ferguson's text was taken from I. John 3rd chapter and 16th verse.

July 11th—Accompanied by the Very Worshipful Grand Secretary, Brothers H. S. Bridges, P. G. D. C., and David Dearness, P. A. G. D. C., I visited Albert Lodge, No. 34, and was kindly welcomed by Worshipful Brother H. D. Cleveland and other members of the Lodge. They had no candidate, but Brothers Hartt and Dearness recited the lectures of the third degree and these were listened to with marked attention. Only four days previous to our visit the town of Albert was visited by a very destructive fire, by which several members of the Lodge met with loss. We had doubts of their being able to hold a meeting; but they had a good attendance of members, who are active, zealous Masons, and I have no doubts of the continued prosperity of Albert Lodge.

July 12th I visited Howard Lodge, No. 15, of Hillsboro, and was kindly received, with Worshipful Brother Mansfield Steeves in the East. Several circumstances prevented some of the active members being present, consequently there was a small attendance. There was no work, but the officers of the Lodge exemplified part of the third degree. Howard Lodge has just completed its semi-centennial, having been organized in 1855 under a dispensation from the Provincial Grand Lodge of Nova Scotia, New Brunswick, Prince Edward Island and Newfoundland.

On Monday, July 17th, with the Very Worshipful Grand Secretary, I left on an official tour of the North Shore. At Chatham Junction we were met by Right Worshipful Brother Fred E. Danville, the District Deputy Grand Master for

district No. 3, who accompanied us on all our visits. On that evening we visited Lodge St. John, No. 27, at Bathurst, when with Worshipful Brother Bishop in the East we witnessed the conferring of the Entered Apprentice degree in a most satisfactory manner. Lodge St. John, though small, and not increasing rapidly, owns its hall and is in a healthy state.

The following evening (July 18th), with Brother James E. Stewart, Grand Standard Bearer, I visited Restigouche Lodge, No. 25, Dalhousie; with Worshipful Brother Claude Brown in the Chair, the Entered Apprentice degree was conferred in a correct and creditable manner. Many of their members being absent, engaged in their usual business of the season, the attendance was small, but we saw evidences of their attachment to the Lodge in the recent repainting and fitting up of the building owned by it, and in which their comfortable and well furnished Lodge room is situate.

Wednesday, July 19th—After a most delightful sail of two hours on the Restigouche River, in company of Brother James E. Stewart, we arrived at Campbellton and were met by Worshipful Brother Dugald C. Firth, P. D. G. M. Campbellton is a live, busy town, increasing in population and in wealth. Here we found the Craft under the care of our old and tried Brother Firth in a prosperous condition. The visit to Campbellton Lodge, No. 32, was very pleasant. With Worshipful Brother Murray presiding in the East, the Master Mason degree was conferred in a manner so correct in ritual, with such solemnity and beauty of the floor work, as to make a lasting impression on the mind of the candidate.

Thursday, July 20th, we arrived at Newcastle; were welcomed by Brothers Richard L. Maltby, P. D. G. M., James McIntosh, P. G. D., S. W. Miller, P. M., and others, with whom a very enjoyable afternoon was spent in a sail on the Miramichi and a drive about the town and suburbs. In the

evening I visited Northumberland Lodge, No. 17, and was received and welcomed by Worshipful Brother Thomas W. Flett. They had no candidate, but with Right Worshipful Brother Maltby in the Chair the Master degree was exemplified, and a very pleasant and profitable evening spent.

Friday, July 21st—We arrived at Chatham and were met by Right Worshipful Brother Robert Murray, P. G. W. Worshipful Brother Anderson, Past Master Robinson and others. I visited Miramichi Lodge, No. 18, when with Worshipful Brother Anderson in the East, the Master Mason degree was conferred very effectively. I was pleased to congratulate the Worshipful Master on the correct manner in which he had conferred the degree on that, the anniversary of his sixty-eighth birthday.

On all these visits, as well as those to the other parts of the province, I and the Grand Lodge officers who accompanied me, have invariably been welcomed in a most cordial and hospitable manner, the brethren having left nothing undone that would add to our comfort or pleasure, for which I give them my sincere thanks.

RESUMED LABOR.

It was a pleasure to learn from Right Worshipful Brother George Ackman, D. D. G. M. for district No. 2, that Zetland Lodge, No. 24, which has been dormant for the past three years, had resumed labor, with good prospects of future prosperity. Zetland Lodge lost the building in which its Lodge room was situate by fire in 1902, when it was found that by oversight of the parties who had the matter in charge the insurance had been allowed to lapse. I would therefore recommend to the consideration of Grand Lodge the desirability of remitting the dues of Zetland Lodge which accrued during the time it was not working.

NEW LODGES.

Having received a petition from a number of brethren, asking for a dispensation to open a Lodge at Woodward's Cove, Grand Manan, to be called Mananook Lodge, and as it was accompanied by the recommendation of St. Mark's Lodge, No. 5, St. Andrews, I, after due enquiry and consideration, granted such dispensation. At my request, Right Worshipful Brother James Vroom, P. D. G. M., on 15th March last, visited Grand Manan, opened Mananook Lodge, and reported as follows:

St. Stephen, N. B., March 16th, 1905.

"V. W. Brother Hartt, Grand Secretary:

"I have the honor to report that the Grand Master's wishes in respect to Mananook Lodge, Woodward's Cove, have been carried out to the best of my ability.

"With Brother W. C. Hawkes, D. D. G. M. of the adjoining district of Maine, whom I met at Eastport; Brother C. W. Jenner, Past Master of Woodstock Lodge, No. 11; Brother Louis Holitser, Past Master of Eastern Lodge of Eastport, and Brother George M. Foster, of Washington Lodge, Lubec, I visited the brethren at Woodward's Cove to convey to them the M. W. Grand Master's Dispensation and to be present at the opening of Mananook Lodge.

"We found them assembled in a large and well furnished hall, with banquet room beneath.

"The building and the land upon which it sits, are the property of the new Lodge, and they have gone to a considerable expense for regalia and other properties.

"This, no less than their eagerness to begin work, shows a determined interest, and promises abundant success in the future.

"The Lodge was organized with Rev. Brother Abner W. McNinch, W. M.; Brother Henry E. Fraser, S. W.; Brother

Ward S. Foster, J. W., and Brother Wm. A. Fraser, Secretary, all apparently good men for office.

"The acting W. M. is familiar only with the ritual of the Grand Lodge of Nova Scotia. I would respectfully recommend that the M. W. Grand Master, if possible, arrange for a Grand Lecturer to visit them at an early date. They have a meeting called for the first Monday in April.

Since Brother Vroom's visit, Mananook Lodge has been visited by Brother J. W. Hoyt, D. D. G. M., and at my request Brother P. G. McFarlane, P. M., of Sussex Lodge, No. 7, has spent some time with them in imparting instruction. All the papers and reports will be placed in the hands of the Committee on Warrants to New Lodges for their consideration.

"The constitutionally requisite number of brethren having petitioned for a dispensation to open a new Lodge at Grand Falls, to be named Colebrooke Lodge, and the petition being accompanied by the recommendation of Benjamin Lodge, No. 31, at Andover, I, after due enquiry and believing that there was good territory for a new Lodge, have issued a dispensation, which lays in the hands of the Very Worshipful Grand Secretary, awaiting such time as the brethren shall have their Lodge room completed and furnished and other necessary arrangements made.

ACTS AND DECISIONS.

The new By-Laws of St. George Lodge, No. 12, were presented to me, and after due consideration were approved.

During the past year there have been a number of enquiries on constitutional points and Masonic usage; only two of which, however, were of general interest.

One was whether an applicant who had lost a foot in

youth and was using an artificial one, could be made a Mason. To this I replied that he could not. According to a ruling made by Grand Lodge at the annual communication of 1872, it was decided "That the loss of a foot is an insuperable objection to the initiation of a person otherwise qualified."

The other was a case in which a man had been elected in a Lodge in a neighboring State, but before being initiated removed into the territory of one of the Lodges in this jurisdiction, which Lodge was requested to initiate, pass and raise him for the Lodge in which he had been elected. My reply was: That although a Lodge may as a matter of Masonic courtesy, at the request of another Lodge confer the second or third degree, or both of them, on a brother initiated in the latter Lodge, it could not initiate and make a Mason of a man on such request; for under our constitution a man must be proposed, balloted for and accepted in the Lodge in which he is initiated.

FUND OF BENEVOLENCE.

Very soon after the formation of this Grand Lodge a resolution was passed to create a Fund of Benevolence, the expectation being that annual grants would be made to that Fund from the General Funds, but financial conditions have for many years prevented that scheme being carried out. The finances of Grand Lodge are now reaching a prosperous state, we having been able during the past year to pay off Fifteen Hundred Dollars of our bonded indebtedness, reducing it to Three Thousand Dollars, payment of which, with 4 per cent. interest, extends over the next seven years. It seems, therefore, as if we might next year and in following years carry to the credit of the Fund of Benevolence such sums as Grand Lodge may be able to spare from the General Funds, the Interest of which could be used to relieve the distress of worthy brethren, their widows and orphans. The

Fund of Benevolence now amounts to Three Thousand Five Hundred Dollars, being largely the accumulated Interest from a small Fund created nearly thirty years ago.

FRATERNAL INVITATIONS.

A very cordial invitation was given to me by the Grand Lodge of Canada in Ontario, to be their guest as the representative of this Grand Lodge at their Semi-Centennial on the 19th to 21st July last. Much to my regret, Masonic and business engagements prevented my accepting their kind invitation. Fortunately, Past Grand Master Ellis was able to attend and our Grand Lodge was, therefore, well represented.

It was with regret that I was unable to be present at the Semi-Centennial of Keith Lodge, No. 23, at Moncton, on the 25th and 26th of June last. On the 25th (Sunday) the brethren attended Divine service at St. John's Presbyterian church and listened to a very eloquent and instructive sermon delivered by Brother Rev. Robert S. Crisp. On Monday evening the Lodge held an At Home, when a very pleasant evening was spent. On the occasion they had the honor of a visit from Most Worshipful Brother Charles R. Smith, Grand Master of the Grand Lodge of Nova Scotia. Right Worshipful Past Grand Master Wedderburn delivered the oration in his usual happy and pleasing manner, and Right Worshipful Brother George Ackman, D. D. G. M., gave an interesting resume of the history of Keith Lodge during the past Fifty years.

At the regular communication of The Union Lodge of Portland in February last, I had the pleasure of meeting and welcoming to our jurisdiction Right Worshipful Past Grand Master Chambers, of the Grand Lodge of Quebec, who during the evening made a very happy and instructive address, which was received with well merited attention by all the brethren present.

It is to be hoped that we may again have the pleasure of a visit from Past Grand Master Chambers, and also of other members of sister Grand Lodges, who will always receive a hearty welcome.

SUGGESTIONS.

The questions of the expediency of reducing the number of districts in the province, and of changing the date of the annual communication to June, will come before you at this session, and I commend their careful consideration to Grand Lodge.

I would recommend Grand Lodge to place the sum of Two Hundred Dollars at the disposal of the Grand Master to enable him to provide instruction for the Private Lodges.

The reports of the District Deputy Grand Masters will be laid before you.

In conclusion, I sincerely thank the Past Grand Masters, present and past Grand Officers, as well as the large number of other brethren who during my year of office have so frequently assisted me by counsel, and aided me by their presence when performing the duties of Grand Master.

REPORT OF
BOARD OF GENERAL PURPOSES.

*To the Most Worshipful Grand Lodge, F. and A. M., of
New Brunswick:*

The Board of General Purposes submits the report of its deliberations during the year just ended.

At the first meeting, held in September, the choice of a Vice-President fell upon W. Brother W. Alexander Porter, P. G. Swd. B.

But few matters have arisen requiring the action or decision of the Board. As usual, there have been some applications for duplicate certificates to replace those lost or destroyed, and in dealing with these the Board has followed the recognized rule as to satisfactory proof of the loss.

The Proceedings of 1904 were printed and issued in the usual form and to the photographs already produced were added those of the late Past Grand Masters R. T. Clinch and Robert Marshall. So far, in the course of the last five years, the printed Proceedings have contained seven portraits. There remain six yet to be procured.

The Board early appointed a Sub-Committee to consider whether any changes in the capital investments of the Fund of Benevolence were advisable, with power to give effect to their views. This Committee subsequently reported to the Board that they had applied \$1,000 of the cash balance of

Grand Lodge to the payment of the two 4 per cent. Grand Lodge Bonds held by the Fund, viz.: Nos. 4 and 8, E. Series, due respectively in 1909 and 1913. A purchase was then made on behalf of the Fund of Benevolence of a 4 1-2 per cent. Town of Liverpool Bond for \$1,000, due June, 1934. The results are that the Fund of Benevolence holds a security for \$1,000 bearing a higher rate of interest than the former Bonds, and Grand Lodge saves the unaccrued interest on the two Bonds retired, less the bank interest on \$1,000, if deposited. The Board approved of the Committee's action.

The adoption by Grand Lodge a year ago of the Board's suggestion as to District Deputy Grand Masters and the reduction in the number of Districts, rendered it necessary for the Board to consider how best to divide the jurisdiction into three Districts and to provide that proper notices of amendment were framed to carry the suggestions into effect. In dealing with the first matter the Board found that it would be better to regard, not a division by Counties, but a division based upon the location of Lodges and the means of communication. The proposal is to make one district of the Lodges in Charlotte County and those along the C. P. Railway and up the River St. John to Grand Falls; another, of the Lodges in St. John and along the Intercolonial, short of Moncton, and the third of Lodges on the Intercolonial North and East of Moncton and the two Lodges in Albert County. Notices of amendment have also been given, intended to effect the other adopted suggestions, viz., to make District Deputy Grand Masters officers of Grand Lodge and to give them and Past District Deputy Grand Masters rank next before the Grand Deacons; also to add regulations as to their regalia. In this connection it may be reported that a set of regalia for a D. D. G. M. similar to the set already possessed by Grand Lodge, has been ordered from a firm in Toronto.

A petition from a constitutional number of brethren residing at Grand Manan, in the County of Charlotte, asking for a warrant of constitution under the name of Mananook Lodge, was presented, and with it the minutes of the Lodge while working under the dispensation of the Grand Master. The whole were referred to the Committee on Warrants to New Lodges.

Moved by R. W. Brother the Hon. J. V. Ellis, P. G. M., seconded by R. W. Brother Julius T. Whitlock, P. G. M.:

"That the election of the elective officers of Grand Lodge be the order of business at 8.30 o'clock this evening."

Carried.

R. W. Brother His Honor Judge Forbes, P. G. M., presented the report of the special committee appointed at the last Annual Communication to examine into the financial relations of Grand Lodge with the New Brunswick Masonic Hall Company, and after some discussion it was resolved, on his motion, duly seconded by R. W. Brother J. T. Whitlock, P. G. M.:

"That the report be received and entered on the minutes, and that it be referred to the Board of General Purposes to be fully considered and reported upon at the next Annual Communication."

The following is the report:

To the M. W. Grand Master and the Grand Lodge of F. and A. Masons of New Brunswick:

Your committee appointed at last meeting of Grand Lodge to examine into the financial relations of Grand Lodge to the Masonic Hall Company, beg leave to report:

That the New Brunswick Masonic Hall Company was incorporated on the 15th day of April, 1872, under an Act

of the Legislature with an authorized capital of \$100,000, divided into 5,000 shares of the par value of \$20 each.

That of this stock Grand Lodge subscribed for 1,250 shares and paid therefor the sum of \$25,000.

That there have been assigned by individual members to Grand Lodge 152 shares of the par value of \$3,040. Grand Lodge is therefore the owner of 1,402 shares of capital stock in the Masonic Hall Company, representing a cash value of \$28,040.

Private Lodges and individual members have subscribed for 597 shares of the par value of \$11,950; there are 26 shares on which payments have been made. We therefore place the situation thus:

This amount is a charge against the building and will mature in 1910.

Grand Lodge owes for Bonds issued to pay for stock \$3,000. To meet these Bonds there is cash on hand as per treasurer's report..... \$2,428
There is also in the Fund of Benevolence..... 3,468

Grand Lodge at its annual session in 1880 adopted the following declaration as the aim and purpose of Grand Lodge:

"It is anticipated that the Masonic Hall Building shall ultimately be owned by Grand Lodge, and that the revenue derived from the five stores which are in the building shall go to swell the Charity Fund of Grand Lodge, which shall be used for the relief of widows and orphans of Masons, not only in Saint John, but throughout the whole Province of New Brunswick."

Your committee would recommend that Grand Lodge should keep this purpose and intention in view, and that efforts should be made to acquire the outstanding stock by Grand Lodge, that the Hall may be owned and controlled by Grand Lodge.

Your committee would call attention of Grand Lodge to the fact that, being an unincorporated body, they do not legally hold the stock for which they have paid, and that the stock assigned to them is in a like position. They also call attention to the fact that there are only stock certificates for 652 shares now in the possession of the Grand Treasurer, whilst 750 shares are not in his possession, where they certainly ought to be.

Your committee would recommend, in view of its present large financial interests in the Building, that Grand Lodge should assume the present outstanding liabilities, relieve the Masonic Hall Company of the same, and thus become the absolute owners and carry out the purposes declared by Grand Lodge in 1880.

Your committee would recommend Grand Lodge to seek such Legislation as will enable Grand Lodge to legally hold its stock, as well as ultimately own and control this valuable asset of Grand Lodge.

The Ritual Committee, through its Chairman, R. W. Brother the Hon. J. V. Ellis, submitted the report following, and the same, without discussion, was, on motion, received and adopted:

The Ritual Committee respectfully reports:

That on the 10th August, instant, it held a session which practically extended over seven hours of time, during which the committee carefully went through the forms of opening, closing and changing the Lodge in the degrees, and of initiating, passing and raising.

Of the four members of the committee who live outside of the city of St. John, three—R. W. Brothers Burchill, Vroom, and Coggon—attended. Of the twelve members of the committee, nine were present, and they had the benefit of the assistance of W. Brothers Dearness, of New Brunswick Lodge, Dr. Ellis, of Albion Lodge, Dr. S. Skinner, W. M. of the same Lodge, Bowyer S. Smith, W. M. of The Union Lodge of Portland, and W. J. Watson, of Carleton Union Lodge. The Most Worshipful the Grand Master also attended during the entire session, and made all the brethren present his guests at the supper which was served in the library. The meeting was in every respect an agreeable one.

The committee finds that there is uniformity of work in the jurisdiction, such differences as exist—and they are not numerous—being almost wholly in phraseology, which differences the committee desires to harmonize to the fullest possible extent. Agreement was therefore come to upon all the points of difference, and the committee entrusted to the memory of two of its members—R. W. Brother Thomas Walker, M. D., and V. W. Brother J. T. Hartt—the exact phrasing in these cases; these brethren undertaking at their convenience to visit the Lodges in the city (or elsewhere), on the authorization of the Grand Master, and to explain where explanation is necessary, the settlements reached by

the committee. This work done in the City Lodges, it will be quite easy in like manner, or in some similar manner, to instruct the Lodges outside the City where the instruction is necessary. The purpose of this report is, therefore, to lay this information before Grand Lodge, that the Grand Master may be enabled to give the necessary authorization to the Worshipful Brethren named.

By direction of the Grand Master, the reports received by him from the District Deputy Grand Masters were laid on the table, and then, on motion of R. W. Brother Arthur I. Trueman, P. G. M., it was resolved that the reports be taken from the table and referred to the M. W. Grand Master, with the request that he direct what portions thereof shall be printed in the Proceedings.

The proposed amendments to the Constitution concerning District Deputy Grand Masters were then taken up. Due notices of these amendments had, by the authority of the Board of General Purposes, been given and inserted in the Proclamation summoning this Communication.

It was moved by the Grand Secretary, under the first notice, seconded by R. W. Brother His Honor Judge Forbes, P. G. M.:

“That the words ‘Worshipful District Deputy Grand Master’ be inserted after the word ‘Secretary’ in sections 5, 7 and 8 ‘of officers.’”

Carried.

Resolved, on like motion, under the second notice:

“That after the above words so inserted in section 8 there be added the words ‘Worshipful Past District Deputy Grand Masters.’”

Under the third notice it was moved by the Grand Secretary, seconded by R. W. Brother Thomas Walker, M. D., P. G. M.:

"That the word 'five' in section 1 of District Deputy Grand Masters be struck out and the word 'three' inserted in lieu thereof."

Much discussion was had upon this motion, and eventually it was moved in amendment by R. W. Brother Donald Munro, P. D. G. M., seconded by R. W. Brother Robert Murray, P. G. W.:

"That no action be taken under the notices 3, 4 and 5, until the next Annual Communication."

The amendment was carried.

Moved by R. W. Brother Arthur I. Trueman, P. G. M., seconded by R. W. Brother Julius T. Whitlock, P. G. M.:

"That the motions amending the Constitution already passed under notices 1 and 2 be reconsidered."

Carried.

On like motion, also resolved:

"That consideration of the proposed amendments under notices 1 and 2 do also stand over until the next Annual Communication."

R. W. Brother James Vroom, P. D. G. M., gave verbal notice that at the next Annual Communication he would move an amendment to the Constitution providing that Past Grand rank be conferred only on the elective officers of Grand Lodge and the Grand Secretary, except in particular cases, by vote of Grand Lodge.

On the motion of R. W. Brother the Hon. J. V. Ellis, P. G. M., it was agreed: "That when Grand Lodge takes recess it take recess until 8 o'clock in the evening."

Grand Lodge then took recess.

TUESDAY EVENING.

August 22nd, 1905.

Grand Lodge resumed labor at eight o'clock.

The following report was first presented:

The Committee on Relations with Other Grand Lodges respectfully report that at the request of your committee Grand Lodge last year allowed the question of the recognition of the Grand Lodge of Queensland in the Commonwealth of Australia, to stand over until the present year. The practical steps for the formation of the Grand Lodge were taken in March, 1904. Documents and papers received during the recess show that the officers of the Grand Lodge of Queensland were duly installed by the Grand Master of the Grand Lodge of New South Wales in October, 1904. There are remonstrances from the Grand Lodges of Scotland and of England against recognizing this Grand Lodge, but this Grand Lodge was itself formed upon the theory that the Lodges in an independent political jurisdiction had a perfect right to form a Grand Lodge. On that principle the Grand Lodge of Queensland was formed, and has been recognized by many Grand Lodges. Queensland is certainly entitled to have a Grand Lodge of its own, and while it is not established by a majority of the Lodges in the State, there were nearly forty Lodges concerned in its formation. Your committee are of the opinion that it should be recognized as an independent Masonic authority for the aforesaid State, and fraternal relations entered into with it.

To the Most Worshipful Grand Master, Officers and Members of Grand Lodge:

The Committee on Warrants to new Lodges have carefully examined the minutes of Mananook Lodge, working at Woodward's Cove, Grand Manan, under dispensation. The committee have also read letters from D. D. G. M. Hoyt and R. W. Brother J. Vroom and W. Brother P. G. McFarlane, who all speak in strong terms of the zeal of the brethren of this Lodge. It appears that meetings have been held regularly since March 15, during which time there have been added to the membership nine. The Lodge owns the hall in which it meets, and it appears to be in a good financial condition. Your committee recommend that Grand Lodge issue a Warrant as prayed for.

Also: "That the reports of the Grand Treasurer and Grand Secretary be taken from the table and filed."

R. W. Brother Thomas Walker, M. D., P. G. M., gave notice that at the next communication he would move an amendment to the Constitution increasing the number of scrutineers to four.

Grand Lodge then took recess until 3 o'clock to-morrow.

WEDNESDAY AFTERNOON.

August 23rd, 1905.

Grand Lodge resumed labor this afternoon at 3 o'clock.

The Library Committee briefly reported that copies of the Proceedings of Sister Grand Lodges had, in many instances, been received and that shelving accommodation again needed extension.

The report was received, and on motion the customary grant of twenty dollars was made for the ensuing year.

Moved by R. W. Brother His Honor Judge Forbes, P. G. M., seconded by R. W. Brother W. B. Wallace, P. D. G. M.:

"That the Grand Master be *ex officio* a member of the Library Committee, and that the Committee be empowered to act jointly with the committee from the Grand Chapter in reference to library matters." Carried.

The committee on the Grand Master's Address then presented its report.

To the Most Worshipful Grand Lodge of New Brunswick:

The committee to whom was referred the Address of the Grand Master desire to express the hearty appreciation of Grand Lodge as to the manner in which the Grand Master has performed the onerous duties pertaining to his office. It is indeed a great satisfaction to learn that the principles of Freemasonry so govern the Craft in the jurisdiction that Peace, Love and Harmony prevail.

The official visitation of the Grand Master to no less than twenty Lodges implies a conscientious attention to duty that entails sacrifice of time and money. It is a pleasure to

know that so many of the Past Grand Officers have accompanied him in these visitations, and that everywhere the ancient Masonic spirit of hospitality and social friendship have been extended.

The Grand Lodge is pleased to know that Zetland Lodge has again resumed labour, and earnestly hopes that its future will be bright and unclouded. In accord with the recommendation of the Grand Master, and for reasons set forth in the memorial of Zetland Lodge, the Grand Lodge herewith remits the dues of Zetland Lodge, which have accrued during the time of its not working.

Your committee suggests that the Lodges in our jurisdiction should keep their property fully covered by insurance.

We cheerfully welcome to our Roll of Lodges Mananook Lodge, of Woodward's Cove, and Colebrook Lodge, at Grand Falls. These Lodges, in the hands and under the care of brethren whose names appear on the petitions must surely have a successful future.

We desire to express the satisfaction of Grand Lodge on learning that the finances are in such a healthy condition that the Fund of Benevolence will shortly be enabled to carry out the object for which the Fund was established.

The Address brings before Grand Lodge in a most feeling manner, the names of some of our brethren who have been called by the Supreme Grand Master to the Rest and Refreshment so well earned. Their vacant places will be hard to fill. Their memories should ever remain.

The departed of other jurisdictions are also referred to. "There is a sorrow that proves the universal kinship." Our Grand Lodge mourns in sympathy with her sister Grand Lodges.

Your committee on behalf of Grand Lodge records their gratification at having such a worthy substitute for the

Grand Master as P. G. Master Ellis to represent them at the Semi-Centennial of the Grand Lodge of Canada in Ontario. These social and fraternal gatherings are productive of great good.

The committee recommend that Grand Lodge again place the sum of \$200.00 at the disposal of the Grand Master to provide correct instruction in Masonic work.

The decisions of the Grand Master referred to in the Address commend themselves to your committee, and appear to be in accord with Masonic practice.

To the Most Worshipful the Grand Master of the Grand Lodge of New Brunswick:

Most Worshipful Sir :

I have the honor to submit herewith my report as District Deputy Grand Master for District No. 2.

On the 27th of December last (St. John's Day), I paid an official visit to Keith Lodge, No. 23, and installed the newly elected officers for 1905; the Master W. Brother R. P. Dickson, having been elected for a second term. This Lodge is in a flourishing condition, and the books are well kept. The W. M. is surrounded by an able staff of officers and there is generally sufficient work to keep up a healthy interest in the Lodge.

At the close of the Lodge, the brethren adjourned to their banquet hall, where an enjoyable time was spent discussing the good things provided.

On January 10th I went to Petitcodiac to install the officers of Steven Lodge, No. 37, but owing to the enforced absence of the Worshipful Master and the Master-elect, no meeting was held. The installation was performed by R. W. Brother Geo. Coggon, of Zion Lodge, some weeks afterward.

On February 21st I paid an official visit to Sussex Lodge, No. 4, Dorchester, and installed the newly elected officers for 1905.

After the installation the Second and Third Degrees were conferred by a staff of officers composed of brethren of Keith and Sussex Lodges. The books and paraphernalia of the Lodge are well taken care of. After the business was disposed of the visiting brethren were royally entertained by the members of Sussex Lodge.

On May 16th I paid an official visit to Lebanon Lodge, No. 28, at Sackville, and was most cordially received by the W. M. and brethren of that Lodge. The visiting brethren from Keith Lodge conferred the Third Degree on two candidates. One of the pleasant features of this visit was the presence of the Grand Master of Nova Scotia, M. W. Brother Charles R. Smith, K. C. A very pleasant time was subsequently spent at refreshment.

On June 13th I again visited Steven Lodge, No. 37, at Petitcodiac. W. Brothers George Coggon and W. T. Kirk, of Zion Lodge, were also present. With the assistance of these two brethren the Third Degree was conferred. Steven Lodge is in a fairly good state, the books are well kept, and the W. M., Brother Fleming, is anxious that the Lodge should prosper. The visiting brethren were entertained on the conclusion of the meeting.

On the 14th of June I paid an official visit to Zetland Lodge, Shediac, for the purpose of re-opening the Lodge. On arriving we found three of the old members in attendance, W. Brother Inglis, W. M., and Brothers R. C. Tait and James Webster. They had nine applications for the E. A. Degree, and with the assistance of the brethren who accompanied me, from Keith Lodge, five of the applicants received the First Degree. The material taken into the Lodge, and that which is to follow, is good. I understand Zetland Lodge owes Grand Lodge four years' dues. I recommend that these dues be remitted, in view of their small membership, and to aid them in the effort they are making to take their place as heretofore.

On the 23rd of June I again visited Zetland Lodge, and conferred the E. A. Degree on four more candidates.

On June 25th and 26th Keith Lodge, No. 23, celebrated its Semi-Centennial anniversary. The brethren attended Divine service on the afternoon of Sunday, 25th, in St. John's Presbyterian church, where a very able, eloquent and instructive address was given by V. W. Brother Rev. Robt. Crisp, Past Grand Chaplain. On the following Monday evening the Lodge held an At Home, and a very pleasant evening was spent. The orator of the evening, R. W. Bro. His Honor Judge Wedderburn, P. G.
