


APRIL 12TH, A. D. 1910.

Pursuant to notice, a Special Communication of "The Grand Lodge of the Antient and Honourable Fraternity of Free and Accepted Masons of New Brunswick" was held in Freemasons Hall, Germain Street, in the City of Saint John, on the afternoon of Tuesday, April 12th, A. D. 1910, at two of the clock.

At the M. W. Grand Master's request, the officers and members of the six City Lodges had been summoned to

attend, and the Brethren assembled in the hallway and subsequently formed in procession under the direction of the Grand Director of Ceremonies.

Grand Lodge was opened in *ample* form at 2.15 o'clock.

The Most Worshipful the Grand Master stated that he had called this Special Communication of Grand Lodge in order to pay a tribute of fraternal respect and regard to the late Right Worshipful Brother Edwin James Everett, Past Grand Master, who had died on the 9th instant, after many weeks of gradually failing strength. The Grand Master made appreciative reference to the late Brother's many years of active Masonic life, his eminent services to the Craft in this jurisdiction and to his lofty qualities as a man and a citizen.

R. W. His Honour Judge Wedderburn, P. G. M., briefly, but with eloquent feeling, recalled a lifelong friendship and the impressions formed of the late Brother's earnest life and high example.

The M. W. Grand Master and the officers of Grand Lodge then repaired to the residence of the late R. W. Brother and preceded the remains to Saint John's (Stone) Church.

In the meanwhile the Brethren at Freemasons Hall had moved thence in procession, but without music, to Wellington Row and lined the roadway to the Church doors; so that the funeral procession passed through the lines into the Church. The service of the Church of England was conducted by the Rector, the Rev. G. A. Kuhring.

Subsequently the Brethren accompanied the remains as far as Haymarket Square, where the officers of Grand Lodge took coaches to Fernhill Cemetery. After the Anglican Service at the grave, the Funeral Service authorized by Grand Lodge was read by the M. W. Grand Master.

The pallbearers on the occasion were: R. W. Brothers Thomas A. Godsoe, Thomas Walker, M.D., Alexander R. Campbell, W. Brother W. H. B. Sadleir, and Brothers George Blake and W. Henry Thorne.

A return was made to Freemasons Hall and Grand Lodge was closed in *ample* form.




The Attendance Register was also signed by seventy-six Master Masons.

Grand Lodge was opened in *ample* form at eight o'clock.

The M. W. Grand Master in formally announcing the cause and purpose of the Communication spoke of the great National Sorrow which had fallen upon the British Empire by reason of the death of its beloved Sovereign; a sorrow which came keenly home to the Masonic Fraternity throughout his Dominions.

The Grand Master felt that it was fitting for Grand Lodge to hold a Memorial Lodge of Sorrow for a Monarch



and a Mason who had so greatly succeeded "in holding the key to the hearts of men."

At the Grand Master's request, R. W. Brother Thomas Walker, M.D., P. G. M., Grand Representative of "The United Grand Lodge of England," also briefly addressed Grand Lodge.

## ADDRESS, The Grand Chaplain

V.W. the Rev. GORDON DICKIE.

The Lord hath taken away our Master from our head to-day, and the sudden shock of death has caused a tremor throughout the whole Empire. Men everywhere regard the loss as personal, for the King had so wrought himself into the fabric of our national life, nothing seemed complete without him. Although Lord of all he considered himself the servant of all. His chief purpose in life was not to be ministered unto, but to minister, and in the faithful pursuit of this ideal he made himself indispensable not merely in England, but throughout the Empire. For him nobility was goodness and the service of life, self-sacrifice. In the language of Henley he could say:

"What have I not done for thee, England, my England?  
What is there I would not do, England, my England?"

We do not appreciate his loss to-day — we cannot. That will come only when the rolling seasons have carried us far hence. Months and perhaps years will pass before we get the true perspective of that life. At present we can only say that "he passes to be King among the dead," and as we listen in our silent grief there seems to come

"As from beyond the limit of the world,  
Like the last echo born of a great cry,  
Sounds, as if some fair city were one voice  
Around a king returning from his wars."

There need be no regrets on his part or on ours. "I think I have done my duty" was his last message to his people, and if upon our part the answer to that query could be found it would be — "Yes, a thousand times over." Might we not all assent with one voice to the words ascribed to the late King's mother by one who knew so well how to clothe his thought in verse:

"O loyal to the royal in thyself,  
And loyal to thy land, as this to thee—  
Bear witness, that rememberable day,  
When, pale as yet, and fever-worn, the Prince  
Who scarce had pluck'd his flickering life again  
From halfway down the shadow of the grave,  
Past with thee thro' thy people and their love."

King Edward was a true sovereign in that he did not only rule, but represent his people. He interpreted their cries. He helped

them bear their burdens. Not only did he rejoice with those that rejoiced — he could weep with those that wept. And that sympathy was heartily reciprocated. An anarchist sent to Britain after the Prince recovered from his attack of typhoid wrote home: "The people are all mad with joy at his recovery. There is no chance of a revolution for the next fifty years."

King Edward made no distinction between the classes and the masses. He would receive a deputation of working men with as much courtesy as he would an assembly of crowned heads. It was evidently his opinion, too, "that God must have liked the common people, else he would not create so many of them." Even in his sorrow he held firmly by his democratic principles. The funeral for his little son was as simple as any peasant's. There were no courtiers — no procession. The King stood by the open grave, hand in hand with the little princes, while the villagers threw in flowers and thus expressed the sympathy that lay too deep for words.

In everything he did the King was truly genuine. He was never known to bear a grudge or do an ill turn to anyone. He studied the characteristics and even the failings of others so that he might the more truly gain their confidence. He had, in a word, what we call tact, and respected the authority as well as the prejudices of others. In his youthful days, when travelling with those who represented royalty, he never "made a scene," and where there was a question as to precedence, would always make a point of giving way, thus carrying out the scriptural principle: "in honor preferring one another."

And it is only fair to state that he was generally religious. He delighted in the Sabbath as a day of rest and peace. He was always in his place in church, and when at sea on Sunday and no chaplain present, he would gather all the officers and read the lessons for the day.

It has been observed that the first act of the late King after his great typhoid illness was to attend a thanksgiving service in St. Mary Magdalene, where those present remarked that it was beautiful to see the expression of thankfulness and adoration on the faces of both King and Queen.

Another proof of his sincere conviction in religious matters is supplied from Rome, where he was once at Easter-time. This is usually the season when all travellers put aside whatever religious convictions they may have and flock to see the splendid ceremonials in St. Peter's and the other Catholic churches. But the Prince — as he was then — went quietly to the plain little English Church, remarking that when Protestant people went to Rome they should be more than usually

particular to uphold their own form of faith. And he was right. We cannot be truly religious unless we are truly loyal. The people who think so lightly of their church service as to forego it for anything and everything are not of the true calibre for Christians. They need this example of loyalty set by royalty itself, if they would obtain "the abundant entrance into the heavenly kingdom."

King Edward was intensely human. He hated anything like cant or snobbery, and he rejoiced in the frankness of the men of low degree. "This is not the first time I have worn the King's uniform," said John Burns when he was being sworn as Privy Councillor, and the King laughed as he remembered how in former days the same John Burns had worn the prison garb.

On different occasions the King had proved that he would gladly endure physical inconvenience rather than disappoint his people. At York upon one occasion he stood up in his carriage—bareheaded—and in the midst of a tropical shower—to salute the crowds that lined the streets. At Paddington as Prince of Wales he ordered his carriage to be opened and driven slowly through the streets, despite the fact that a great storm was raging, simply to satisfy the people. No king could show such grace as this and fail to win the appreciation of his people. He had the reputation for being a good fellow, and such acts as these gave him a grasp on popular affection that no mere display of pomp and circumstance could attempt to rival. The people loved their King because they knew his heart was right. He was their King and they were his people. He has taken his place with the great monarchs of the ages, who, by means of their humanity, have bound their people to them with bands that can never be dissolved. If, like Alexander, he had no patrimony but his hopes, his people would willingly face death to share them with him. Surely it would be appropriate to say that if King Alfred be called the Great and Queen Victoria the Good, the title which we would preserve for him would be Edward the Beloved.

In world politics King Edward was no inconsiderable factor. Here, as elsewhere, he spared no personal pains to secure the greatest good to the greatest number. His prayer for his country was that "peace might be within her walls and prosperity within her palaces."

In other countries, too, he exercised the same happy faculty for promoting the best interests of mankind. His personality was one of the chief factors in promoting the good understanding that has arisen between France and England. Both in Russia and Germany men sigh for a sovereign who can rule with the same love and gra-

aciousness as the late King Edward. Where kings were gathered together he was easily first—the King of all Kings—making friends and ever winning over the enemy by his charm and winsomeness of character.

And shall we not say that he was equally successful in preserving peace at home. Factions could not exist in his presence. The spirit of misunderstanding was bound to be destroyed when he appeared. In no tangle that has occurred in his short reign was his presence so much needed as in the political crisis now impending. He has been taken at an unfortunate moment. But we believe that the God who casts one servant down will raise up another. He will not suffer our foot to be moved—He who keepeth us will not slumber. Let us, therefore, with one accord cry out: "The King is dead. Long live the King."

Fellow craftsmen! I have spoken to you of our late King's qualities as a man, and I think you will agree with me that these were also the qualities of a true mason. Perhaps we might even hazard the conjecture that he learned the lessons of charity and of fraternity in our masonic ceremonies. Be that as it may, we merely stop now to mention that in 1870 the Rank of Past Grand Master (P. of W. Lodge) was conferred upon His Royal Highness, and in 1875 the "heir apparent" to the throne of Great Britain and Ireland was installed, in the Royal Albert Hall, the Grand Master of the Grand Lodge of England, the oldest and grandest Lodge in the world.

On assuming the mastership the late King was presented with an address wherein the facts of the history of the Prince of Wales Lodge under the patronage of royalty were graphically described, and in reply closed his address with the following words, which should be heeded by us all. "I fully agree," he declares, "with that portion of the address which referred to the close connection between the throne and the craft, and feel assured that as long as Freemasonry remains true to the principles of religion and loyal to the throne, so long will it continue to flourish, which I sincerely hope will be forever."

And so may it ever be. Let us all follow the example of our honored King, and as good men and true, whether in the lodge room or in the open street of life, "wear the white flower of a blameless life." May lofty patriotism, gentle charity and holy faith ever call us to the duties of the hour.

The M. W. Grand Master then read his Annual Address.

**GRAND MASTER'S ADDRESS.***Brethren of Grand Lodge:*

We are privileged at the end of another year to meet again in that spirit of love and fraternity which should always pervade our hearts on occasions like the present. These annual gatherings serve as milestones to mark our course as we journey swiftly along over the rugged road of life. Should we not then, my Brethren, be happy in again having the privilege of taking sweet counsel together, and kindling into new life that spirit of brotherly love and greeting, which must, I feel sure, throb in the breast of every one now present.

It is with feelings of unfeigned pleasure that I extend to each of you a cordial welcome to this the Forty-third Communication of the Grand Lodge of New Brunswick, believing, as I do, that we are members of a fraternity which, owing to the efforts that it has made to teach morality and practise charity, has been a very powerful factor in advancing Christian civilization throughout the world. The mission of Freemasonry is peace and good will, and the lodges of the Craft established in every part of the globe are engaged "in the noble work of teaching truth by that beautiful system of symbols so dear to us all." But it is not my purpose to enter upon any eulogy of Freemasonry at the present time, for it needs none. It has always flourished, owing to the efforts that the members of the Craft have made to promote the general good of mankind, and to extend a generous hand to the unfortunate in the time of their distress and need.

As I glance back over the year which has just closed, it seems only yesterday that you placed in my hands the gavel of authority as Grand Master of this jurisdiction.

I may say that I accepted the office with many misgivings, for I felt somewhat afraid that I had not the time to devote that attention to the work which was necessary for the proper discharge of the many duties incident to the office, but the kind assistance and hearty co-operation received from the officers and members of the Grand Lodge — particularly the assistance of our efficient Grand Secretary R. W. Brother J. Twining Hartt — have relieved me of a number of my most arduous duties, so that many of the cares usually devolving upon the Grand Master have been scarcely felt by me.

Several faithful craftsmen of our jurisdiction, during the year just closed, have obeyed the summons of the Great Architect of the Universe, and have crossed that bourne from which no traveller returns.

St. John's Lodge mourns the loss of two of its members, who were also members of this Grand Lodge. W. Brother Alexander W. Macrae died in this city, November 2, 1909, after a very brief illness at the comparatively early age of 44 years. The son of Rev. Donald Macrae, one of the best known Presbyterian clergymen in Canada, Brother Macrae had received careful training and a thorough education. He received the M. M. Degree in December, 1890, and for a time took an earnest interest in the affairs of his mother lodge, being elected Worshipful Master of St. John's Lodge, December, 1894. He was a frequent attendant at the communications of Grand Lodge, and being a good speaker often took an active part in its deliberations. By his energy and ability he had built up for himself an extensive and lucrative practice as a lawyer, and held many positions of honour and trust in this community. His death in early middle life was deeply mourned by his Brethren and friends generally.

Not many months after his eldest son's death, the Rev. Donald Macrae, himself, was borne to his last resting-place

in the cemetery near this city, which he loved so well, and in which so much of his active life was spent. Dr. Macrae at one period of his life took a very keen interest in Freemasonry. He was Senior Warden of St. John's Lodge, and for three years Grand Chaplain of the Grand Lodge of New Brunswick. In middle life he was one of the best known pulpit orators in Canada, and was a speaker of unusual power and earnestness. Many of the Brethren present here to-day will remember with pleasure his sermons and eloquent addresses on public occasions. He rests from his labours and his works follow him.

With unaffected regret we mourn the death on 9th of April last of R. W. Brother Edwin J. Everett, for over fifty years an active member of the fraternity in this jurisdiction, and one ever warmly devoted to its interests. Brother Everett was born in this city October 13, 1836, a member of a family which has given to this community several active and useful citizens. He was initiated into Freemasonry in Albion Lodge — then on the English registry — in June, 1859, became its Master in 1869, and to the day of his death its interests and its prosperity were constantly in his thoughts. For eight years, 1895-1904, he was Grand Treasurer of the Grand Lodge of New Brunswick, and but few know to what extent our present excellent financial condition is due to his constant attention, prudence and good judgment. The extraordinary ability with which R. W. Brother Everett administered the finances of Grand Lodge marked him out as one who would ultimately occupy the office of Grand Master. To this important position he was elected in 1904, holding office until 1906, and discharging its varied duties with energy, with good judgment, and with a well grounded knowledge of masonic law and masonic principles. No man ever occupied this chair who was more responsive to trusts imposed upon him

than our late Brother Everett, and none ever established himself more thoroughly in the good will and esteem of his Brethren. In all the various branches of our fraternity, he took deep and earnest interest, and in many of them he filled the highest positions, giving to them all the advantage of sound business knowledge and of large experience in ordering affairs. Although our late Brother gave much time to masonic engagements, he had on the other hand active business interests, and was earnest in the advancement of many public undertakings, such as the Park Commission, and the Relief and Aid Society, and was a generous supporter of various helpful philanthropic movements. An honourable business man, capable in dealing with affairs of many kinds, ever animated by a strong sense of justice and yet with a gentle nature united with great firmness of character, Brother Everett possessed all the characteristics of the best type of citizenship. His years were well spent, and his memory will long be cherished in this Grand Lodge as that of a Brother who faithfully did his duty by his fellow men.

The Corinthian Lodge, No. 13, was deeply bereaved on May 11, by the death of W. Brother Allan McN. Travis, at the age of 68 years. Brother Travis was born in the City of St. John and entered Masonry through the portals of The Union Lodge of Portland, affiliating with The Corinthian Lodge, December 30, 1868, while the Lodge was still in its infancy. Shortly after affiliation he was elected Worshipful Master, and so well did the Lodge prosper under his direction that he was chosen by his Brethren on many subsequent occasions to fill this important office. At the Semi-Centennial Celebration in 1903, the members of the Lodge, recognizing his faithful and continuous services, conferred upon him honorary membership with the right to vote. An older member of the Lodge has well summed up his services in the expressive words —

“he taught us to creep, to stand and to walk, and in our weakness was strength.” His memory will be cherished long in the hearts of the Brethren of The Corinthian Lodge.

On Wednesday, July 27, The Corinthian Lodge lost another member, who though not a member of Grand Lodge, should fittingly be mentioned in this address. I allude to Brother Wm. Jackson, who died at the age of 81, having been the Tyler of the Lodge for thirty-six consecutive years. He affiliated with The Corinthian Lodge from Zion Lodge, Sussex, on the same evening as W. Brother Travis. Brother Jackson's repeated refusal to accept higher office was the sole reason that he was not a member of Grand Lodge, as his Brethren were most anxious to confer upon him the highest office at their disposal. By his generous gifts of land and money in the early days of The Corinthian Lodge, by his keen interest in all matters pertaining to the Lodge, by his faithful attendance, and by his genial disposition, he had endeared himself to all. His generous action in giving a considerable sum of money to establish a fund for poor and distressed members of The Corinthian Lodge is well worthy of special mention. He will be missed not only by the Brethren of his own Lodge but also by the visiting members of the Craft.

Hiram Lodge, No. 6, sincerely mourns the loss of its oldest Past Master, and the second member on the roll of the Lodge. R. W. Brother George F. Gregory was initiated in St. Andrew's Lodge, Fredericton, then under the jurisdiction of the Grand Lodge of Scotland, December 13, 1860, and raised March 14, 1861. In 1867, and the four following years, he filled the oriental chair, and in 1872 was elected Senior Grand Warden of Grand Lodge. He was a member of Fredericton R. A. Chapter, and for a number of years its Secretary. Brother Gregory's whole life was spent in the city of his birth. In his early years he was most prominent in municipal affairs, and his

fellow citizens honoured him on seven occasions by electing him Chief Magistrate. As Mayor of Fredericton, as one of the foremost barristers of the Province, as a private citizen, he displayed marked ability, energy and force of character. His public utterances were always appreciated, and few faces were better known throughout the Province, or forms more familiar than his. His elevation to the Bench of the Supreme Court of New Brunswick in October, 1900, came as a fitting tribute to and recognition of his long and distinguished services at the bar, and few appointments have met with greater appreciation from the Province at large. On account of failing health he retired from the bench in May, 1909. In private life he possessed most estimable qualities of heart and mind that endeared him to friends and relatives, and it may be well said of him as of one of his friends that "in all his undertakings and labours he aimed at the public good, and the record of his life is one to which we can well pay the tribute of fraternal respect." In peace he rests from his labours.

Two Special Communications of Grand Lodge have been held during the year, one for the purpose of accompanying the remains of R. W. Brother E. J. Everett to his last resting-place, the other for the purpose of holding a Lodge of Sorrow in memory of our Illustrious Sovereign and Brother, King Edward VII, who died May 6, after a brief illness, and who was for twenty-seven years M. W. Grand Master of the United Grand Lodge of England. The attendance at the Lodge of Sorrow of members of the Craft from this city and from other parts of the jurisdiction was very large, and I feel sure that all present will long remember the occasion as one of great impressiveness and solemnity. The oration of the Grand Chaplain, Rev. Gordon Dickie, was worthy of the occasion, and a fitting tribute to the memory of the illustrious dead. Although many tributes have been paid to the memory of our late King, none I venture to think can be higher than that expressed in the British Parliament on behalf of the Labour Party by Mr. Edwards, the member for Hanley, whose words I make no apology for quoting in this address: "The King, by his noble life, by his heroic services, has brought the great mass of working men to realize that, after all, those in high places have used their enormous powers to make their lot happier and brighter. Of no one may it be so truly said as of the late King, that he worked and toiled for the good of the people. While his immediate associations were with

those whose lot is better in this world, the great mass of the people at the base of society found that in King Edward they had a warm and sincere friend. Nowhere will sorrow be truer, more sincere, or deeper than among the humblest of the poor." To these simple and earnest words, which evidently come from the speaker's heart, we can as Freemasons give an unqualified approval, and at the same time offer up an earnest prayer to the Great Architect of the Universe, that our present King George V. may live up to the example of his father, and that his reign may redound to the everlasting happiness of the Empire.

Perhaps the most pleasing duty of a Grand Master is that of visiting the subordinate lodges throughout the jurisdiction. It has been my aim to devote as much time to this important work as I could spare from my other duties, and I cherish the hope that the visitations made during the year have been as profitable to the Brethren visited as they have been pleasant to myself and the officers of Grand Lodge.

On the evening of October 15, 1909, accompanied by the Deputy Grand Master, R. W. Brother Robert Murray, R. W. Brother Richard Maltby, P. D. G. M., R. W. Brother J. Twining Hartt, Grand Secretary, W. Brother H. E. Goold, Grand Director of Ceremonies, and Brother D. Arnold Fox, Grand Organist, I visited Miramichi Lodge, No. 18, at Chatham. We received a warm welcome from the Worshipful Master, Brother Dunbar, and found a very large attendance of members and visitors present. The D. G. M., Brother Murray, ably assisted by the officers of the Lodge conferred the M. M. Degree on two candidates in an impressive manner. Miramichi Lodge has but lately celebrated its fiftieth anniversary and is an active and very prosperous lodge. The zeal of the older members, and the enthusiasm prevailing among the younger Brethren, indicate that the future of this lodge will be even brighter

than the past. The business of the lodge being concluded, we were most hospitably entertained, and greatly enjoyed pleasant social intercourse with our Brethren of the North Shore. It was pleasant to meet our worthy Brother Jas. Anderson again, and to hear his reminiscences of the good old days. May he long live to guard well the outer door of Miramichi Lodge.

November 2, 1909, accompanied by the Grand Secretary I left Saint John for the purpose of paying official visits to Carleton Lodge in East Florenceville, and Woodstock Lodge at Woodstock, and also to consecrate and dedicate Bethel Lodge, No. 40, at Edmundston, which had been working under a dispensation for some little time. Reaching Woodstock on the night of November 2, we were joined there by W. Brother Wm. H. Smith, Senior Grand Deacon, and proceeded next day to Florenceville, and on the evening of November 3, visited Carleton Lodge, No. 35. Although the weather was most unpropitious, there was a fair attendance of members, and the Worshipful Master, who had driven fully eight miles in a torrential rain to welcome us, is to be commended for his zeal. With the assistance of the Grand Lodge officers, Brother George J. Cronkhite, the W. M., worked two degrees, that of E. A. and M. M., in a correct and pleasing manner. Brother Cronkhite is a good ritualist and has evidently taken pains to be accurate in his work.

Next day, November 4, we returned to Woodstock, and on the evening of the same day visited Woodstock Lodge, No. 11. The attendance of members and visitors was very large, and our reception most cordial. The Worshipful Master, Brother Hubert A. Seely, assisted by the officers of the Lodge, conferred the F. C. Degree correctly and impressively. R. W. Brother Donald Munro still occupies the position of Secretary of this important Lodge, and, needless to say, the records are faithfully and accurately

kept. After the conclusion of the evening's business a call to refreshment was given to all present, who heartily partook of the hospitality of the brethren of Woodstock Lodge. Woodstock Lodge, with a membership of 195, still holds the proud position of the banner lodge of the Province.

November 5th, assisted by R. W. Brother E. L. Hagerman, and W. Brother D. W. Kyle, of Woodstock Lodge, W. Brother W. F. Kertson, of Colebrooke Lodge, the Grand Secretary, and the Senior Grand Deacon, I had the pleasure of constituting, consecrating and dedicating Bethel Lodge, No. 40, according to ancient usage and the custom of the Craft. After the ceremony of dedication was concluded I installed W. Brother Aaron Lawson as Master of the Lodge, and afterwards at his request installed the other officers. There was a large number of members and visitors in attendance, and among the visitors were several from the neighboring State of Maine. Bethel Lodge has already a membership of over 30, and has I trust a bright and prosperous future before it. Everything was done by the Brethren there to make our visit enjoyable and pleasant.

On the evening of November 23, accompanied by P. G. M. Dr. Thos. Walker and a full staff of the officers of Grand Lodge, I paid an official visit to The Union Lodge of Portland, No. 10, and received a warm welcome from the Master, W. Brother H. Russell Sturdee. There was a very large gathering of the craft present, and the M. M. Degree was worked in a manner highly creditable to the Master and his efficient staff of officers. Indeed it may be said that the work was as near perfection as can possibly be attained. A fine choir of voices under the leadership of the Grand Organist delighted all present by the admirable manner in which they chanted the sublime scripture reading of the Third Degree. After the lodge closed, we repaired to the banquet hall, and there enjoyed the

hospitality for which this lodge has long been noted. The pleasant recollections connected with this evening's gathering of Masons will linger for a long time in the memory of those who were present to enjoy it. At this visit I had the pleasure of installing the Grand Chaplain, the Rev. Gordon Dickie.

December 6th, accompanied by R. W. Brother Thos. Walker, P. G. M., R. W. Brother A. R. Campbell, as S. G. W., R. W. Brother David Dearness, as J. G. W., R. W. Brother Twining Hartt, Grand Secretary, W. Brother Wm. H. Smith, S.G.D., W. Brother H. E. Goold, G.D. of C., Brother D. Arnold Fox, Grand Organist, and W. Brother James Patton, I went to Sussex for the purpose of visiting Zion Lodge, No. 21. W. Brother Rev. Canon Neales, the Master of the Lodge, occupied the chair and conferred the E. A. Degree on one candidate, and the M. M. Degree on two, in a manner which showed that he was a perfect master of the ritual. Zion Lodge is evidently in a most prosperous condition. Following the business session there was a call to refreshment in the banquet hall where we greatly enjoyed the excellent repast provided and served by the wives and daughters of the members of Zion Lodge. At the close I had the pleasure of presenting on behalf of the Lodge a beautiful Grand Lodge Apron to R. W. George Coggon, to mark the esteem in which he is held by his brethren of Zion Lodge.

On the evening of January 4th, 1910, accompanied by a full staff of Grand and Past Grand Officers, I visited St. John's Lodge, No. 2, for the purpose of installing Brother W. S. Clawson as Worshipful Master, and the other officers of the Lodge. It was pleasant to find this, my mother lodge, in such a flourishing condition at the end of more than a century from its foundation. St. John's Lodge at present as in the past contains many earnest masons, who

are zealous for the good name of their Lodge, and who are determined that it shall not stand second to any lodge in the jurisdiction in the character and quality of its work. The banquet at the close of the ceremony of installation was a most enjoyable affair.

Jan. 11th, accompanied by P. G. M. Thomas Walker and a very large number of officers and members of the Grand Lodge, I visited Hibernia Lodge, No. 3, at the request of the Master W. Brother A. W. Emery, and installed Brother Joshua P. Clayton as W. M., and at his request installed the other officers of the lodge. The attendance of members and visitors was very large, and we received a most cordial and enthusiastic welcome. When the ceremonies of installation were concluded, the Worshipful Master invited us to partake of the hospitality of the Lodge in the banquet hall, and a couple of hours was most agreeably spent enlivened by speech and song. Hibernia contains a large number of enthusiastic members of the craft, and I venture to predict for it a year of great prosperity under the guidance of W. Brother Clayton and his capable staff of officers.

Jan. 13th, accompanied by a large staff of Grand Lodge officers I visited New Brunswick Lodge, No. 22, and at the request of the W. M., Brother W. C. Birrell, installed the newly elected Master, W. Brother Herbert E. Storey. At his request I also installed the other officers. The reception given us by New Brunswick Lodge was most cordial, and it was especially pleasing to see so many of the past officers and members present to welcome us. This lodge has had several years of great prosperity, and contains among its members some of the best ritualists in the craft. I have no doubt that W. Brother Storey will do his utmost to maintain the reputation which this lodge has long enjoyed for skill and accuracy in their work. Here also we were most hospitably entertained, and after two hours of pleasant

social intercourse we departed carrying with us agreeable recollections of our visit to New Brunswick Lodge.

The following evening, Jan. 14th, accompanied by W. Brother George E. Day, as S. G. W., W. Brother Reverdy Steeves, as J. G. W., W. Canon Neales, P. G. C., Brother J. Twining Hartt, Grand Secretary, W. Brother Wm. H. Smith, S. G. Deacon, W. Brother H. E. Goold, G. D. of C., W. Brothers Francis Burpee and H. Russell Sturdee, Grand Stewards, Brother D. Arnold Fox, Grand Organist, and W. Brother Jas. Patton, I visited The Corinthian Lodge, No. 13, at Hampton, and duly installed the Worshipful Master elect, Brother Cecil March, and also at his request installed the other officers. This Lodge is entering upon an era of great prosperity. The new lodge room is perhaps the most beautiful and artistic in the whole jurisdiction, and the greatest harmony evidently prevails among the members. The officers and members of The Corinthian Lodge are active and zealous masons, and are doing their utmost to attain perfection in the working of the several degrees. Nothing could surpass the cordiality of the reception extended to us in the lodge room, or the hospitable way in which we were afterwards entertained when the ceremony of installation was completed.

March 3rd, accompanied by Rev. Gordon Dickie, Grand Chaplain, J. Twining Hartt, Grand Secretary, Wm. H. Smith, S. G. Deacon, H. E. Goold, G. Director of Ceremonies, and D. Arnold Fox, Grand Organist, I went to Fredericton for the purpose of visiting Hiram Lodge, No. 6. On arriving at the Lodge we found one of the largest and most enthusiastic gatherings of the craft, which it has been my privilege to meet during my year of office. The W. M., Brother Boyd, gave us a warm welcome, and then proceeded to the work of the evening which was that of conferring the M. M. Degree. The work was done in an admirable manner, the W. M. being ably assisted by his

officers and by W. Brother F. St. John Bliss, D. D. G. M., and R. W. Brother Hedley V. B. Bridges, both of whom are accurate ritualists, and proficient in the lectures of the Third Degree. The books of the Lodge are in good order and the records admirably kept by W. Brother Herbert C. Creed.

The good Brethren of Hiram had provided a sumptuous banquet for us at Windsor Hall whither we repaired after the business of the lodge was over, and where we spent an evening of unusual pleasure. The speeches and music were most enjoyable, and I was particularly impressed with the enthusiastic manner in which the National Anthem was sung in response to the toast of "The King and the Craft." Little did any of us then imagine that our good King Edward VII. was so soon to be called from earth to his reward in the Celestial Lodge above.

The next evening, March 4th, accompanied by R. W. Brother Donald Munro, R. W. Brother R. S. Barker, W. F. St. John Bliss, D. D. G. M., the Grand Secretary, and W. Brothers Samuel H. McKee and Austin Dunphy, I visited Alexandria Lodge, No. 33, at St. Mary's. The work of the evening was the M. M. Degree, which was satisfactorily done by the officers of the lodge with P. M. W. Brother Whitman Brewer in the chair. This lodge is in a good financial condition and the records and books are well kept. Though comparatively few in number the members are all zealous and active masons.

March 15th, accompanied by P. G. M. Thomas Walker, R. W. Brother David Dearness, the Grand Secretary, the Senior Grand Deacon, the Grand Director of Ceremonies, W. Brother Jas. Patton, W. Brother R. Percy Dixon, D. D. G. M. and R. W. Brother Geo. Ackman, of Keith Lodge, Moncton, I went to Sackville for the purpose of visiting Lebanon Lodge, No. 28, and to install the W. M. elect, Brother Jas. H. Williams, the

Wardens, and other officers of the Lodge. Not only was there a full attendance of the members of Lebanon Lodge present, but also many brethren from Dorchester, Moncton and Amherst. At this visitation I had the particular pleasure of meeting M. W. Brother Chas. R. Smith, P. G. M. of the Grand Lodge of Nova Scotia, whose presence added much to the interest of the occasion. After the ceremonial of installation the M. M. Degree was conferred by the officers of Grand Lodge. Lebanon Lodge has had large additions to its numbers in the past few years and is now an active and very prosperous lodge. We all regretted exceedingly the absence, through illness, of our good Brother R. W. Daniel Jordan who has done much to bring Lebanon Lodge to its present condition of efficiency, and who, we trust, may long be spared to assist his Brethren by his skill and counsel. Following labour the members of Grand Lodge and visiting Brethren were entertained at a magnificent banquet. Every one enjoyed the good cheer provided, the enthusiastic responses to the various toasts, and the hearty good will and fellowship that prevailed.

April 1st, accompanied by a full staff of Grand Lodge officers, past and present, I had the great pleasure of visiting Albion Lodge, No. 1, and seeing the M. M. Degree conferred by W. Brother Crockett and his efficient staff of officers. This Lodge still keeps up its old reputation for accurate and painstaking work. Among its numbers are enrolled some of the best ritualists in the craft, and not a detail was omitted that could serve to make the floor work most impressive. It is pleasing to find Albion Lodge still just as vigorous and quite as efficient as in any previous period of its history. The social entertainment furnished by the hospitable Brethren of Albion in the banquet hall at the close of the business of the evening was greatly appreciated and much enjoyed by all.

May 6th, accompanied by R. W. Brother J. Twining Hartt, Grand Secretary, W. Brother Wm. H. Smith, S. G. Deacon, W. Brother H. E. Gould, G. Director of Ceremonies, Brother D. Arnold Fox, Grand Organist, I went to McAdam to visit Ashlar Lodge, No. 36. At McAdam we were joined by P.G.M. J. T. Whitlock, P.D.G.M. Donald Munro, W. Brother Clifford G. Chase, D. D. G. M., W. Brother P. G. McFarlane, P. S. G. D., and several other Brethren from St. Stephen and Woodstock. The W.M., Brother Arthur L. Jolliffe welcomed us most cordially on behalf of the Lodge, and afterwards worked the M. M. Degree in such a manner as to earn the warm commendation of myself and other officers of Grand Lodge. Ashlar Lodge is evidently in a highly prosperous condition. The Grand Secretary found the books in good order and the records carefully and accurately kept. At this visit I had the great pleasure of presenting R. W. Brother Geo. Rothwell, a Past Master's jewel, the gift of the Lodge, to show their high appreciation of his services as Secretary. The splendid banquet given us in the Depot Hotel by the hospitable Brethren of Ashlar made the occasion of this official visit one of the most delightful we had yet spent.

On June 15th, accompanied by P. G. M. Thomas Walker, P. D. G. M. Andrew McNichol, the Grand Secretary, the Grand Director of Ceremonies, D. D. G. M. R. Percy Dixon, D. Arnold Fox, Grand Organist, and W. Brothers Wm. C. Birrell and J. Herbert Crockett, I paid an official visit to Keith Lodge, No. 23, at Moncton. On arriving at the lodge room we found a very large gathering of the craft present to meet us, and received a warm welcome from the W. M., Brother Forbes. Afterwards at the request of the Worshipful Master the officers of Grand Lodge conferred the M.M. Degree on two candidates. After the business of the lodge was concluded, light refreshments were served in the lodge room and a couple of hours

were most agreeably spent in pleasant social intercourse. Keith Lodge, which celebrated its semi-centennial about five years ago, has over 150 members on its roll and is certainly in a very active and efficient condition.

I have nominated W. Brother Chas. D. Jones for appointment as Representative of the Grand Lodge of Quebec near the Grand Lodge of New Brunswick, in the place of R. W. Brother A. I. Trueman, deceased.

R. W. Brother David Dearnass as representative of the Grand Lodge of Queensland near this Grand Lodge in the place of W. Brother Frank L. Tufts, deceased.

W. Brother Geo. E. Day as representative of the Grand Lodge of Georgia, near this Grand Lodge, in the place of R. W. Brother John D. Short, deceased.

W. Brother H. Colby Smith as representative of the Grand Lodge of Michigan, in the place of R. W. Brother William D. Forster, deceased.

R. W. Brother Hedley V. B. Bridges as representative of the Grand Lodge of Washington near this Grand Lodge in place of W. Brother Alex. W. MacRae, deceased.

In the terrible conflagration which visited Campbellton early in July and entirely destroyed that flourishing town, our Brethren of Campbellton Lodge lost their new building and everything that it contained. The insurance carried is only sufficient to pay the amount of their indebtedness, and all that is now left them is the lot on which the Lodge once stood. It would seem therefore that here is an occasion where it is our duty to show in a practical way that brotherly love which is one of the tenets of our profession, and I would recommend that Grand Lodge set aside at least the sum of \$300 for the assistance of our Brethren in Campbellton, leaving it optional with the members of the Lodge to use the money as they may think best. The Secretary of the Lodge has also reported the

destruction of the Charter, and I have directed that a duplicate be at once prepared, and I would ask Grand Lodge to confirm this action. In connection with the disaster at Campbellton, I have much pleasure in calling your attention to an act of kindly sympathy on the part of the Grand Master of the Grand Lodge of Canada in Ontario, M. W. Brother D. F. MacWatt. At his request the Grand Secretary of that Grand Lodge wrote to our Grand Secretary saying that their Grand Master had been much exercised over the severe loss which has befallen the town of Campbellton, and desired to ask whether there were any Masons in that town who were in need of relief — that, if there were, he would be very happy to recommend a grant for that purpose from the funds of their Grand Lodge. On receipt of this communication I at once asked our Grand Secretary to telegraph our sincere thanks, stating the exact position of our Brethren in Campbellton, and adding that such a grant would be most acceptable to them. It seems to me that it would be proper for this Grand Lodge to pass a resolution expressing our thanks for such a kind and generous action.

I would also recommend that Grand Lodge place the sum of \$200 at the disposal of the Grand Master to provide instruction for private Lodges.

And now, my Brethren, it affords me much pleasure to be able to say that peace and harmony prevail throughout our jurisdiction. There has been much activity in the Lodges throughout the Province during the past year, and the reports of the Grand Treasurer and Grand Secretary will show you that the finances of Grand Lodge are in a sound condition, and that there is a substantial increase in our membership. Our relations with Sister Grand Lodges have been most cordial and friendly, and the future looks bright and prosperous.

Permit me in closing to express my gratitude to you all for the loyal support which has been so cheerfully

accorded me during my year of office, and to assure you that while I have fallen far short of what I desired to accomplish I have been animated by a sincere desire to promote the interests and dignity of our noble order.

The R. W. Deputy Grand Master submitted the following report of the Board of General Purposes.

### REPORT OF THE BOARD OF GENERAL PURPOSES.

*To the Most Worshipful Grand Lodge, F. and A. M., of New Brunswick:*

The Board of General Purposes begs to submit to Grand Lodge its report for the past year.

The Board held its usual quota of meetings, five in all, and at the first meeting, on September 22nd, elected the Senior Grand Warden, R. W. Stewart L. Morrison, Vice-President.

It will be recalled that Grand Lodge at its last Communication adopted the Board's recommendation to invest fifteen hundred dollars of the general balance on account of the Fund of Benevolence; and so at this same meeting the Grand Treasurer and R. W. Brother Edwin J. Everett were empowered to make the investment. It was subsequently reported that a purchase had been made of three Bonds of the N. B. Masonic Hall Company \$500 each, payable in twenty years, and bearing interest at four and a half per cent. and that these Bonds had been carried over to the assets of the Fund of Benevolence.

The only other matter which Grand Lodge directly placed with the Board was the authority to procure a new set of regalia. A sub-committee of three members of the Board was appointed to obtain information and report. One of this Committee was the late R. W. Edwin J. Everett, P. G. M., and it was known that he already possessed very full data as to cost and as to reliable London manufacturers. No meeting of the Committee, however, was held before Brother Everett's death, and so the information has not been laid before the Board. A prominent Mason of Toronto, familiar with the subject, has recently been asked to advise upon the matter; so if Grand Lodge is still in favour of making the purchase the incoming Board can soon take action.

A business communication from the N. B. Masonic Hall Company made it necessary to hold a special meeting in November. This was to the effect that the Company intended to issue \$2,000 of recently authorized Bonds and take up the certificate of indebtedness for that amount so long held in the funds of Grand Lodge; but giving the Board the option to take the Bonds at 97½. The Board was unanimous in accepting the option and the Grand Treasurer was authorized to make the exchange, and this was shortly afterwards done.

Two applications for duplicate Grand Lodge certificates have been made to the Board, the Brother in each case, asserting that despite careful search the certificate could not be found. The Board, however, adhered to the rule that mere loss is not sufficient and that there must be undoubted proof of destruction, partial or total, before a duplicate can be issued.

Early in the year a communication was received from the Recording Grand Secretary of Massachusetts to the effect that from time to time, relief had been granted from his office to the widow of a Brother, once a member of Leinster Lodge, late on the Register, and intimating that the case was one for the cognizance of this Grand Lodge. On inquiry it was ascertained that the Brother was an excluded member at the time Leinster Lodge surrendered its warrant and was subsequently restored by the Board of General Purposes and took his demit, his residence then being in the United States. Under such circumstances the Board could not but resolve “that there is no fund under its control out of which aid could be granted to the late Brother's widow or family.”

The report of the Audit Committee on the finances of Grand Lodge is here inserted and the Board, in view of the prosperity of the past year, is glad to recommend Grand Lodge to direct the transfer of the sum of two thousand dollars from the General Account to the Fund of Benevolence for investment on the Fund's Account.

The words of welcome spoken by Past Grand Master Ellis and the subsequent "Grand Honours" were acknowledged by the Grand Master who then assumed the East.

The Report of the Special Committee on the Grand Master's Address was presented by its Chairman, R. W. Brother His Honour Judge Forbes, and on his motion, seconded by Past Grand Master Walker, the report was received and adopted and its recommendations ordered to be carried out.



Grand Lodge was opened in *ample* form at the hour of three of the clock with solemn prayer and the reading of the 24th psalm.

The M. W. Grand Master directed the Grand Pursuivant to admit Master Masons as Visitors if in good standing and properly clothed.

On motion of R. W. Brother His Honour Judge Forbes, P. G. M., it was ordered, "That the Minutes of the last Annual Communication be taken as read and confirmed, inasmuch as they had been printed in the Annual Proceedings of which copies had been distributed through the jurisdiction."

The minutes of the Emergent Communication of June 25th were read and confirmed.

The M. W. Grand Master directed that the Report of the Credential Committee be presented at the evening session.

The M. W. Grand Master then delivered the following address:

## GRAND MASTER'S ADDRESS.

*Brethren of the Grand Lodge of New Brunswick:*

At the end of another year it is our privilege to meet once more within these walls in that spirit of charity, of brotherly love, and gratitude to God which should always characterize these annual gatherings. Another year in the history of Freemasonry in New Brunswick has passed away and again I stand before you to give an account of my stewardship, and to extend to each one of you a sincere and hearty welcome to this the Forty-fourth Annual Communication of the Grand Lodge of New Brunswick.

As Freemasons we should be profoundly grateful to God for the continued prosperity of this great British Empire of which we form a part, for the constant growth and healthy condition of the Craft within this jurisdiction, and for the harmonious and friendly relations that have existed between this and other Grand Lodges.

It is also my privilege and pleasure to report that peace and harmony have prevailed throughout every part of this jurisdiction, and also that there has been unusual activity in the Subordinate Lodges throughout the Province during the past year. The reports of these Lodges will show a substantial increase in our membership. But, my brethren, it is well to remember that it is not the number of those who wear the lamb skin that has given to our fraternity the proud position that it has always held in the world's estimation, but rather the internal qualifications and exemplary conduct of each individual Mason. No anxiety therefore to increase the membership of our Lodge should ever lead us to permit those to join our ranks who do not maintain that high moral standing which should always characterize good Masons. If we wish to preserve the high standing of our noble fraternity, we must never lose sight of that well known maxim, "Guard well the outer door."

We have looked forward to this annual communication with feelings of the deepest pleasure, for it is and ever should be a time of enjoyment, yet while we are met here as friends and brothers and have exchanged cordial hand clasps with each other, a feeling of sadness pervades our minds as we recall the fact that many places are to-day vacant in our ranks which were ably filled a year ago — Death, the great reaper, has taken from among us several brothers whose absence we sincerely mourn, and whose companionship is greatly missed. To their surviving

friends and relatives we to-day tender our sincere and heart-felt sympathy in their sad bereavement.

The roll of Hiram Lodge is reduced by the death of three of its members, who were also members of Grand Lodge. W. Brother A. G. Beckwith, who had been living for some years in New York died in that city October 23, 1910. He first received light in Solomon's Lodge in the City of Fredericton, February 26, 1861. After his initiation he took an active interest in Masonic work and was elected Worshipful Master of Solomon's, which office he held in 1865 and again 1866. Brother Beckwith often attended the communications of Grand Lodge, and was made Senior Grand Deacon in 1870. During his long residence in Fredericton he was a public spirited citizen and was always active in promoting whatever was conducive to the development and progress of the city. His nature was generous and sympathetic, and those whose privilege it was to know him intimately found him a sincere and warm-hearted friend.

R. W. Brother Alfred F. Street died in the City of Fredericton December 11, 1910. He was initiated in Solomon's Lodge in 1869, and was its Worshipful Master in 1874 and 1875, and afterwards in 1877 and 1878. When St. Andrew's and Solomon's Lodges were united, Brother Street was elected as the first Master of the new Lodge now known as Hiram, No. 6, and discharged the duties of that important office in a highly satisfactory manner. Keenly interested in Masonic work he often attended the communications of Grand Lodge and was elected Junior Grand Warden in 1874. He was thoroughly versed in the ritual and took great pleasure in instructing the younger men, some of whom still feel the benefit of his careful teaching. He was prompt and correct in the discharge of his important duties as Collector of Customs at the port of Fredericton, faithful and devoted to the interests of

Hiram Lodge, and will be much missed by the members of the Craft throughout the Province. At the time of his death Brother Street was the representative of the Grand Lodge of Arkansas near this Grand Lodge.

W. Brother Herbert C. Creed, who had been the efficient Secretary of Hiram Lodge many years, died August 31, 1910. He was initiated in Solomon's Lodge, Fredericton, February 11, 1873, and raised April 3 of the same year. Three years later he was elected Worshipful Master and took a prominent part in the union of Solomon's and St. Andrew's Lodges. It was at his suggestion that the name Hiram was given to the united Lodge. In the Lodge room to-day are the rough ashlar and the perfect ashlar which were presented to Hiram Lodge by W. Brother Creed at the time of the union. From 1880 to 1901 Dr. Creed was not connected with the Lodge, but rejoining in April, 1901, he occupied the office of Chaplain for four years, and that of Secretary until his death. His knowledge of the ritual, his strict attention to detail, and his regular attendance even in failing health exerted an influence for good over his brethren that is not easily overestimated. The sweet remembrance of his many virtues will long be cherished by his many friends in the Lodge for which he loved to work, and which he served so faithfully.

Carleton Union Lodge sincerely mourns the death of Brother Jarvis Wilson, who died February 27, 1911, at the great age of ninety-four. Brother Wilson was born in the County Tyrone, Ireland, in 1817, came to New Brunswick in 1834, and took up his abode for a time in Queens County, but moved to Carleton in 1845, where he resided until the time of his death. Becoming a member of Carleton Union Lodge in 1862, he maintained a deep interest in its affairs for nearly half a century and faithfully attended the meetings of the Lodge until two months before his death. In 1899 he was made an honorary member

of Grand Lodge with the rank of Junior Grand Deacon. In his early days Brother Wilson was a very active business man, was for several years a member of the Common Council, and always identified himself with every movement that concerned the public good. He was always active in the religious life of the community in which he lived, and for nearly fifty years was an elder in the Carleton Presbyterian Church. A good citizen, an upright man and Mason he died sincerely regretted by the whole community in which he had lived for more than sixty years.

Hibernia Lodge lost on the 4th June, 1911, its oldest Past Master, W. Brother John Johnston. Brother Johnston received his M. M. Degree in Hibernia Lodge September 22, 1863, when the Lodge was working under a charter from the Grand Lodge of Ireland. He was installed Worshipful Master of his Lodge in 1868, and again in 1886. At the time of his death he had been a member of Hibernia for 48 years, and its treasurer for many years. Brother Johnston was a skilful workman in his business, an excellent citizen and a good Mason. Faithful in all things entrusted to his care he died greatly regretted by his many friends and highly respected by all who knew him.

Sussex Lodge, No. 7, lost on the 8th of April, 1911, one of its oldest Past Masters, R. W. Brother Henry Graham, who died very suddenly in St. Stephen at the age of seventy-one. Brother Graham was born in England, but came to this province in early life and resided for a time in the City of Fredericton. Later he went to New York to live and received his M. M. Degree in 1866 in Kings County Lodge, No. 511, Flatbush, Long Island. On his return to New Brunswick he took up his residence in St. Stephen, where he affiliated with Sussex Lodge, No. 7, in 1872, and was elected its Worshipful Master in 1880. For a time he took an active interest in the affairs of Grand Lodge

and was elected Senior Grand Warden in 1883. In civic and municipal matters he took a very prominent place, having served as Mayor of St. Stephen and also Warden of Charlotte County. At the time of his death he was the Representative of the Grand Lodge of New York near this Grand Lodge.

W. Brother Andrew Skillen, the oldest Past Master of St. Martins Lodge, No. 30, entered into rest at the age of ninety years, on the 10th of August, 1911. He was initiated in True Blue Lodge at Killyleagh, County Down, Ireland, in 1842, and was probably the oldest active Mason in Canada, having been a member of the Craft for more than sixty-nine years. Brother Skillen came to New Brunswick in 1848 and carried on business in the City of St. John until 1855, when he moved to St. Martins where he resided until his death. He was enrolled as a member of St. Martins Lodge at its first meeting February 5, 1872, and was installed Treasurer, a position which he held continuously until 1882, when he was elected Worshipful Master. In 1884 he was again elected Treasurer and held this position until his decease. He was made an honorary member of St. Martins Lodge in 1901, and in 1904 the rank of Past Senior Grand Warden was conferred upon him by this Grand Lodge in recognition of his long and devoted interest in Freemasonry. In his younger days he took an active part in municipal matters and represented St. Martins in the Municipal Council on several occasions. Quiet and unassuming in his manner he possessed the confidence and esteem of his fellow citizens and exemplified in his daily walk and intercourse the highest principles of our order.

The Reverend Richard Mathers, Albion Lodge, No. 1, died December 7, 1910. Grand Chaplain 1882, 1883.

The Reverend C. H. Manaton, Past Master of Sussex Lodge, No. 4, Dorchester, died April 25th, 1910.

Robert Hutchinson, Past Master of Lodge Saint Andrew, Richibucto, died August 10th, 1910.

J. M. Deacon, M.D., Past Master of Victoria Lodge, Milltown, died February 20th, 1910.

John L. Ray, Past Master of Victoria Lodge, Milltown, died May 16th, 1910.

## VISITATIONS.

During the past year I have visited quite a number of the Lodges throughout the jurisdiction, not only because it is the duty of a Grand Master to do so, but because I am fully persuaded that such visits, on the part of the officers of Grand Lodge, are productive of much good to the Craft

generally, and aid greatly in securing that accuracy of detail in our ritual which should characterize the working of the several degrees in our Subordinate Lodges. It is a great pleasure to report that, in those Lodges which I was able to visit, the work of conferring the degrees was for the most part admirably done, and that our ritual is being faithfully observed throughout the jurisdiction. The cordial reception extended to myself and the officers of Grand Lodge, who have accompanied me on these occasions, has been a source of very great pleasure to us all, and will remain among the most cherished memories of my life. It is my earnest wish that the present friendly feelings towards Grand Lodge may animate and pervade the minds of the brethren in the several Lodges throughout our jurisdiction during all the years to come.

My first official visit in 1910 was made early in October to the Lodges in the valley of the St. Croix. On October 4th, accompanied by R.W. Brother Thos. Walker, P. G. M., W. Brother Chas. D. Jones, Grand Director of Ceremonies, and Brother D. Arnold Fox, Grand Organist, I left St. John for St. Stephen. On reaching that city we were met at the Windsor Hotel by P. G. M. Julius T. Whitlock, W. Brother M. L. Young, R. W. Brother Walter W. Inches, W. Brother Clifford G. Chase, D. D. G. M., with whom we exchanged most pleasant and cordial fraternal greetings. In the evening, accompanied by all the brethren mentioned above, I visited Sussex Lodge, No. 7, where I was warmly welcomed by R. W. Brother Jas. Vroom, whom I found occupying the chair in the absence of the W.M., Brother Frank H. Beek, whose health had been for some time in a delicate and uncertain state. While we greatly regretted the absence of the Worshipful Master, we were pleased to see so accurate a ritualist as R. W. Brother Vroom in his place, and found him quite equal to the occasion, as he abundantly proved this by the

manner in which he worked the First Degree. Brother Vroom also exemplified the work of the Second Degree with the same accuracy that characterized his work in the First. The books and accounts of the Lodge were examined by R. W. Brother Thos. Walker, P. G. M., who acted as Grand Secretary in the absence of R. W. Brother Hartt, and found to be thoroughly and accurately kept. Before closing the Lodge Brother Vroom gave the visiting officers an opportunity for speech making and some interesting remarks were made. The reminiscences of R. W. Brother J. T. Whitlock, P. G. M., who had just returned from a trip across the Atlantic, and who had, during his visit away, attended a session of the Grand Lodge of England, were most instructive and thoroughly enjoyed by all.

Making St. Stephen my headquarters for the next two days I visited in succession Victoria Lodge, No. 26, at Milltown on the night of October 5, and Alley Lodge, No. 14, at Upper Mills on the night of October 6. On my visit to Victoria Lodge I was accompanied by R. W. Brother J. T. Whitlock, P. G. M., R. W. Brother Jas. Vroom, P. D. G. M., W. Brother Melvin L. Young, as S. G. W., W. Brother Walter W. Inches, as J. G. W., R. W. Brother J. Twining Hartt, Grand Secretary, W. Brother Clifford G. Chase, D. D. G. M., W. Brother Wm. H. Smith, as G. D. C., W. Brother A. Mungall, as S. G. Deacon, and Brother D. Arnold Fox, Grand Organist. The attendance of members and visitors was large and the W.M., Brother A. P. Dewar, with an efficient corps of officers, worked the Third Degree in a correct and impressive manner. Light refreshments were served in the lodge room at the conclusion of the labors of the evening, and a most enjoyable time was spent in renewing and strengthening old friendships and forming new ones. Victoria Lodge is evidently in a very prosperous condition.

On my visit to Alley Lodge I was accompanied by W. Brother C. G. Chase, as D. G. M., W. Brother Melvin L. Young, as S. G. W., R. W. Brother Walter W. Inches, as J. G. W., R. W. Brother J. Twining Hartt, Grand Secretary, W. Brother A. H. Hiltz, as G. D. of C., and W. Brothers A. A. Laffin and Dr. Lawson, as Grand Deacons. The W. M., Brother Neil D. Smith, was in the East and gave us a hearty welcome. There was no candidate in waiting for a degree, but at my request the Worshipful Master and his officers exemplified the First Degree in a highly creditable manner. A notable feature of the evening was the presentation to the Lodge by the D. D. G. M., W. Brother Clifford G. Chase, of a portrait of his father, the late Granville Chase. The W. M., in accepting the portrait of our late Brother Chase, whose death, at a comparatively early age, had been deeply regretted by the whole community in which he had lived, referred in fitting terms to his sterling qualities as a man and Mason, and mentioned particularly the high esteem which was felt for his memory by the members of Alley Lodge. There can be no doubt that the future of Alley Lodge looks bright and prosperous. The lodge room has been thoroughly renovated within the past few years and now presents a bright and most attractive appearance, many new members have been initiated and all are evidently animated by an earnest and zealous feeling of attachment to our noble Order. During our stay in St. Stephen the many kind attentions extended to both the Grand Secretary and myself by Brothers Walter Inches, Dr. Melvin Young, Jas. Vroom, and P. G. M. Whitlock made this visit a particularly agreeable one and added greatly to our enjoyment.

On the night of October 26, accompanied by P. G. M. Thos. Walker and a large number of Grand Lodge officers, past as well as present, I paid a visit to the Union Lodge of Portland, No. 10, and found W. Brother J. Morris

Robinson presiding in the East. After a cordial reception by the W. M., and the interchange of fraternal greetings, the officers of Grand Lodge witnessed the conferring of the Third Degree, in the working of which the Worshipful Master was ably assisted by his efficient staff of officers. The work was correct and impressive throughout, as was to be expected in a Lodge which possesses such accurate ritualists as the Grand Treasurer and the Grand Secretary. The chanting of that sublime passage of Scripture — "Remember now thy Creator, etc.," by a picked choir of voices, under the direction of Brother D. Arnold Fox, Grand Organist, was thoroughly enjoyed by all lovers of good music present, and added greatly to the impressiveness of the ceremonial. After labour was concluded, the Worshipful Master invited the officers of Grand Lodge and the visiting brethren to partake of the good cheer provided in the banquet hall. Here we spent a couple of hours most pleasantly and profitably, all experiencing feelings of regret when the time came for us to part. The Union Lodge of Portland is evidently in good hands and there can be no doubt of its continued prosperity.

On the evening of November 3, accompanied by a full corps of Grand Lodge officers, I had the pleasure of paying my first official visit to Carleton Union Lodge. The attendance of members and visiting brethren was very large, and the Worshipful Master, Brother John Emerson, gave us a cordial welcome in appropriate and graceful language. The work for the evening was that of conferring the First Degree, which was carried out in a manner that I have seldom seen equalled and never surpassed in any of the Lodges which I have yet visited. The Lodges on the east side of the harbour will have to look well to their laurels or they may be surpassed by Carleton Union Lodge in accuracy and effectiveness of work. One of the pleasant memories connected with this visit was that of

meeting three generations of one family as members of this Lodge — viz., Brother Jarvis Wilson, his son and grandson. Brother Wilson had reached the great age of ninety-four, but was still hale and cheerful and in the complete possession of all his faculties. As he conversed with us so brightly and pleasantly, none could realize that this was to be the last occasion on which we were to meet him in Carleton Union Lodge. After the close of the Lodge we accepted an invitation to refreshment and spent a most enjoyable hour in social intercourse with our brethren of Carleton Union, being obliged to leave all too soon in order to be in time for the last trip of the ferry boat to the East side. Carleton Union possesses one of the most attractive lodge rooms in the jurisdiction, the members both old and young being thoroughly devoted to its interests, and will be in the future, as it has ever been in the past, a prosperous and progressive Lodge.

January 3rd, 1911, accompanied by a large number of Grand and Past Grand officers I paid an official visit to St. John's Lodge, No. 2, for the purpose of installing the Worshipful Master elect, Brother C. A. Rutherford, and other officers. There was a very large gathering of the Craft present, and we found W. Brother W. S. Clawson, the retiring Master, presiding in the East, under whose guiding hand this, my Mother Lodge, had had a prosperous year. The members of St. John's feel proud of its past history and are untiring in their efforts to promote its interests, and to keep it in that prominent place which it has always occupied among the Lodges of the Province. The banquet at the close of the labours of the evening was greatly enjoyed by all, enlivened as it was by pleasant speeches and good music.

On the evening of January 13, 1911, accompanied by V. W. Brother Fred G. Knowlton, Grand Treasurer, R. W. Brother J. Twining Hartt, Grand Secretary, W. Brother

Chas. D. Jones, G. D. C., and Brother D. Arnold Fox, Grand Organist, I went to Hampton for the purpose of installing the Worshipful Master elect of the Corinthian Lodge, Brother E. Allan Schofield, and the other officers. There was a good attendance of members, some of whom had travelled a long distance in order to be present, and we were given a cordial welcome by the retiring Master, W. Brother Cecil March, under whose care the Lodge had greatly prospered during the past year. It is always a very pleasing duty to visit this Lodge and to note the evidences of prosperity which have fallen to its lot in recent years. Everything possible was done by Brother Schofield to make our visit an agreeable one, and the pleasant social intercourse enjoyed with our brethren in Hampton while partaking of the abundant good cheer provided for us after the ceremony of installation was concluded still remains fresh in our memory.

On May 9th, accompanied by R. W. Brother Thos. Walker, P. G. M., R. W. Brother David Dearness, D. G. M., W. Brother Chas. D. Jones, G. D. C., and Brother D. Arnold Fox, Grand Organist, I went to Newcastle to pay an official visit to Northumberland Lodge, No. 17. On arriving at Newcastle we were met at the station by Dr. Nicholson, the Worshipful Master, who conveyed our party to the hotel, after first giving us a very pleasant drive around the town. In the evening of the same day we proceeded to the Lodge, where we were joined by R. W. Brother Robert Murray, P. D. G. M., R. W. Brother W. R. Gould, S. G. W., and a large number of the Craft from Miramichi Lodge which is situated in the adjoining Town of Chatham. At the request of the Worshipful Master the officers of Grand Lodge, who were with me, assisted by R. W. Brothers Murray and Maltby, worked the Third Degree, for which no less than six candidates presented themselves. There was a very large attendance of members and visitors

present, and I was very much pleased to find such Past Masters as Brothers Richard L. Maltby, Dr. Pedolin, and Hon. John P. Burchill still taking an active interest in the affairs of their Lodge. Many new members have been added to the roll of Northumberland Lodge since Brother Nicholson has been in the chair, and its present condition is most gratifying. R. W. Brother Murray, who acted as Grand Secretary in the absence of Brother Twining Hartt, examined the books of the Secretary and Treasurer and found them in a satisfactory state. Light refreshments were served in the lodge room when the labours of the evening were over, and a most enjoyable hour was spent in social intercourse with the hospitable brethren of Northumberland Lodge.

During April I received a petition from a number of brethren asking for a dispensation to open another Lodge at Moncton to be called Tweedie Lodge. As this petition was accompanied by the recommendation of Keith Lodge, No. 23, I thought proper to grant the request of the petitioners and directed that a dispensation be issued to them, and on May 12th, accompanied by the Grand Secretary and Grand Organist, I went to Moncton for the purpose of instituting Tweedie Lodge, U. D. With the assistance of R. W. Brother H. B. Fleming, as D. G. M., R. W. Brother Geo. Ackman, as S. G. W., R. W. Brother Jas. E. Masters, as J. G. W., R. W. Brother Geo. R. Sangster, as Grand Treasurer, R. W. Brother J. Twining Hartt, Grand Secretary, W. Brother R. P. Dickson, as S. G. Deacon, W. Brother F. P. Forbes, as J. G. Deacon, and W. Brother Geo. H. Pick, as G. D. of C., I placed Brother Fred W. Emerson in the East as W. M., Brother Samuel C. Alward in the West as S. W., Brother Geo. Percy Kirk in the South as J. W., and Brother M. J. Steeves as Secretary. The First Degree was then conferred on three

candidates. I would recommend that the prayer of these petitioners for a charter be granted, as I am satisfied that good results will follow the opening of this new Lodge in the thriving City of Moncton.

In the month of February last it was my privilege to accept the cordial invitation which was extended to me as your Grand Master, by the Grand Lodge of the District of Columbia to be present with them on the occasion of the celebration of their one hundredth anniversary at Washington. The proceedings connected with this great Masonic festival were of unusual interest, and extended over a period of three days. On the evening of Saturday, February 18, there was a reception to the Craft in the new Masonic Temple at Washington when the visiting Grand Masters had an opportunity of exchanging fraternal greetings with M. W. Brother Keiper, Grand Master of the Grand Lodge of the District of Columbia, and other distinguished members of the Craft in Washington. On Sunday, February 19, at 3 p. m., a most interesting and inspiring religious service was held in Belasco's Theatre, which was filled to overflowing. The addresses delivered on this occasion were full of the true spirit of Freemasonry and were listened to with the closest attention by the large gathering present. On the morning of Monday, February 20, the visiting Grand Masters attended a special communication of the Grand Lodge, and in the evening of the same day were entertained at a sumptuous banquet in the new Willard Hotel. Everything was done by Grand Master Keiper and the committee in charge of the celebration to look after the comfort of their visitors, and they are certainly to be congratulated on the great success which marked every feature of their one hundredth anniversary.

I have nominated W. Brother C. Fred. Chestnut for appointment as Representative of the Grand Lodge of

Arkansas near the Grand Lodge of New Brunswick in the place of R. W. Brother A. F. Street deceased.

W. Brother John A. Morrison for appointment as Representative of the Grand Lodge of Ohio near this Grand Lodge in place of W. Brother H. C. Creed deceased.

W. Brother Francis F. Burpee for appointment as Representative of the Grand Lodge of New York near this Grand Lodge in the place of R. W. Brother Henry Graham deceased.

W. Brother Robert Clerke for appointment as Representative of the Grand Lodge of North Dakota near this Grand Lodge in the place of W. Brother John Johnston deceased.

An Emergent Communication was held in the City of St. John on Sunday, June 25, at the Masonic Temple for the purpose of attending Divine service. There was a large attendance of members from the several Lodges in the City besides many brethren from other parts of the Province. After Grand Lodge had been opened in ample form, a procession was formed under the direction of W. Brother C. D. Jones, G. D. C., and W. Brother Francis F. Burpee, as Assistant G. D. C., and the brethren then marched to St. Stephen's Church where service was conducted by the Grand Chaplain, Rev. Gordon Dickie. The sermon preached by the Grand Chaplain on this occasion was a very instructive one and was listened to with marked attention by all. After the conclusion of the service, the brethren returned to the Temple, where, after appropriate resolutions had been passed thanking the Trustees of St. Stephen's Church for their kindness in allowing them the use of the building, and the Grand Chaplain for his able and instructive sermon, Grand Lodge was closed in ample form. The presence of an escort of Knight Templars under the command of Sir Knight Thos.

E. Powers added materially to the appearance of the procession, and I take this opportunity to thank the Knights for the courtesy extended on this occasion.

Two events of peculiar interest to every citizen of the great Empire of which we form a part have occurred during the past year, and it is quite fitting that some reference should be made to them on the present occasion. The Coronation of King George V. at Westminster Abbey was perhaps the most magnificent spectacle that has ever been witnessed in that historic building. As Freemasons we rejoiced greatly in the spontaneous outburst of loyalty with which the crowning of the King was attended in every part of his vast dominions. We hope that he may long be spared to rule over us, and that he may follow in the footsteps of his father, King Edward the "Peacemaker," who was so long the patron of our Order.

In August, 1911, not many weeks after the Coronation of the King there was signed at Washington a general treaty of arbitration between Great Britain and the United States of America. As members of an Order that professes to be actuated by the noblest principles and animated by the spirit of brotherly love, we must surely welcome the ratification of such an important agreement between the great Mother Land and her earliest offspring, and earnestly pray that the other nations of the earth may be influenced by the noble example set before them to do likewise, thus ushering in the time of universal peace so vividly pictured by Tennyson:

"When the war-drum throb'd no longer, and the battle-flags were furled,  
In the Parliament of man, the Federation of the world."

From the reports of the Grand Treasurer and Grand Secretary, which will be laid before you at this meeting, it will be seen that the finances of Grand Lodge are in a sound condition and that there is again an increase in our membership.

It would be well for Grand Lodge to place the sum of \$200 at the disposal of the Grand Master to provide instruction for private Lodges, and I recommend that this be done as heretofore.

I desire before closing, to sincerely thank my associate officers for their promptness and willingness to assist me on all occasions in the discharge of the numerous duties pertaining to this office — more especially do I extend my thanks to the Grand Secretary, for the uniform courtesy and kindness which have always characterized him in the discharge of his duties.

And now, brethren, it is my earnest wish, that all our deliberations on the present occasion may be carried on in the spirit of brotherly love, and that prudence and wisdom may guide us in all our doings.

The report of the Board of General Purposes was then submitted by the Acting Deputy Grand Master, R. W. Brother James Vroom, P. D. G. M.

It was as follows:

### REPORT OF THE BOARD OF GENERAL PURPOSES.

*To the Most Worshipful Grand Lodge, F. and A. M., of New Brunswick:*

The Board of General Purposes begs to submit its report for the past year.

The Board has held three Regular and three Special Meetings, at the first of which the Senior Grand Warden, R. W. Wilfrid R. Gould was elected Vice-President.

As Grand Lodge had approved of the proposal to transfer Two Thousand Dollars to the Fund of Benevolence, the Board requested the Grand Treasurer and R. W. Brother Thomas Walker to select the investments, and they agreed on the purchase of four Town of Truro Bonds of \$500 each, bearing interest at 4½ per cent.

The only matter referred to the Board by Grand Lodge was that of obtaining new Regalia for Grand Lodge Officers. A Special Committee was appointed to obtain information as to reliable makers and probable cost. Subsequently, however, on learning that Past Grand Master Walker intended to visit England during the present summer, the Board entrusted him with authority to interview London firms and to place the order. No communication has yet been received from R. W. Brother Walker since his arrival in England, but doubtless, ere long, Grand Lodge will be in possession of a set of Regalia such as is needed for special occasions.

At its first meeting the Board appointed a Special Committee of five to frame Rules and Regulations for administering the Fund of Benevolence, it being generally felt that the income of the Fund should henceforth be available for cases of need. The report of this Committee was fully considered by the Board, and the Rules as finally adopted are here inserted for the information of the Craft:

## RULES AND REGULATIONS.

FUND OF BENEVOLENCE OF THE GRAND LODGE OF NEW BRUNSWICK,  
ADMINISTERED FOR THE BENEFIT OF MEMBERS OF THE CRAFT IN  
NEW BRUNSWICK.

In order to be entitled to aid from the Fund, a Brother must be a Regular Member of a Lodge under the jurisdiction of the Grand Lodge of New Brunswick at the time of his application for aid, must have been a Subscribing Member for at least four years, and have paid his annual dues to his Lodge for that period. Widows and orphans of Brothers, who are so qualified, are entitled to the benefit of the Fund as though the husband or father were living.

The appeal for help from the Fund must be presented on a prescribed form of application to the Committee in charge of the Fund by the Lodge to which the Brother belongs, over its Seal, and must be signed by the Master and Secretary, and by the Brother who has reported the case to the Lodge.

The administration of the Fund shall be in the hands of a Committee of three Members of the Board, one of whom shall be the Grand Master for the time being, and the others shall be chosen annually by the Board of General Purposes, at the Meeting of the Board called for organization purposes, after the annual session of Grand Lodge, or at some meeting called thereafter.

No grant to any one, either a member, a member's widow, or children, shall exceed in one year the sum of fifty dollars, but if the Grand Master advises the Board to enlarge the amount, it shall be competent for the Board to do so. The Grand Master shall state the maximum amount which he advises, and that amount may be allowed in whole or in part.

The amount expended in any one year by the Committee shall not exceed the annual income of the invested fund in the year preceding.

The grants made shall be paid by cheque issued by the Grand Treasurer, and countersigned in the usual manner.

It shall be, as far as is possible, a guiding principle that the Fund shall not be expended by way of pensions or annuities, but to relieve immediate and pressing distress.

Copies of the above and also Forms of Application have been sent to each Subordinate Lodge.
