

The M:W: Grand Master welcomed the Brethren, outlining the purpose of this Conference and soliciting free discussion of the preliminary agenda and other subjects for the advancement of the Craft in our Jurisdiction.

R:W: Brother James S. Hoyt, Chairman of the Ritual

Committee, opened the forum discussion on topics of ritual, examination of visitors, balloting, reception of Grand Master, D.G.M. and D.D.G.M.s on official visits, Masonic dress, funeral service, etc.

These subjects along with others pertaining to matters of the Craft were enthusiastically discussed and much benefit derived from the deliberations. General approval of this Grand Master's forum was expressed by those assembled.

Following this meeting the M:W: Grand Master, Donald A. Somerville, entertained the distinguished visitors and a number of Grand Lodge members at a sumptuous dinner in the Admiral Beatty Hotel.

Pursuant to a request from M:W: R. V. Harris, Nova Scotia a meeting of the Canadian Masonic Research Association of Canada was held in the Craft Lodge Room, Masonic Temple, Saint John, N. B., at 8:30 p.m.

A large gathering of Brethren attended and enjoyed the following historical papers of particularly significant interest to this Jurisdiction of New Brunswick:—

By M:W: Bro. R. V. Harris, P.G.M., Grand Lodge of Nova Scotia, on Hiram Lodge, the first Lodge in Saint John, established 175 years ago, shortly after the city was founded.

By R:W: R. T. Pearson, P.G.M. of New Brunswick, on old Sion Lodge and its successor at Kingston and Sussex Vale.

The M:W: Grand Master expressed the appreciation of the gathering for the efforts of the two distinguished Brethren in providing this factual information of Masonic history in our Province.

The Annual Meeting of the Masonic Grand Lodge Corporation was held this morning in the Masonic Temple in the City of Saint John, at 9:30 o'clock, pursuant to notice given in the Proclamation summoning the Annual Communication of Grand Lodge.

Those present are listed as being in attendance at Grand Lodge.

The report of the V:W: Grand Treasurer was presented and taken as read, copies having been distributed to the Brethren. The Statement set forth the Receipts and Expenditures on General Account and also of the Fund of Benevolence and a list of the Assets of the Fund. The Grand Treasurer's Statement had previously been considered and adopted by the Board of Directors of the Grand Lodge Corporation.

The Annual Meeting of the “Masonic Grand Lodge Corporation,” on motion, duly seconded, then adjourned.



92nd Annual Communication

May 28th, 1959.

THE NINETY-SECOND ANNUAL COMMUNICATION of "The Grand Lodge of the Antient and Honourable Fraternity of Free and Accepted Masons of New Brunswick" was held at the Masonic Temple, Germain Street, in the City of Saint John, on Thursday, the twenty-eighth day of May, A.D. 1958, A.L. 5959.

Most Worshipful Dr. Donald Andrew Somerville assumed the Throne and Grand Lodge was opened in Ample Form at 10:00 o'clock a.m., with solemn prayer by the V:W: Grand Chaplain, Rev. Frank E. Archibald, followed by the Lord's Prayer:—

"Our Father, Who art in heaven, Hallowed be Thy Name, Thy Kingdom come, Thy Will be done on earth as it is in heaven. Give us this day our daily bread, and forgive us our trespasses as we forgive those who trespass against us. And lead us not into temptation but deliver us from evil. For Thine is the Kingdom and the power and the glory, forever and ever. Amen.

"So mote it be."

The Proclamation calling the Ninety-second Annual Communication of Grand Lodge was read by the R:W: Grand Secretary.

The Most Worshipful Grand Master welcomed the Brethren to Grand Lodge as follows:—

Brethren:

I welcome you to this Ninety-second Annual Communication of Grand Lodge, duly assembled this morning for the consideration and disposition of such business as may be presented to us. I would like to see you participate fully in our deliberations and trust you will enjoy this great experience.

I wish to extend a special welcome to any who are attending for the first time. Particularly am I grateful to see so many presiding Masters present, many of whom welcomed me to their respective Lodges. To all I repeat that our aim and purpose is one, namely, to consider the activities and record of the year, now closing and to plan and build as wisely as we can for the year ahead.

To our Distinguished Visitors, the same welcome applies—we welcome you in every sense that our great Fraternity stands for. We hope that you may leave us with something for the good of the Craft—also that you may receive some inspiration whilst sojourning in our midst. I assure you that your assistance and presence will add greatly to our assembly.

As we gather year after year, the hope is expressed that the future will be brighter — that the dark cloud hanging over us will dissipate in the sunshine — that freedom will come to all peoples. Our Order can best flourish in a peaceful atmosphere — although it has withstood the ravages of time.

Let us keep constantly before us the fact that our world of today needs the philosophy of brotherly love more than ever in its history. Let us also remember that in no other institution, except the church, can better example of this be found than is shown in our Masonic Fraternity. Let us

move onward to new fields of service and grow stronger with each new Mason who becomes a member of our Lodge.

Before proceeding, I would like to say, Brethren, that the gavel I am using today is one presented to me by Keith Lodge following the Installation ceremonies last December. I shall be ever grateful for their thoughtful gift which I hope I may use most fairly and justly in our deliberations.

masonry; not so much buildings the temple of stone, as building the temple of life. But the same rules apply, and the same lessons are taught and learned. Only in speculative masonry, it is not Solomon who purposes to build, who, as architect, draws up his plans upon the trestle board; it is the Divine Architect of the Universe with Whom we have to deal, Whose name is God Himself.

So let our first thought be that the Divine Architect of the Universe, even as King Solomon, plans with great vision the temple of life. For truly the Bible has spoken in Proverbs 29: 18, "Where there is no vision, the people perish." In his mind's eye King Solomon could see that temple as he dreamed it would one day be, could sit down at the trestle board and translate his vision into pictures and lines and drawings; even so the Great Architect of the Universe has His vision for the temple of your life and mine. And God's vision for the temple of our lives we see in Him Who was born in a manger, and worked at a carpenter's bench, and was crucified on the cross and rose again the third day.

And then this thought: the great Architect of the Universe plans with great accuracy. And that is reflected in speculative Masonry in the letter "G" high in the East—Geometry. It is an accurate science. We see it in the proposition that is associated with the name of Euclid and the name of Pythagoras. We see it in the engraving of many a Masonic emblem. "The square on the hypotenuse is equal to the sum of the squares on the other two sides." And forthwith the proposition is proven. Accuracy—it is the hallmark of geometry, it is the hallmark of the plans for the temple, it is the hallmark of God's plans for us.

The Bible bids us to know, in Psalm 37: 23, that "the steps of a good man are ordered by the Lord." His steps are all planned out. In truth, unlike the temple stones of operative masonry, man can go contrary to the overall plan of God, the Architect Supreme, but nevertheless there is still a plan of God for each life that He has made. And often

only at the end of the way, can we, looking back, see the working out of His purposes and plans.

*"With mercy and with judgment, my web of time God wove,
And aye the dews of sorrow were lusted by His love,
I'll bless the hand that guided, I'll bless the heart that planned,
When throned where glory dwelleth, in Emmanuel's land."*

One further thought; the great Architect of the Universe, even God the Father, plans the temple of our lives in great detail. Each one of us He sees; for each one of us He has a place in His plans, His designs upon eternity's trestle board. One of the thrilling experiences in life is to visit the cathedral of Milan in Italy. The architect has planned it to the last detail, and the masons have carefully, indeed meticulously, carried out his plans. The result is a temple of perfection, known throughout the world.

Even so, doth the Divine Architect plan, His purpose being that all men play the part of speculative Masons in carrying out His plans, His designs on the trestle board. A place is there for all, even the most unknown, and most obscure. For they are not unnoticed by the Divine Architect of us all. And what encouragement that means for life, just to know—as Tennyson's "In Memoriam" has it:

*"That nothing walks with aimless feet,
And not one life shall be destroyed,
And cast as rubbish to the void,
When God has made it all complete."*

And Solomon sent to Hiram, saying, behold I purpose to build an house unto the name of the Lord my God."

And of that temple, we, each one of us, are living stones.

The M:W: the Grand Master thanked the V:W: Grand Chaplain for an inspiring service and address.

Grand Lodge now took recess until 2:30 p.m.

When Grand Lodge resumed labor with R:W: Dr. F. C. Thomas, Deputy Grand Master, in the East, the M:W: Grand Master delivered the following address:—

GRAND MASTER'S ADDRESS

*TO THE MOST WORSHIPFUL GRAND LODGE
OF FREE AND ACCEPTED MASONS
OF NEW BRUNSWICK:*

MY BRETHREN:

According to our Constitutions, there comes a time in the proceedings of our Annual Communication, when the Grand Master is required to present himself and deliver a report on the activities which have taken place in his tenure of office. This moment has now arrived

As we convene today in our ninety-second Grand Lodge Communication, in this Loyalist city, in this beautiful room with its many memories contained within its four walls, it is my privilege for the second time, to extend a heartfelt and cordial welcome to my Brethren. It is pleasing to witness so many of the Craft present today. Truly a busy year!

While all my visits were equally enjoyable, I trust no offence will be taken if I refer in detail to my visit to Mananook Lodge on July 25th, mainly due to the difficulty in reaching this outpost of Masonry. Through the efforts of Wor. Bro. W. J. Campbell of Black's Harbour, approximately thirty-five members of Grand Lodge were ferried on the MV Allan McLean to Grand Manan. The use of this vessel was through the generosity of Connors Bros. We were met at the wharf by the Master of Mananook

Lodge, Wor. Bro. Paige Cook, and several of the Brethren, and taken on a tour of the Island. Later, we attended a supper held in conjunction with the Grand Manan Hospital Fair, then adjourned to the lodge room at Woodward's Cove.

As no work was slated, a degree team was hastily assembled under the direction of the D.D.G.M. Summerville of Saint John and a degree exemplified. However, it was not until later that we discovered that our labors for the day were not completed, and that Mother Nature had an eventful return journey in store for us. While the afternoon journey was sunny and enjoyable, with several of the Brethren bearing evidence, for several days after, of what a combination of sun and salt water can do to one's countenance, we were greeted with the exact opposite as we departed in the darkness. The combination of wind and rain played havoc with digestive systems, positions in the boat were taken by all present to meet the needs of the moment and invariably held until the mainland was reached. And so it was with relief that the mainland was again reached and an experience not readily forgotten.

DISTRICT DEPUTY GRAND MASTERS

ANNIVERSARIES

The time is rapidly approaching when several Lodges in the Jurisdiction will be celebrating their Centennials. Thus an opportunity is afforded the Craft for re-dedication to those noble principles by which the Fraternity is known. Salisbury Lodge No. 20 held their Centennial on November 20th and I was pleased to be present, accompanied by a large Grand Lodge. A delightful banquet was held and following the return to the lodge room, I was privileged to dedicate the 100th year regalia.

Another opportunity to attend a Centennial was afforded me recently at Monument Lodge in Houlton, Maine, in the neighboring Jurisdiction. A most appropriate address was given by Grand Master Littlefield, who is with us today. I was accompanied by several of the Brethren from District No. 4.

DEDICATION

An emergent Communication of Grand Lodge was held in Boiestown on October 21st last for the purpose of the Dedication and Consecration of Landmark Lodge, they having been granted their Charter by Grand Lodge a year ago, after operating a sufficient period under Dispensation. Practically all of Grand Lodge was present on this auspicious occasion. The experience of being in office as Grand Master and performing the ceremonies of Dedication is one of the highlights of my term. A masterful address was given by Past Grand Master Burchill. To all who were present and assisted in any way, my deepest thanks.

ALL CANADA and WASHINGTON CONFERENCES

The sixth Biennial Conference of Grand Lodges in Canada was held in Montreal on February 19th to 21st last. I was happy to have in attendance with me, Past Grand Master Pearson and Grand Secretary Lemmon. Various subjects were presented and it was the pleasant task of New Brunswick to lead the discussion on the topic "Province-wide Jurisdiction For Every Lodge." A warm fraternal feeling prevailed throughout the Conference and it was the opinion that much was accomplished.

From Montreal we journeyed to Washington for the annual Conference of Grand Masters of Masons in North America held February 24th and 25th. I mention the topics for discussion to give you an idea of present-day thinking in Speculative Masonry:—

(1) Should Grand Lodges exercise more control over the recognition and activities of organizations requiring Masonic affiliation for membership?

(2) Should Grand Lodges respect the laws of other Grand Jurisdictions concerning candidates?

(3) Should Freemasonry actively reply to anti-masonic religious propaganda on misrepresentation and falsehood?

(4) Should Symbolic Masonry extend its charity outside the Craft?

(5) Should candidates undergo compulsory instruction in Masonic philosophy?

Again, I am in debt to Grand Lodge for having made it possible for my attendance; shall I call it one of the rewards of office.

GRAND TREASURER and GRAND SECRETARY

There are two Brethren in Grand Lodge whose work for and contributions to our Freemasonry set them apart from

all others. They occupy the offices of Grand Treasurer and Grand Secretary respectively. These Brethren are more than mere bearers of titles, they are friends to every Mason, wise counsellors and towers of strength to the Grand Master. V:W: Brother Dalton has assiduously adhered to his budget of a year ago as evidenced by his report shortly to be presented.

The Grand Secretary and myself have been in constant touch with each other throughout the year, both by correspondence and in my visits. Having served an apprenticeship through our late Grand Secretary, R:W: Brother Lemmon has continued the efficiency of that office without interruption and has lessened my labors considerably. For example, throughout the year, dispensations issued under my direction numbered 91 and were issued for the following purposes:—

Records in the office are kept with such perfection that information can be ascertained almost at once.

FIFTY-YEAR PINS and CERTIFICATES

It has been my privilege to have presented this recognition from Grand Lodge on various occasions during the year. In fact, during the past months, a total of 29 passed through the Grand Secretary's office. I am indebted to the other Brethren who have acted for me at various presentations. These elder Masons who have been faithful to Freemasonry for fifty years or more are certainly entitled to this recognition. It also affords the local Lodge a very splendid opportunity to honor a deserving Brother, not only for his devotion to the Craft but also for his service to the community.

VISITATIONS OUTSIDE THE PROVINCE

Since last addressing you, I have been fortunate in attending four sister Grand Lodges as already mentioned in my report. In Nova Scotia, I was honored with the "Erasmus James Phillips Medal," truly a surprise. I was invariably accompanied by other Past Grand Masters or members of Grand Lodge. One of the rewarding features of these visits is the fraternal friendships acquired.

STATE OF THE ORDER

As shown by the Grand Secretary, a modest gain is shown this year in our membership, thus reversing the trend of the last few years. Whether one can deduce from this that interest in Masonry is on the upswing, I am not prepared to say. But I do know that our Fraternity is in the hands of dedicated Brethren whose devotion to duty and our cause will ever place our Order on that pinnacle intended by the founders of our Honorable Society.

CONCLUSION

Brethren, we meet at a time when the world is divided as never before. Despite the fact that we have been drawn closer together through the fantastic development in transportation and communications, the line of division between ideologies has been so sharply drawn that we find ourselves geographical neighbors but poles apart on fundamental beliefs that are near and dear to a Mason's heart.

If there is one single taproot that nourishes the sturdy worldwide institution of Freemasonry, it is the simple and forthright question that every candidate for Masonic degrees must answer: "In whom do you put your trust?"

If he fails to reply with that one word, so well known to us he can never become a member of the Craft, for in that answer alone lies the one universal tie that binds to-

gether Masons of every country, sect and opinion. It is the most and most essential of all of our Ancient Landmarks. Without Freemasonry could not exist.

All of us who are members of the Fraternity have made this declaration. Yes, it is altogether proper to ask ourselves again and again if we actually mean what we say; or have we merely repeated a familiar phrase? Would any other answer do just as well? Or, be more truthful?

There are those who say that too often our actions belie our words; that "In God WE Trust" is more of a platitude than a reality; that frequently we give the impression of placing more trust in material things.

It seems to me that we must again look to the *Great Light* for inspiration in the solution of our Masonic problems, and especially St. John 1: 40-41, in which we read that Andrew "first findeth his *own brother*" which is the simplest and best way to make Freemasonry active.

Freemasonry is something that needs good men, who can be brought by Freemasons to those who know and believe in them. A chain of union among Brothers, by which the fire and enthusiasm of one good Mason can inspire and create a love of good works and a desire to become a part of an active force for good.

And so I say that with our free institutions attacked even by those who were born under them, there is no limit to the work for a Mason to do. You and I are not living up to the traditions of the past; we are not worthy successors of the Masons who have preceded us; we are not performing the service which may well be expected of us, if we are not putting something in time and effort to our obligations as citizens. Masons of today should not be less assiduous than the Masons of yesteryear in that service to duty which binds us whenever and wherever opportunity offers.

Brethren, another Masonic year in our Grand Jurisdiction is soon to end and will then become history. How brief this

term of office has seemed to me in retrospect. Yet each day was spent in some Masonic labor, at times with great satisfaction, at others with disappointment. It seems to me that this quotation from the Scriptures was apt more than once: "Except the Lord build the house, they labor in vain that build it; except the Lord keep the city, the watchman waketh but in vain."

I shall not attempt to thank the Brethren individually for their goodness to me, assuring them that I am no less grateful. We come to the end of this experience much the same as we come to the end of the day. It will be difficult to return to a normal life.

If I have omitted to mention any contribution to Masonry from the Craft during my term as Grand Master, I crave your indulgence, believe me it was appreciated.

And so with the admonition from St. Mark 10: 44, which I have attempted to keep before me at all times: "And whosoever will be chief among you, let him be servant of all."

I now close my report. May the Supreme Architect continue to guide and bless you. May every act, thought, word and deed be to His Glory.

The Lodge has a convenient and suitable place in which to meet being a hall in the United Church in Gunningsville which charges a moderate rental of \$15.00 a month.

Financially the Lodge is in a healthy condition with \$800.00 to its credit in its general account and \$75.00 in the Benevolent Fund account.

There were 61 officers and members as charter members and 14 have been initiated this year so far and 3 have come in by affiliation.

A unique feature of their year has been the attendance

REPORT OF THE GRAND HISTORIAN—1959

*TO THE MOST WORSHIPFUL, THE GRAND MASTER,
OFFICERS AND MEMBERS OF GRAND LODGE:*

As your Grand Historian I beg to submit the following report for the year now drawing to a close:

As most of you know during the greater part of the first half of the year I was ill due to an accident early in July. I desire to express my heartfelt thanks for the great kindness shown me by so many.

Our congratulations are extended to the M:W: the Grand Master on the completion of a second very successful year in office.

At this time you will observe in the anteroom display cases in which are already a number of relics, all of which are valuable to the History Department of our Order in

this Province. We respectfully invite you to look at these and any one who can add to them is earnestly requested to do so. I wish to thank R:W: J. William Duncan for his great help in this particular effort.

Members of the Scottish Rite will, I am sure, be delighted with the beautiful display case and its contents recently installed in the Rite room by the Ill. Deputy for New Brunswick. We offer him our congratulations. What he has accomplished should be an example and an inspiration to us in the Grand Lodge.

At the meeting of the Canadian Masonic Research Association last evening in this room R:W: Ralph T. Pearson, P.G.M., made an excellent contribution by his paper on Sion Lodge No. 21 (P.R.N.S.) 1792-1863, Sion Lodge No. 21, G. L. of England, 1963-1868, and Zion Lodge No. 21 (G.R.N.B.) 1863—date.

Mention must also be made of the paper read in the same meeting by M:W: Dr. R. V. Harris, P.G.M. (N. S.), Secretary-Treasurer of the Association, entitled Hiram Lodge No. 17, Saint John, (1784). Most Worshipful Brother Harris is an honorary Past Grand Master of the Grand Lodge of New Brunswick.

I was fortunate in being able to accompany our Grand Master, Grand Secretary and P.G.M. Pearson to witness the ceremony of turning the first sod in the construction of the new Masasonic building in Amherst, N. S., June 8, 1958. It was noteworthy that the customary spade was absent and the sod was turned by a large flag-decked modern machine controlled by the Grand Master of Nova Scotia, Judge Kenneth L. Crowell. A number of Masons from the Moncton area attended the ceremony of laying a wreath at the Cenotaph which was followed by the turning of the first sod and a Church Service after that. The Grand Master, the Grand Secretary, R:W: Bro. Pearson and I attended the Grand Lodge meetings on Monday, June 9th, when the Grand Mas-

ter and R:W: Bro. Pearson were awarded the Erasmus James Philips medal by the Grand Lodge of Nova Scotia.

June 18th (1958) I had the honor of installing the Grand Junior Deacon, Wor. Bro. W. S. H. Crawford in Sackville. In this ceremony I was assisted by D.D.G.M. Bateman of District No. 2. I also installed as Grand Chaplain, Bro. the Rev. Dr. F. E. Archibald. This took place at Coverdale Lodge on June 2, 1958.

At the same meeting D.D.G.M. E. E. Lewis installed Wor. Bro. John H. Lingley as Grand Standard Bearer.

The Grand Master very kindly took P.G.M. Pearson and myself along with him when he paid a fraternal visit to the Grand Lodge of Prince Edward Island meeting in Charlottetown. We were royally entertained.

Calls have been made during the year on our collection of historical items and fortunately we have been able to supply the answers.

A complete outline of the history of Howard Lodge No. 15, of Hillsboro, has been supplied.

Bateman, D.D.G.M. of District No. 2.

A book entitled "The History of Tweedie Lodge No. 41," by V:W: Harold A. Nichol, Chaplain of Tweedie Lodge, was dedicated by P.G.M. James S. Hoyt, an Honorary Past Master of Tweedie Lodge, representing the Grand Master, assisted by R:W: F. C. Thomas, D.G.M., with the Prayer

of Dedication being offered by the Grand Chaplain, V:W: Rev. Dr. F. E. Archibald.

Honor was paid to the older members of the Lodge present, ten of whom had their pictures taken, which will be placed in the book just dedicated.

After these ceremonies and lodge closing the Brethren repaired to the banquet hall where they were joined by the ladies to witness a programme of entertainment and enjoy refreshments.

On October 31 Landmark Lodge of Boiestown was dedicated and consecrated and was warranted as No. 51 on the G. R. of N. B.

Today we are able to record the recommendation that Coverdale Lodge receive its Charter.

The grim reaper has visited many homes and Lodges since our last report. To those who mourn we extend our heartfelt sympathy.

I do not doubt that during the year many things of importance have transpired news of which has not reached your historian and, in closing, I once more appeal to you to forward such items. We have installed a set of steel files and in them each Lodge in the Jurisdiction has its own compartment in which to place such items for future reference and for continuing the partially written histories as time goes on. Accounts of the current events of today, if preserved, supply the material for later histories.

I should indeed be remiss in my duty if I failed to mention the success of our new Grand Secretary who has been winning golden opinions from all parts of the Jurisdiction and by now has settled into his task with the ease and confidence of a veteran.

Thanks to all who have helped in this important work of rescuing from forgetfulness the stories of our Lodges and the relics of their equipment. Every good wish!

REPORT OF THE RITUAL COMMITTEE

*TO THE MOST WORSHIPFUL, THE GRAND MASTER,
OFFICERS AND MEMBERS OF GRAND LODGE:*

We beg to submit herewith our report as the Ritual Committee for the year just ending.

This has been rather an active one, inasmuch as the several District meetings which have been held, brought many things to the attention of the Ritual Committee for clarification and direction.

We are indeed grateful to P.G.M. Pearson for his continued and untiring help at all of the District meetings where he gives freely of his time toward aiding and assistance to the Brethren in clarifying and interpreting the many points that are brought to his attention.

The Ritual Committee met earlier this month and have prepared several papers for consideration, and have discussed many of the points which cause little troubles here and there, through our forms and ceremonies.

The question of balloting is one of vital importance to all members of the Craft. We recommend the two-compartment ballot box to be used as the standard method of balloting, at which time ballots are distributed by the Junior Deacon, the ballot box is presented by the Senior Deacon and the standard procedure after the ballot is taken is for the Senior Deacon to approach the Junior Warden, the Senior Warden and the Worshipful Master for their examination of the ballot, and when requested by the Master as to how they find the ballot, their reply is either "favourable" or "unfavourable" with the Master's wording: "So I find it in the East. I therefore declare, etc." Three or more black balls is unfavourable and therefore rejects the candidate.

Other subjects presented to the Ritual Committee for consideration allowed them to study and present for your

approval and adoption, the method of reception of a Grand Master; the examination of a visitor unable to be vouched for; the taking up of the Word; and the proper dress to be worn; all of which will be presented to you at this session of Grand Lodge.

The vital and important question of the revision of the Funeral Service, is still before the Committee, as it is before many Grand Lodges at the present moment. It will also be given consideration by the Conference of Grand Masters of Canada and we believe we should ask for a further extension of time before presenting a draft of our proposal on this subject, for your consideration.

We, the Committee, appreciate the opportunity of being able to serve this Grand Lodge and particularly to clarify and help District Deputies and Masters in order that standard wording, forms and ceremonies will prevail throughout our Jurisdiction.

REPORT AND RECOMMENDATION RE COVERDALE LODGE (U.D.)

Most Worshipful Sir:

Supplementing and continuing my earlier reports on Coverdale Lodge (U.D.) as contained in my letter to you under date of February 6th, 1958, and which is published in the Proceedings of Grand Lodge for 1958 — my verbal report given at the last session of the Grand Lodge and part of my official report of last year — I now beg to submit further report as follows:—

Interest has been well maintained in this Lodge and regular progress has been made. This worked out extremely well, the average attendance being shown in the tabulated portion of this report.

I also had the pleasure of being accompanied on this journey by our Grand Senior Warden, R:W: Bro. P. C. Austin of Bathurst. I was indeed pleased to have him along with me. He has been very faithful in helping me in any way he can and I appreciate his assistance very much. This gathering was very beneficial to me and I trust I will have the opportunity to attend a similar one again in the near future.

Our District meeting this year was held in Chatham on April 22nd, and was very well attended. Upwards of 150 from the District were present. We were well represented by Grand Lodge as Most Wor. Bro. Dr. Somerville, our

Grand Master, R:W: Bro. Dr. Thomas, D. G. M., R:W: Bro. A. C. Lemmon, Grand Secretary, R:W: Bro. James S. Hoyt, R:W: Bro. Ralph T. Pearson were with us. Again it is a pleasure to report to you the conditions and activities of this your home District for the year 1958-59.

As you well know, conditions have not been at their best in our District this past year, and they are reflected to some extent in our Lodges. Nevertheless, Masonry, I think, has held its own. Some of our Lodges have not had a candidate, but the interest among the Brethren has been keen and all our Lodges had a splendid staff of Officers and in most instances the attendance has been very good.

The big exception to the lack of candidates was your home Lodge, Carleton No. 35, where you had a large group of candidates. Benjamin No. 31 also had a good year for new members. Tobique No. 48 and Hartland No. 46 had no candidates. The others all had some work but the year was not too good for new members.

Several of the Lodges have made major improvements in their quarters, notably Benjamin, where the Brothers have rebuilt their quarters and now have a fine modern hall. Bethel Lodge is continually improving their quarters. Last year they installed new siding to the interior of the lodge room and a complete new lighting system. This year they have remodelled the entrance and are at present renovating the kitchen.

At the beginning of the year I had the pleasure of assisting in the installation of the Officers of Carleton, Bethel and Tobique Lodges. The grippe and ice conditions on the roads prevented me from attending some other installations that I would have liked to attend.

I have managed to visit all the Lodges in our District at least twice, with the exception of Hartland. Twice I planned to attend and was unable to go, once due to icy roads and the second time due to the 'flu. I shall try again in June, when they expect to raise three candidates (the first since I have been your Deputy).

On April 10th, District No. 4 played host to District No. 1 of the Grand Lodge of Maine at an International night dinner and social evening held at the high school auditorium in Andover. This was the first time we of this District ever held such a meeting; although we have been associated with our Brothers at such meetings before, they have always been held in Maine. District No. 1 William Summerville, V:W: D.D.G.M. Winston Brewer, W: Grand Director of Ceremonies Andrew H. McCain.

R:W: District Deputy Don Canders, of District No. 1 of Maine, assisted me in organizing his District. R:W: Past Deputy Grand Master Ronald Baird thanked the speaker on behalf of the Brethren. This meeting was in my opinion, a big success, and did much to further Masonry in this area.

I also had the pleasure of accompanying you to a District meeting of District No. 3 in Moncton where D. D. Bateman presides. This meeting was another very fine effort and was well attended. Much good comes out of meetings of this nature, and I hope they are continued. In fact, we are planning one to be held in Woodstock this fall.

I also had the honor and privilege of accompanying you to Houlton, Maine, to the celebration of Monument Lodge No. 96, centennial anniversary meeting and dinner on April 26th. This was a largely attended affair and there were several very fine speeches. Most Worshipful the Grand Master of Maine, John M. Littlefield, was the guest speaker.

On May 7th I accompanied you to Woodstock Lodge, where you presented three 50-year pins to Brothers of that Lodge and we also witnessed the raising of three candidates; Wor. Master King and his Officers did a very fine job and I was very proud of them.

I hope to close out the year with a third visit to Carleton Lodge on May 14th and then to Grand Lodge. After Grand Lodge we are planning to hold our annual Church parade at East Florenceville on Sunday, June 21st. Most Worshipful Aubrey Burbank, Past Grand Master of the Grand Lodge of Maine, is to be the speaker.

In closing I wish to thank all the Masters and other Officers for the support they have given me. No Deputy could ask for more and without which nothing could be accomplished.

Please let me express my thanks for the honor of being your Deputy in this your home District.
