

ANNUAL REPORT OF THE BOARD OF GENERAL PURPOSES

May 1997

TO: THE MOST WORSHIPFUL THE GRAND MASTER,
OFFICERS AND MEMBERS OF THE GRAND MASONIC
LODGE OF NEW BRUNSWICK

The first meeting of the Board was an Emergent Meeting held on July 1st, 1996 called to discuss suggested changes that should be made in the Grand Lodge Office.

The June meeting was called to order by the Grand Master, M:W:B: William Balsler, Jr. who presided during the election of the Chairman for the year, R:W:B: James H. Pike and the Vice Chairman, R:W:B: Robert M. Johnston.

A Committee was appointed to look into the Problem previous to the meeting and submitted the following report.

That a new computer and fax machine be obtained along with a new photocopier.

That a qualified Accounting Clerk be hired to replace the present Stenographer who is not trained in the Accounting Field. This was a suggestion of the Treasurer who noted the problem at a previous meeting.

As a result of this meeting the new equipment was obtained on a rental basis for five years and an Accounting Clerk was hired.

The problem of straightening out the records will be an ongoing one that will have to be done while other work is going on and could take a year or two.

The matter of Entered Apprentices being charged dues and not being allowed to vote was settled as follows:

The Masonic Fraternity has the power to make laws and regulate itself and as Apprentices do not have to remain apprentices they will eventually be given voting powers.

Check lists for Investigating Committees was referred to Jurisprudence who submitted a Check List which will be given to those who desire to have such a guide.

The appointment of a Grand Representative to Prince Hall Jurisdictions was referred to the Fraternal Relations.

The Masonic Float which is no longer being used was brought to the Boards attention and it was agreed that the Float would be sold if possible and the money given to Masonic Charities and Housing.

The Grand Master noted that he had discussed the matter of a one day conferral of degrees on a number of Candidates at the same time and asked for some input.

The Committee on Fraternal Relations reported to every meeting on progress being made toward the next meeting of Grand Lodge.

After some discussion on the matter of a one day conferral on the second and third degree, the first degree having been conferred in the Mother Lodge the project was indorsed in principal by the Board on motion regularly moved, seconded and carried.

A brief report on the Aldridge Atlantic Eastern Conference held in Moncton in late September was given by M:W:B: J. William Murray.

The matter of giving authorization to the establishment of an Internet Web Site for the Grand Lodge of N.B. under strict control. W:B: Ed Armstrong made a presentation to the Board and permission was granted.

R:W:B: Clark reported on the position of Fraternal Relations with the Prince Hall Masons noting that we have recognized two Jurisdictions.

The one day Conferral was again discussed and it was reported that monthly meetings were being held.

W:B: R. M. Hodgins was appointed the New Editor of Mostly Masonry and has produced his first Edition.

The Grand Master and Deputy Grand Master will attend the Canadian Conference of Grand Masters which will again be held in Winnipeg again this year.

An update on the arrangements for the one day conferral was given the members present by the Committee which has been meeting on a monthly basis. The site has been changed to the Riverview Recreation Centre due to the number of Candidates expected to attend.

At the March meeting, Notices of Motion for The Grand Lodge Meeting were dealt with.

Recommendations for awards were received and processed also recommendations for appointments were also received. Arrangements for a Speaker on the Drug Problem in Canada was arranged.

An Emergent meeting was called on Monday April 21, 1997 to consider the problem we were facing due to the illness and eventual passing of Mrs. Allan our Treasurers Wife.

As the Audit was in progress and could not be completed and no financial statement was available for mailing to the Members of Grand Lodge, The Grand Master was concerned and felt that the Members should be informed.

As a result of the meeting several motions were made and passed including:

- Signing Officers
- Maintaining Financial Records in the Grand Lodge Office
- Investments are to be made only on the recommendation of the Finance Committee
- A Financial Statement is to be presented to the Grand Master on week prior to the Board of General Purposes Meetings and a copy of the Annual Financial Statement and the Audit report are to be in the hands of the Grand Master 14 days prior to the Annual Communication.

On closing I would express my thanks to the Staff of the Grand Lodge Office for the cooperation I have received.

REPORT OF THE COMMITTEE ON FRATERNAL RELATIONS

TO: THE MOST WORSHIPFUL THE GRAND MASTER,
OFFICERS AND MEMBERS OF THE GRAND LODGE OF
NEW BRUNSWICK F. & A. M.

Your Committee is pleased to note that during the past year a number of appointments were made to fill the on going vacancies in the Grand Representative Ranks, not only with recommendations covering our own deserving brethren but in receiving and responding to the recommendations from Grand

Lodges of foreign lands. Your Committee reviewed requests for recognition from a small number of foreign Grand Lodges. These having been carefully examined and recommendations follow.

The Grand Lodge of Russia

In our report presented at the 129th Annual Communication in May 1996, you were informed of the request for recognition received from the Grand Lodge of Russia, regularly consecrated by the Grande Loge National Francais in Moscow on the 24th June 1995. Although that new Grand Lodge had advised the Commission for Recognition that the standards for recognition are followed, your Committee deferred a recommendation while awaiting further information. This has now been forthcoming through the Annual Report of the Commission for Recognition which encourages recognition by other members of the Conference of the Grand Masters of Masons in North America, when it is sought by the Grand Lodge of Russia. The above noted Annual Report states there are now five constituted Lodges under the new Grand Lodge, with recognition coming from four Grand Lodges in the United States, five in Canada, six in Europe and a number of Grand Lodges elsewhere in the world.

Accordingly it is this Committee's recommendation that the Grand Lodge of Russia be recognized by the Grand Lodge of New Brunswick and Representatives be exchanged.

The Grand Lodge of Malgache

The Commission for Recognition reported in 1996 that the Grande Loge National Francais had chartered three Lodges in Madagascar with the ultimate purpose of constituting a new Grand Lodge on this Island, formerly a French Colony but now independent.

The Grand Lodge of Malgache was consecrated by the Grande Loge National Francais on March 6, 1996 with three Lodges. This past January 10th, 1997 two new Lodges were set to work, The New Grand Lodge has provided the Commission with full information relating to its regularity, showing that it meets the Standards for Recognition. A letter has been received from the New Grand Lodge confirming the above events and extending their fraternal greetings.

Accordingly it is recommended that Recognition be Extended to the Grande Loge National Malgache and where an exchange of

Representative has not been requested this feature should be deferred to the future.

The Grand Lodge of Yugoslavia

The Grand Lodge of Yugoslavia has been recognized by this Grand Lodge and our nominated Grand Representative appointment recommended to them, however after a lengthy period we have not been apprised of the results of our recommendation. The member of their Grand Lodge named for our appointment was subsequently expelled from the Grand Lodge Yugoslavia due to internal disruption.

The name of the Grand Lodge has been changed to read "Regular Grand Lodge Yugoslavia" and the Commission for Recognition is of the opinion that the Grand Lodge operating as the Regular Grand Lodge is the only regular Grand Lodge in Yugoslavia.

Concurrence is now requested of the Grand Lodge to recognize this new identity and to re-submit the name of a selected nominee for Grand Representative and respectfully suggest that the Regular Grand Lodge of Yugoslavia be requested to re-submit the name of their nominee.

The Grand Lodge of Panama

The Grand Lodge of Panama is desirous of establishing fraternal relations with the Grand Lodge of New Brunswick.

It is recognized in Canada by all Grand Lodges except for British Columbia. This Grand Lodge is Regular and meets the Standards for Recognition. Therefore it is recommended that the Grand Lodge of New Brunswick extend fraternal recognition and exchange Grand Representatives.

February 13, 1997

The first item on the agenda was the matter of Entered Apprentices not being permitted to vote and be appointed to Committees. This was referred to the Committee by the Board of General Purposes.

Findings:

The Masonic Fraternity has the legal right to make Laws and Regulations to Govern itself.

Entered Apprentices are not confined to the Degree of Entered Apprentices Forever but may continue on through the First, Second and Third Degrees when they will receive voting rights and privileges.

The present ruling makes things easier for Lodge Secretaries as it spells out an Entered Apprentices situation.

He is a member of the Lodge

He must pay yearly dues

If he does not pay, he will be dismissed for N.P.D.

Regarding the motion at the 129th Communication

R:W:B: Douglas Wood may present the motion again at the 130th Communication if he so wishes.

Another request for a ruling on the use of the Square and Compasses in money making ventures by Lodges in the Jurisdiction was referred to the Committee.

We approve the request of Colebrook Lodge #39 in Principal with the following changes.

That the Squares and Compasses be placed with the Title Bar only, on the same level and not in the area of Business Ads.

We also recommend that Section 53, Page 61 be changed to read:

No Member shall, on any pretence, exhibit or expose any representation or similitude of any jewel or furniture of the Lodge, or of any Masonic Emblem or Device in any way that may be interpreted as for personal or commercial gain.

We recommend that the Committee on the Revision of the Constitution consider the matter of adding a section to the Constitution that would contain a list of Masonic Offences and the method of conducting Masonic Trials.

The Jurisprudence Committee also recommends that the Education Committee check the Officers Manual and bring Seniority Listing in line with the information contained in the Book of Constitutions.

On motion moved by R:W:B: James Pike, seconded by R:W:B: Merrill Henderson the report was adopted and published in the Proceedings. Motion carried.

REPORT OF THE GRAND MASTER

TO: THE MOST WORSHIPFUL GRAND LODGE OF FREE AND

This year we celebrate the 130th Anniversary of our Grand Lodge and for our Grand Lodge this is where it all began, here in Saint John. District Deputy Grand Masters

The DDGMs have been my right arm these past two years. I am not the easiest Grand Master to work with, once the program has been established I fully expected it to be carried out. They have superintended the craft under their care and they have worked very hard for all the Brethren in their respective Districts.

Through their efforts our Grand Lodge visits were well attended and the Brethren kept informed of everything which was taking place at the Grand Lodge level.

I am very proud of the District Deputies and in recognition of their loyalty and support I have presented each one with a Grand Representatives Commission.

Grand Officers

Very early in my term we implemented the team concept with your Grand Lodge Officers. I may have been elected as the lead horse on the team but to make our programs work we have all pulled together. Each elected officer was elected because of the confidence the brethren had in their abilities. The appointed officers were appointed for the same reason. The brethren had confidence in their abilities. We have operated at a fast pace and several new programs have been presented. The Grand Lodge Officers have met every challenge. They have been very loyal and have travelled throughout our Jurisdiction at every opportunity supporting Grand Lodge Visits and representing Grand Lodge officially at our concordant bodies. The Grand Lodge Officers are the ones who made it happen, one person does not constitute a team, but together we are a team. Any accomplishments made during my term of office are a direct result of dedication and hard work by all the members of the team.

Conferences

The Aldridge Atlantic Conference was held in Moncton on Sept. 27/96 with delegates from the Maritime Provinces and Quebec attending. All of our Grand Lodge Officers together with several PGMs attended as observers. Several papers were presented by representatives from each Jurisdiction. The papers

related to topics which were of concern to all Jurisdictions and sparked some very interesting debate.

In March 1997 R:W:B: Pike, DGM and I attended the All Canada Conference in Winnipeg. Many interesting papers were presented and ideas discussed. One of the hottest topics discussed was the Situation with the Shrine Temple in Quebec accepting applications from Master Masons. It was suggested that a letter be sent from each Grand Master to the Imperial Potentate voicing our displeasure with idea and suggesting that anyone entering the shrine without following the established route through the concordant bodies could be disciplined and/or proscribed from membership. As Grand Master of New Brunswick I strongly disagreed with this idea and will not endorse such a letter to the Imperial Potentate.

Brethren, each year members of the Board of General Purposes ask the question. Are these conferences worth the time and expense? In my opinion they are very worthy. I feel that it is very important that New Brunswick be kept up to date and have a voice in all Masonic matters which may have an effect on the Masons of New Brunswick.

Lewis Mason Program:

In the fall of 1996 the Lewis Mason program was presented to and endorsed by the Board of General Purposes. The purpose of this program is the same as all of our programs. To stimulate activity and make us proud to be Masons. The Lewis Jewel is worn by the son of a Mason. The top bar of the jewel contains the initiation date of the Father and the bottom bar contains the initiation date of the Son. In some Jurisdictions special privileges were afforded to Lewis Masons. In this Jurisdiction there are no special privileges afforded to Lewis Masons. The bond between a Father and a Son is strong and when this bond is strengthened by the bonds of freemasonry. It is very special. We feel that it is a terrific way for the Son of a Mason to honour his Father.

The Masonic Family in New Brunswick

We are unique in New Brunswick in that we have a strong Masonic Family. Many times as I travelled I am told that we have something special in New Brunswick, we are all working together, we support each other. That is very true, we are too small a Jurisdiction to compete with each other. Much more is

accomplished when we work together. In 1995 we met with the Heads of all concordant bodies and established a procedure in that we would prepare a calendar of events for all bodies and not hold Provincial events on conflicting dates. This program has been very successful. In 1997 we published The New Brunswick Family Booklet. Each member of the family participated in the booklet by writing and/or approving the script of their respective bodies and by contributing to the publishing costs. We feel that this booklet will be of assistance to non-masons and Master Masons by providing information to everyone about our Fraternity.

New Lodge Warranted

It was with a great deal of excitement that Grand Lodge travelled to Campobello Island in December 1995 and issued a warrant to Sunset Lodge #56 to operate as a Lodge under dispensation from this Grand Lodge. The Officers of Sunset Lodge #56 were also installed during the same visit. In April 1997 we returned to Sunset Lodge #56 and issued their warrant as a regular Lodge under the Jurisdiction of The Grand Lodge of New Brunswick. The Lodge was also consecrated by the traditional ceremony previous to the presentation of the warrant. The members of Sunset Lodge are very excited about having their own Lodge. They are active in their Lodge and have seen their membership increase in the past year. Sometimes we hear of Lodges closing or amalgamating to survive, but here in New Brunswick Lodges are not closing we are growing. I wish to thank the brethren of Sunset Lodge for giving me the opportunity to participate in a special event in the history of our Fraternity.

Grand Lodge Home Page

Our Grand Lodge now has its own home page on the world wide web. This page was created by W:B: Ed Armstrong, PM Zion Lodge #21. W:B: Armstrong was also appointed as WebMaster of our homepage and we commend him for his hard work and dedication to our Fraternity. Shortly after going online through a link from our homepage to the GL of NS we had an inquiry from a Mason in Yellowknife, NWT seeking information for his brother in New Brunswick, who was inquiring about membership in the Fraternity. As a result of a few E-Mail messages and personal visits we now have a new member in St. Mark's Lodge #5. It is anticipated that in the very near future our Grand Lodge Office will be equipped to handle E-Mail.

Youth Programs

The members of the Order of Rainbow and the Order of DeMolay are the future leaders of our nation. We are very fortunate to have both Orders established in our Jurisdiction. Both of the organizations teach our youth the values of good citizenship and the foundations of leadership. It is with a great deal of pride that I welcome them as members of our Masonic family. However, I am very concerned about the lack of support by the members of our Fraternity to our youth. I do not mean financial support. The Masons of New Brunswick have been very generous with financial support to our youth. I mean hands on support. Attendance at meetings and participation on the Advisory Boards. The task of working with our youth has fallen on the shoulders of a few dedicated Masons and Star members. They are working their hearts out because they believe in our youth, but they need some help. We have the potential to expand Rainbow and DeMolay throughout the province. However, I am very concerned that if we do not take "a hands on approach" and volunteer to get involved that we are going to lose a very vital member of our Masonic Family. I am very proud to be a Senior DeMolay. Several Senior DeMolay's from my generation are active in our Fraternity with many serving as Masters and Grand Lodge Officers. A Senior DeMolay was a candidate in our recent Grand Master's Class. I believe that any success that I have had in my Masonic career is directly related to my membership in DeMolay. Believe in our youth and become active in their programs. Remember you will be working with the leaders of tomorrow.

Masonic Renewal

The Masonic Renewal Program is firmly established in our province. Our goal was to REKINDLE Masonry in New Brunswick and I firmly believe that we have accomplished that goal. Masons are proud to be Masons and we see this pride in many lodges as we travel the Jurisdiction. **The Friend to Friend Program** has been the catalyst which has started the ball rolling. Many lodges have had very successful Friend to Friend nights which have resulted in a number of good men joining our Fraternity.

To complement the Friend to Friend Program we have recently introduced the **Brother to Brother Program**. This program is designed to retain the interest of our members who are active and to regain the interest of our members who are not

attending. With these two programs being utilized by each Lodge I see a very bright future for our fraternity.

The Grand Master's Class of conferring the Fellow craft and Master Masons' degrees was a further step of our Renewal program. The **objective** was to stimulate Masonic activity in our province. Even before the event was held, this objective was accomplished. From the beginning of the early planning stages Masons concerned about our Fraternitiy met with the determination that we would make Masonry come alive in New Brunswick. Brethren Masonry is alive in New Brunswick. On April 26 almost 400 Masons watched as **forty-one** Masons became members of the first Grand Master's Class in New Brunswick and the first class in Canada. We will be sending a number to each Lodge but if anyone wishes to purchase one today we will be most happy to provide the same.

Camp Goodtime 1996 held June 30th to July 6th proved a great success and I am pleased to say was well attended by members of the fraternity and their wives on Sponsor Day. Forty-four children attended last year's Camp and each were provided with a Camp Goodtime cap and T-shirt. Treats were provided on Sponsor Day and Camp was off to a good start. The children look forward to this care free holiday and many express the hope of being able to return to the next year's camp.

This year's Camp is scheduled to be held June 29th to July 5th but at this time we do not have a firm number of children who will be attending. The cost of this year's Camp will be \$18,500.

Your contributions have further brightened the loves of another group of handicapped young people. I refer to those we sponsor to the Deafblind and Rubella Camp held September 5th, 6th and 7th at Richibucto. Each year for the past three years we have been able

to sponsor four children and their intervenors, however this year the Deafblind and Rubella Association was faced with an unseen situation. Three additional children moved into the area. No budget provision was available and we have been asked if we might be able to assist. It is with great pleasure that I am able to inform the Deafblind Association that we would cover the cost of seven children this year at a total cost of \$4,550.

The efforts of the Masonic Fraternity is not going unnoticed. The general public has become more aware of what we are accomplishing. Our Lodge activities have done much to spread our message and increase our image. To better illustrate the point, I would like to quote from a letter I recently received from Madeleine Cormier, retired Director of Patient Services, Canadian Cancer Society NB Division. "I am indeed very happy to hear that once again, you have been able to realize the necessary funds for Camp. Last week, the mother of one of the Campers who attended the Camp years ago wrote to thank me once again. She wrote that I would never know what it did for her son. When he was diagnosed he was young, shy and insecure. Camp provided him with security, fun and an opportunity for the parents to let go of their possessiveness. Today he is a fine young man going to College who still keeps in touch with the ones that he shared his Camp experience with. Tom, as you can see, your group has really provided something very special for so many of these sick kids. Congratulations and thank you. I will always be forever grateful for the generosity of the N.B. Masonic Charities & Housing." I think the foregoing says it all.

The Masonic Charities brochure we published last year has been widely circulated with encouraging results. Several Lodges have distributed them at their fund raising projects. Any Lodge wishing a supply of these brochures may obtain the same by contacting the Secretary or Treasurer.

Quinn House in St. Andrews, providing comfortable accommodation for seniors, continues to function in a most efficient manner under the capable chairmanship of R:W:B: Frank Langley of St. Mark's Lodge #5 in St. Andrews.

On behalf of the Board I would like to thank all Masons in the Jurisdiction for their splendid support without which our projects would not be the success that they are. I would also like to sincerely thank the members of the Board of Directors for the wonderful support they have given me during my term as President.

REPORT OF THE FINANCE COMMITTEE

TO: THE MOST WORSHIPFUL THE GRAND MASTER,
OFFICERS AND MEMBERS OF THE GRAND LODGE OF

I wish to submit this my final report as Chairman of the Grand Lodge Finance Committee. I have been a member of this committee for the past thirteen years, eleven of them as Chairman. I believe in that time I have done my duty to the craft and that it is time for a new face as well as new ideas and perhaps new direction for this committee.

During this period, that I have been a member of this committee, our Grand Lodge investments have more than doubled and we now have investments in excess of \$850,000. Most of these investments are now managed by the investment firm of Wood-Gundy. This has allowed us a greater maximization of return on our investments and greater flexibility in our investment account then when it was self administered.

During the time I have been a member of this committee we have seen the annual expenditures of Grand Lodge raise from approximately \$48,000. to a projected expenditure for 1997 of approximately \$125,000.

Previously most of our income was derived from the per capita levied against each lodge. This has remained stable at \$10.00 per member since 1980. More than half of our income is now derived from our investments and if investments continue to grow, no increase in per capita is forecast for the near future.

During 1996 several of our higher yielding investments were recalled and had to be reinvested at lower interest rates. During 1997 several more of our investments are maturing and will have to be reinvested at a lower interest rate. This will result in lower investment income over the next few years.

We believe that proper management of our investments as well as slow growth in investments and strict control of expenditures that the financial outlook for this Grand Lodge should remain sound for the next several yeats.

We have recommended to the Board of General Purposes that the unconditional grant to Lodges be reduced from \$550.00 to \$400.00 per Lodge for 1997.

We also recommend that Bursaries totalling \$10,000.00 again be given in 1997 and that amount be taken from the Fund of Benevolence.

REPORT OF THE GRAND HISTORIAN

TO: THE MOST WORSHIPFUL THE GRAND MASTER,

Most Worshipful the Grand Master, distinguished east and brethren all. It is my pleasure to present my report on the activities of this Grand Lodge for the last year. This past year has been one of the busiest for Grand Lodge in recent years.

At the last communication of Grand Lodge it was voted to have the ritual of the Grand Lodge of New Brunswick printed in full except for a few pass words. The ritual committee who had the task of preparing a full text manuscript from the jewel did an excellent and timely job. The new rituals have been in use since the fall. This decision of the Grand Lodge took several years to come to fruition, but the end product has been well received.

The Lodges of the Jurisdiction were very busy this year having many special nights for such things as rededication's, 50 years pins and anniversaries to which the Grand Master and many of the Officers attended. Two of these events are particualrly noteworthy. In June of 1996 a special event was held by St. Marks #5 of St. Andrews where they reenacted the reception of numerous brethren arriving by boat. In this case the sailing was from St. Stephen to St. Andrews where the brethren were received by the Grand Master and many other masons. They formed up and Marched through the town to Church for divine worship

conducted by the Grand Chaplain R:W: Eric Caldwell. The Grand Master and the Officers presented the warrant to Sunset Lodge No. 56 on Campobello Island.

The participation of the Masons of New Brunswick in Camp Goodtime has continued over the past year. We have been able to cover the complete cost of this camp for young cancer patients. The raising of the funds has brought many of the Lodges closer together as they put on events to raise the money. The Masonic Charities has also continued to sponsor children to the Canadian Deaf, Blind and Rubella Camp.

During the year our Grand Lodge Office structure was changed with the hiring of an Executive Assistant to help the Grand Secretary run the office. The position of secretary was discontinued. The computer and communication equipment was also updated.

The Grand Lodge of New Brunswick entered the electronic highway with the setting up of a web page on the internet. There are many Masonic Pages on the internet and our page is connected to these. The site is still growing and all are invited to visit and register at the site. Suggestions on the pages are invited.

One of the initiatives of The Grand Master this year has been the promotion of the Lewis Mason in New Brunswick. This is a program where the sons of a Mason who are members of the craft can wear a special medal, The Lewis Medal, that shows their dedication to their father. The first of these in the Province was received by the Deputy Grand Master R:W:B: James Pike. The most recent presentation of this medal took place this week at Howard Lodge. The Grand Master and Officers of Grand Lodge were there to rededicate the Lodge in their new Lodge room. During the ceremony W:B: Bill Balsler, Sr. presented the Lewis Medal to his two sons, Most Worshipful Grand Master William Blaser, Jr. and B: George Balsler all members of Howard Lodge.

A major program of the Grand Master has been Masonic Renewal and to reach this objective several things have been done to improve membership both new members and current members. The Lewis Medal was one of these and the expanded use of the Friend to Friend was another. Also this year a booklet "The Masonic Family in New Brunswick" was produced. This booklet gives a brief explanation of the Blue Lodge and each of the concordant bodies in the Province.

The largest undertaking of the year had to be the Grand Masters Class held in Riverview on April 26, 1997. This class was a one day conferral of the Fellowcraft and Master Mason degrees. The degrees were given in full to each of the candidates in mass. The second degree team was lead by R:W:B: Maurice Linkletter with the assistance of Moncton area Masons. R:W:B: Linkletter took the chair and the Senior Deacon was done by W:B: Don Williams. The third degree team was lead by R:W:B: Fred Healey with R:W:B: Ossie Nason in the chair. At this all day meeting 38 received their Fellow Craft and 42 received their third degree. The attendance of Masons both helping and observing was 274. At a banquet in the evening 276 were in attendance. The new Masons received their aprons and their charters. For those who attended this historic occasion they were treated to excellent degree work in front of a large crowd. This was a first for Canada although many have been done in the USA.

In closing I must say that the pace of this past year in terms of new ideas and the number of initiatives points well to growth of Masonry in this Jurisdiction.
