





**REPORT OF THE RITUAL COMMITTEE**

TO: THE MOST WORSHIPFUL THE GRAND MASTER,

On behalf of the Ritual Committee, I have the pleasure of submitting the following report for the past year.

The Grand Lodge Ritual Committee was expanded last year to include members from other districts outside the Saint John area. The expanded membership, with representation from other areas of the jurisdiction, has served the committee well. It has allowed the committee to cover a larger area of the province. The committee has this past year, in association with the DDGM's, attended district workshops in Districts #1 and #6 and also a followup meeting in District #2 at the request of the District Deputy. It is our sincere regret that we did not get to conduct district meetings in either of Districts #3 or #4. Attempts were made, but things did not work out as expected. The workshops, both this year and last, were well attended by members of the different districts. If this committee could make a recommendation it would be that the Grand Lodge Ritual Committee should continue to conduct district workshops.

The committee also held a special meeting where the committee reviewed the "original" ritual as provided by the Grand Secretary. Several items, which had been presented to the committee, were reviewed and most were found to be already included in the latest edition of the ritual book.

The committee presented its final report to the Board of General Purposes at the November 6th, 2004, meeting with recommendations on the lighting/extinguishing of the candles at opening and closing, the recognition of speakers at the close of the meeting, and on the practice of "closing on the level". Unfortunately, due to schedules, weather conditions and several other items, the committee worked on but did not complete some other items including a Lodge of Sorrow Ritual and an addition to the Funeral Ceremonies booklet. The committee also saw the need for a compendium of all of the different pieces of ritual that is being used throughout the jurisdiction. The Ritual Committee would take on the task of collecting all of the versions of all these individual lectures/rituals, review them for consistency and publish in booklet form after approval by the Board. This work is still in progress.

The committee members wish to thank The Grand Master for their appointment to this committee and we hope that our deliberations have been satisfactory.

It is a great pleasure for me to submit my annual report as District Deputy Grand Master for District #1.

This has been another busy year for Freemasonry in our district. With the surrender of the charter from Union Lodge of Portland, there are now eight lodges in our area of the province. Our total membership has declined over the year. However, two lodges did show an increase in membership, and with the amount of degree work taking place in most of our lodges at present, there is hope that total membership will start to increase once more.

Another successful year of fund raising for Camp Goodtime was seen in our district with many activities undertaken by the various lodges. Most financially successful of those ventures was the "Ron Hodgkin Memorial" District #1 Golf Tournament, which showed a profit of \$3,670. Following the battle for the "holy grail" of District #1, the Corinthian Lodge #13 will face all challengers to defend its title in September 2005.

Our Grand Master completed his tour of the District #1 Lodges with four official visits in the year, with the District Meeting taking place on April 7th, 2005, at Carleton Union Lodge #8. Our District Council is alive and will have had meetings twice in the year. Requests from some of the current Worshipful Masters and Wardens have been received with the next unofficial date for meeting being in June.

Certainly the low point in our year occurred on December 21, 2004, when the Union Lodge of Portland #10 went dark after a long and distinguished history. To date, 17 members of the lodge have joined a sister lodge in the district and every effort is being made to accept any who wish to continue their Masonic careers.

Some other highlights: Four Fellowship Nights (which explains the amount of degree work at present); the Officers Training Program session in March which helped all present from new Master Masons right through to Past Masters; three official visits made (by Albion #1

and Carleton Union #8) to Lodges outside of the district; and a spirited quest for the traveling gavel resulting in much visiting and the traveling banner awarded to the New Brunswick Lodge #22.

In closing, I would like to report that this has been a very educational two years for me. I thank all the brethren who supported me and I look forward to utilizing my new knowledge and experience for the betterment of Freemasonry.

And, best wishes to our new District Deputy Grand Master.

It is with pleasure and some regret that I submit my final report as District Deputy Grand Master for District #2. It has been a very rewarding and memorable two years and I now express my sincere appreciation to you for the opportunity to serve in this capacity.

During the past year, I completed my official visits to the lodges within District #2 as well as attending many of the regular communications within the greater Moncton area (Districts #2 and #7). I had the pleasure of presenting many long service pins, certificates and Masonic Bibles to the brethren. I would also like to express my thanks to the many brethren who accompanied me on my visitations and supported me during my term of office. I attended all installations in Districts #2 and #7 and had the distinct pleasure of participating in many of them.

In conjunction with R:W:B: George Bowness, DDGM for District #7, and in collaboration with the lodges in two districts, we have continued the combined District Council Meetings for the two districts. This evolution continued largely through the close cooperation and rapport among the lodges. We had a very productive and successful meeting with the Ritual Committee from Grand Lodge in attendance to demonstrate the ritual of opening and closing lodge, general discussion and an information session. The success of this meeting

can be attributed to the excellent turnout and participation provided by the brethren. At the last District Council Meeting in April we had a good representation from the lodges in the two districts. Two key items from this meeting were the desire to continue and possibly expand the close relationship which exists within the two districts. And in an effort to promote attendance/visitation and involve more of the brethren in the district, the council decided to move a portion of the education/training typically performed and discussed at a council meeting to a lodge meeting night. These sessions would alternate between district and lodges on a rotation basis with the agenda determined and prioritized by the Masters of the lodges and with input from the District Deputy Grand Masters.

A few of the lodges have been suffering from minimal attendance and reduced visitation but there appears to be some improvement over the past few months. The Masters are also initiating new and original programs which are generating interest and corresponding visitation. Although it may not be an immediate concern, there should be consideration given by some lodges in the district to their future direction based on their viability considering their membership level, active members, and new members additions.

Three of the lodges in District #2 had Masonic Church Services which I attended along with a good representation from the brethren. Zetland Lodge had a joint service with members attending from the Order of the Eastern Star.

The lodges in the district have continued their support of the N.B. Masonic Charities and Housing Corporation through their many fund-raising activities as well as other community related support activities within their community, C.O.D. Supper, Book Sale, Yard Sale, Support of the Salvation Army Kettle Campaign, etc. Three of the lodges in Moncton had a very successful fund raiser for Camp Goodtime with a dinner and dance featuring 50's and 60's music.

In closing, I would like to express my sincere thanks to the many brethren who supported me during the past year. Your friendship, assistance and hospitality was greatly appreciated. I congratulate and pledge my support and assistance to the incoming District Deputy.

The Most Worshipful The Grand Master made his official district visit to St. Mark's #5 in March with reports from all lodges. There was a good attendance at this meeting. ### REPORT OF THE FINANCE COMMITTEE

TO: THE MOST WORSHIPFUL THE GRAND MASTER,  
OFFICERS AND MEMBERS OF THE  
GRAND LODGE OF NEW BRUNSWICK, F. & A.M.

Thank you for permitting this committee to report on the financial affairs of Grand Lodge for the year 2004.

You will see from the Treasurer's Report, that we budgeted for a loss in our general account of \$5,820. but realized a small gain for the year of \$1,726. Our Benevolent account had a gain of \$2,016. These results were made possible by a small revenue increase of \$2,000. and a reduction in expenses in several areas.

Our general account budget for 2005 projects revenue of \$106,700. and expenses of \$106,977. with a minimal deficit of \$527.

The investment climate is still difficult, with guaranteed interest rates in the 4% range. Our loans to the Masonic Temple and private lodges are at 6.5%. This is a good rate to them and a reasonable return on our investments.

Last year we reduced our grants to private Lodges to \$200. and have budgeted to leave them at this level for 2005. Our financial status in future years may determine if the \$8,800 expenditure is sustainable.

Per capita income will increase over the next four years but we will undoubtedly face reduced income from investments.

We recommend again this year that \$10,000 be paid from the Fund of Benevolence for Grand Lodge bursaries.

These last two years as your Grand Master has been a once in a lifetime experience for me and has allowed me numerous opportunities to meet you at special functions and in your home Lodges. I thank you for the warm and gracious reception that you gave me at all times.

### Our Distinguished Guests

I am very pleased to welcome our special guests from sister jurisdictions of Canada and the United States. I have been warmly received in each of your jurisdictions and treated with great hospitality and extended the highest of courtesies. For this I thank you and hope that this weekend can return these in kind.

I also thank the representatives of the Concordant Bodies for bringing greetings to this Grand Lodge on behalf of your respective bodies and ask you to return our greetings back to your membership. I was able to attend many of your functions, but unfortunately because of time restraints I could not attend all. I was pleased to have other Officers take my place.

### Necrology

Brethren, again this year we have been saddened by the loss of some of our brothers, called to the Celestial Lodge above. We fondly remember our times spent with these brethren and the contribution they made to Masonry. To their families, on behalf of all the Masons of New Brunswick, I extend our greatest sympathies and thank you for sharing your loved ones with us.

The Grand Secretary will now read the names of our departed Brothers.

We will observe a moment of silence followed by a prayer from the Grand Chaplain.

Their memory we cherish in our hearts.

### Visitations

I am pleased to report that during my two years in office I was able to make an official visit to each Lodge in the Jurisdiction. This year I again had an Official Visit to each District in the Jurisdiction and received detailed reports from the Masters of each Lodge. This year two Lodges, St. George #12 and Howard #15, had Grand Lodge perform rededication ceremonies celebrating their one hundred and fifty years. Colebrook #39 had a rededication for their 100 year anniversary. On all of my visits I was very pleased to have Officers and members of this Grand Lodge accompany me and to show their support to the Grand Lodge. Thank you each and all.

This year I attended the annual communication of four sister jurisdictions and in my two year term I attended in total twelve annual communications. This was a total of ten different Grand Jurisdictions. Again I say thank you to all of these Jurisdictions for the good reception I received.

### Committees

The committees of this Grand Lodge are to be thanked for the many hours of work they put in on behalf of this Grand Lodge. Most members and the chairmen served for two years and when they give their individual reports the volume of work they did will be evident. Thank you all for a job well done. Several significant reorganizations of our operating procedures are under way and have required hours of work by several committees, these are expected to be on the agenda next year.

To the members of The Board of General Purposes I give special thanks, your attendance has been very faithful this year. To those who will retire from the Board your efforts on behalf of the Masons of New Brunswick is commendable.

### District Deputy Grand Masters

Six of you have had the same two years in office as me and will retire with me this afternoon. Your position is very important to the Grand Master as you are his representative in the Districts and it is your role to keep the Grand Master informed as to what is taking place in each District. This role has been fulfilled to my satisfaction by all of you, thank you.

### All Canada Conference

In early April, the Deputy Grand Master and I attended the All Canada Conference of Grand Lodges of Canada in Winnipeg. I was asked to present a paper on our Lodge Training program. In this I presented a short history on its development and the progress we have made in presenting it to the lodges. I also pointed out a few things that we have had to change as the program evolved. The national Board of Directors of DeMolay Canada met in the same hotel and presented a report on DeMolay to the conference on Saturday. The importance of our youth was discussed in another paper earlier in the conference and points out that across Canada the youth are in the minds of the Masons.

### State of Lodges

Lodges in the jurisdiction continue to address the trend of the last few years of declining membership. All Lodges have a larger proportion of older members to younger members and as many reach the age where they reduce their input to lodge operation make fewer trips so lodge attendance drops. The number of new Masons seems to be on the rise in many Lodges and this trend will soon see many more young Masons holding the offices and taking responsibility for the operation of their Lodge. This leads to a good mix of senior advisors and eager young Masons. Lodges that are going to be vibrant must make this conversion and empower these younger Masons. Not to do so means the loss of many of these young men and the Lodge putting itself in danger.

This year, two Lodges amalgamated and one Lodge surrendered its Charter and went into darkness. Fownes Lodge #45 and Salisbury Lodge #20 petitioned the Board of General Purposes to allow them to amalgamate under the name of Harmony Lodge #20. This petition was granted at the November Board meeting. On November 15th, the Deputy Grand Master received the Charter of Salisbury #20 on my behalf and put the lodge into darkness. On December 2nd, I received the Charter of Fownes Lodge #45 and this Lodge went into darkness. The receiving of the Charter of a Lodge is a sad and emotional experience, not only for the membership, but for all in attendance. On December 21st the new Lodge, Harmony #20, was opened under dispensation by the Grand Master. The new officers were installed by a suite of Grand Lodge Officers and past Grand Lodge Officers. This Lodge waits for its Charter to be delivered and the Lodge to be dedicated according to antient custom.

It was also my sad duty to attend on Union Lodge of Portland #10 on December 21st and receive their Charter. They found themselves in the position of not having enough active members to continue the work of this Lodge.

### Jurisprudence

This year the Grand Lodge was requested by St. George Lodge #12 to adjudicate a charge of un-masonic conduct made by one of its members against another member of the Lodge. Pursuant to the section on Masonic trials in the constitution the two Brothers were called to a board of trial conducted by the Grand Ldge in the Lodge room of the temple in Saint John on July 27, 2004. The trial was presided over by The Grand Master with the Grand Wardens, Grand Secretary, chairman of the Jurisprudence Committee and several Past Grand Masters present. Each brother was able to present their side of the case and each were questioned by the Grand Master for clarification. Documents were also presented and reviewed by the members of the board. After deliberation the members of the trial found unanimously that there was in fact un-masonic conduct. As a result, I put Brother Harvey Hooper on indefinite suspension from all Masonic connections. This Grand Lodge will be asked to ratify this action.

### Acknowledgements

My Brothers it is not easy to express the gratitude that I have to you for firstly trusting the position of Grand Master to me and secondly for the support that I have received. The fellowship that I received from all of you was overwhelming and greatly appreciated.

To the Officers, committee members and the members of the Board of General Purposes who have put in the time to help this Grand Lodge function properly and to grow properly I say, job well done, thank you. An especial thank you to the Most Worshipful Grand Secretary. Your assistance and that of your office has made my job so much easier.

To my wife Lanah, it is hard to express the thanks that I have for the sacrifice that you have made so that I could travel these last few years as I progressed to this office. Many late nights and many weekends alone is the price that our spouses pay so that we can do these offices. To all, thank you.

I take great pleasure in presenting the Annual Report of the N.B. Masonic Charities & Housing Company Ltd. for the year 2004-2005.

At Grand Lodge in May 2004, Betty Hoyt, Director of Community Programs, N.B. Division of the Canadian Cancer Society, was present and accepted a cheque in the amount of \$36,088.00 to fund Camp Goodtime and the Junior Leadership Program for 2004.

**Fund Raising:** Masons of New Brunswick have shown their dedication and passion by donating in excess of \$35,000.00 to fund our projects. The fund raising activities by the Blue Lodges and Con-Coordinated bodies are providing great public relations at the local level and involve a lot of communities in New Brunswick. Total funds raised for the year 2004-2005 are in excess of \$47,000.00 from our Blue Lodges, Con-Coordinated bodies of Masonry, individuals and corporate donations. The name "Camp Goodtime" is well known in the Province of New Brunswick.

**N.B. Masons Camp Goodtime:** Approximately 32 campers, ages 7 to 12 (original Camp Goodtime) and 16 campers, ages 13 to 14 in the Junior Leadership Program (JLP) attended a seven-day summer camp for children with a history of cancer. The JLP was a great success in 2004 and will continue in 2005.

In 2005, Camp Goodtime will be extended to an eight-day camp from July 10th to 17th, with Mason's Day/Closing Celebrations on Sunday, July 17th at 10:30 a.m.

## REPORT OF THE BOARD OF GENERAL PURPOSES

TO: THE MOST WORSHIPFUL THE GRAND MASTER,  
OFFICERS AND MEMBERS OF THE

The Board of General Purposes met four times since Grand Lodge 2004 in Saint John at the Masonic Temple. The first meeting was held on June 19th, 2004. R:W:B: Wayne H. McKay, Deputy Grand Master, was appointed chairman for a second time. R:W:B: Art Young, Senior Grand Warden, was appointed vice-chairman. M:W:G:M: Gordon R. Rattray gave his welcome and introduced R:W:B: Ed Gilks, DDGM District #3. A moment of silence was held in memory of R:W:B: Millard Ganong. The policy statement was accepted as printed and put into practice at this time.

The Ritual Committee submitted a report on Lodges holding memorial services at funeral homes. The Brethren, upon entering the room to hold a service, if at all possible, should be on one side of the room facing the family. It was also stated that it is not necessary to open Lodge before this service.

R:W:B: William Ryan reported on Grand Lodge Communication. He stated that everything was well attended, with everyone especially our guests visiting from other jurisdictions enjoying themselves. The M:W:G:M: thanked the chairman and all who took part in the arrangements for Grand Lodge.

Constitutional Review Chairman, R:W:B: Randall W. Nelson, will continue work on dividing the Constitution into two parts, one part will contain the Constitution and the other part will contain the Regulations.

Masonic Housing and Charities, W:B: Brian Francis, spoke on the new setup of Camp Goodtime, where the cost has increased as a result of combining the two age groups and the effect of McCains withdrawing their financial support. W:B: Francis was thanked for his dedication to Masonic Housing and Charities over the year.

Education Committee Chairman, R:W:B: Boyce Ward, spoke on Fellowship evenings and requested that the Grand Secretary send a letter to the Lodges and ask them that the number of candidates entering Lodges as a result of Fellowship Night be recorded and reported to him.

R:W:B: William Boone is reviewing the minutes of the B.G.P. back to 1984 and will report to the Board in the fall.

A moment of silence was held for R:W:B: Perley Ward, PDDGM District #6, and R:W:B: Ralph Saage, PDDGM District #6, at our November 6, 2004, meeting. M:W:G:M: Gordon R. Rattray brought

his opening remarks and gave a special welcome to W:B: William Whalen, the new Chairman of Masonic Housing and Charities.

R:W:B: William Boone presented his report on the review of minutes of the B.G.P. It was moved and carried that a committee be appointed and review so that members of the Board may refer to them when necessary.

Letters were received from Salisbury Lodge #20 and Fownes Lodge #45 to be consolidated into one lodge to be named Harmony #20. All assets of the two lodges will become the property of Harmony #20 at the time of amalgamation. It was moved and seconded that the request for amalgamation be granted and arrangements be made to proceed with amalgamation.

M:W:G:M: Gordon R. Rattray reported on a Board of Trial held at the Masonic Temple in Saint John on July 27, 2004. The matter was referred by St. George Lodge #12 and resulted in one member being suspended.

R:W:B: Randall Nelson presented a complete report on the restructuring of the Constitution. Nothing has changed to date. The information is now in the hands of the B.G.P. and eventually to the Lodges for their input, which will be incorporated into the finished product, when it is presented for final approval by Grand Lodge.

The task of replacing Grand Lodge regalia was discussed. The committee reported that funds are limited and may be expanded in one year. In 2004, the G:M: and D:G:M: aprons were replaced. In 2005, two DDGM aprons will be replaced. It was moved and carried that undress aprons and cases be purchased for DDGM's to wear at unofficial functions.

March 12, 2005, found the members of the Board at their final meeting for the current term. After welcoming remarks by M:W:G:M: Gordon R. Rattray, it was down to business. Grand Lodge 2005 is now in the final preparation. Candidates for elective office were presented. R:W:B: William Boone presented the Report on Policy of Record to the B.G.P. reviewing motions as presented from 1984 to the present time. Members of the Board felt that several motions should be recommended or deleted. At the next meeting in June, 2005, there will be further discussion on the Policy of Record so that the final draft can be put into a booklet, which will be an asset to the members of the board to have at their disposal.

My term as Chairman of the B.G.P. is now at an end. My sincere thanks to all the members of the B.G.P., all of whom are dedicated and hard-working Masons. It has been my pleasure to work together on this Board for the good of Freemasonry.

Your Grand Lodge Committee on Youth submits the following report.

As you have already heard, our youth groups are doing very well on the local and national levels. We should all take pride in the manner in which our Masonic youth have distinguished themselves.



Last year, for the first time in more than 30 years, our DeMolay was strong enough to host their own Atlantic Provinces Convention. This would not have been possible without the dedicated support of all the Adult Advisors that continue to work with our youth every day. Also each Lodge, as well as all the Concordant bodies which assisted and purchased ads in the Convention Year Book. This money went directly to support the youth of the Atlantic Provinces and enabled them to have a very successful convention.

Many changes are being made at the national level, and in conjunction with the international bodies, we are attempting to reduce the cost of operating Chapters and Assemblies, especially in the areas of insurance and background checks of all who work with our youth.

This year, DeMolay Canada met in Winnipeg, Manitoba, and were able to make a presentation to the Canadian Conference of Grand Masters. I was especially pleased to hear the remarks of our own Grand Master, M:W:B: Rattray, who suggested that each Grand Lodge should support each of their youth groups by donating 25 cents per member to each of the groups. He is correct when he says that 25 cents is not a lot of money to ensure that the Leaders of Tomorrow have an organization today. I was very proud as a member of this Grand Lodge to report to DeMolay Canada that our Grand Lodge was meeting this commitment and has been very strong in their support of our youth groups.

Brethren, each year DeMolay and Rainbow take the Masonic Fraternity and its ideals into places it has never been before; the homes of the youth of our nation. Each year dads, uncles, brothers and neighbours have joined the Masonic fraternity because of what these youth have shown them about the Masonic fraternity.

We Masons have two things that the youth do not have. One is our time and the second is our financial resources. If we share both these things with our youth we can help overcome two of the major hurdles our youth groups face. They do need our time as adult leaders and they do need our financial resources.

We have shown each year that we are able to help others through our work with Camp Goodtime and the Canadian Deaf, Blind and Rubella Association. Let us continue to work as a group, as a team, to ensure that our Masonic youth reach their greatest potential and continue to be the pioneers of Freemasonry by taking us into these new and as yet undiscovered homes.

### REPORT OF THE GRAND HISTORIAN

TO: THE MOST WORSHIPFUL THE GRAND MASTER,  
OFFICERS AND MEMBERS OF THE  
GRAND LODGE OF NEW BRUNSWICK, F. & A.M.

With permission, I present my fourth annual report as Grand Historian.

In the months since 2004 Annual Communication, there have been several positive aspects, though also low points, when considering the immediate past history of the jurisdiction.

The New Brunswick Masonic community has again witnessed the demise of a craft lodge. After 158 years of existence, Union Lodge of Portland, a charter member of this Grand Lodge, surrendered to circumstances moving into darkness and into the pages of history when the brethren agreed to surrender the lodge's charter to the Grand Master on 21 December 2004.

The history of the lodge may be traced to the rolls of the lodges of the Grand Lodge of Ireland. With the support of the Hibernia Lodge of that era, several brothers petitioned the Grand Lodge of Ireland for a warrant to organize a lodge in the suburban village of Portland just outside the City of Saint John.

On 14 May 1842, a warrant was received with the authority to form Union Lodge No. 324. The home of Brother John McCready, on the first Thursday in the month of October 1842, was the site of the lodge's first meeting.

Circumstances, which possibly may have been ego related, gave the lodge a short history. Voting to disband and return the lodge's Charter occurred in or around the years 1845-1846. On 03 November 1846, a new lodge was warranted by the United Grand Lodge of England, with the title and number of The Union Lodge of Portland No. 780. The new lodge's first recorded Master was Brother Alexander Balloch, of which a page or more could be written on that Mason alone.

At the time of the formation of the Grand Lodge of New Brunswick, the lodge having accepted the principle, was duly warranted as Lodge No. 10 of the Grand Lodge of New Brunswick.

From these beginnings, Union Lodge of Portland remained on the New Brunswick Masonic scene, until quietly though not without a struggle, slipped into the history and the myths of Freemasonry on 21 December 2004, when the Lodge's Charter was surrendered to the Grand Master, Most Worshipful Brother Gordon Rattray.

The afternoon of 18 December 2004, saw the joining of 228 years of Masonic history, a history which can be traced to the years

prior to the formation of the Ancient and Honourable Fraternity of Free and Accepted Masons of New Brunswick. A history which predates many of the current lodges, though there are lodges which have earlier inaugurations.

Though two Charters were surrendered, a more positive note was seen with the union or rather amalgamation of two lodges, bringing together 228 years of Masonic history and experience.

Salisbury Lodge No. 20 can trace its history to 03 August 1858 when a dispensation, brought to Masonic Light Lodge 1110 of the United Grand Lodge of England, though formal constitution did not take place until 05 June 1861. It has to be remembered that communication across the waters was not as swift as it is today.

Seven years and some months later, 07 January 1868, an interim warrant from the newly formed Grand Lodge of New Brunswick acknowledged the lodge and on the 20th of May of that year it was formally adopted as Lodge No. 20. In that year the lodge had a membership of 19 brothers. By the end of 1876 membership had grown to 55 members. Though the Grand Lodge Proceedings for 1899 record a membership of 16, the lodge continued and the annual return for 31 December 2003 recorded a membership of 60.

At this time there is no need to review the aches and pains of growing old; many today could give a detailed report on those effects. Let it be sufficient to say that Salisbury Lodge has had its share of ups and downs, none worse than the period from 1883 to around 1900, which could create a tale all of its own.

On 15 November 2004, not without regret, Salisbury Lodge No. 20 surrendered their Charter to Right Worshipful Brother Wayne McKay, The Deputy Grand Master, thus ending the lodge's 147 years of Masonic life.

The present Village of Salisbury's Masonic Hall was erected in 1931, though not completed and dedicated to Freemasonry until 10 October 1933. It was in this building that Salisbury Lodge celebrated its Centennial Year in 1958. The Masonic Hall in the Town of Salisbury was not to remain vacant for long.

Fownes Lodge No. 45 of Havelock, New Brunswick, while much younger as a Masonic Lodge, commenced in 1922 when 18 members of the Craft made the decision to form a Freemasons Lodge in the Village of Havelock. The majority of those brethren were members of Steven Lodge No. 37 of Petitcodiac. Actually, the Worshipful Master Daniel R. Keith, Senior Warden John R. Price and Junior Warden Arthur R. Coats were all Steven Lodge members.

The name Fownes was that of Captain William H. Fownes, who had married "Squire" John C. Price's daughter, a cousin of the first

Senior Warden. Brother Fownes began his Masonic career with Leinster Lodge No. 19; it is understood that he became a 31st Degree Scottish Rite Mason. Retiring from the sea at age 54, in 1903, he became a chicken rancher in Petaluma, California, where a year later he died. He now lies in Cypress Gardens Cemetery, San Francisco, where he was interred with full Masonic Honours by the Masons of Petaluma.

The first lodge meetings were held on the second floor of the Bank of Nova Scotia building which was reported to be owned by Captain Fownes' widow. The second building, Most Worshipful Brother A. S. Robinson, PGM and Grand Historian reported, was constructed by the brethren, even so far as cutting and sawing their own lumber. Ten years after its inception the lodge's membership stood at 73, by 1952 its membership was reported as 93.

At a meeting of the two lodges in 1973, Right Worshipful Brother C. A. Carter, DDGM, at Salisbury Hall installed the officers of Salisbury Lodge and Fownes Lodge.

At a meeting on 02 December 2004, Fownes Lodge surrendered their Charter to the Grand Master, Most Worshipful Brother Gordon Rattray. One of their last official acts of business was to ballot on a new member who will be initiated at the new united lodge.

On the 18th of December 2004, upwards of 65 brethren gathered to witness the union of Salisbury and Fownes Lodge as it was dedicated and constituted as Harmony Lodge No. 20.

With that amalgamation, Harmony Lodge No. 20 joins with Hiram Lodge No. 6 who 125 years previously was the results of the amalgamation of Solomon Lodge No. 6 and St. Andrews Lodge No. 29 in the City of Fredericton.

As Grand Historian, it is hoped that someone, some interested brother or brothers, will take the time to record the history of both of these lodges and that the current Harmony Lodge will see that their lodge's history is recorded and maintained over the coming years of what is hoped will be a long and useful Masonic life.

This again leads to what is a Grand Historian's continual urging, for all lodges of the New Brunswick jurisdiction to ensure their lodge history is prepared and continually updated.


