



REPORT OF THE PUBLIC RELATIONS COMMITTEE

TO: THE MOST WORSHIPFUL THE GRAND MASTER,
OFFICERS AND MEMBERS OF THE
GRAND LODGE OF NEW BRUNSWICK, F. & A.M.

The Public Relations Committee had the responsibility of producing Mostly Masonry, and maintaining the Grand Lodge Website. No other matters came to our attention during the past year.

Mostly Masonry appeared three times: Summer Issue, June 2005; Fall Issue, November 2005; and the Winter Issue, February 2006. It is an informative newsletter and has received many compliments. Because of the difficulty in timely delivery, the Committee met in August 2005 to consider what options might be available to facilitate distribution. At present, Mostly Masonry is compiled, sorted and bundled for delivery to the Lodges by the District Deputy Grand Masters who pick up their package at the Board of General Purposes meeting. Actually getting it into the hands of the Lodge Secretary in time for inclusion in their Notice mailing, has not been consistently successful. Add to this the practice of some Lodges using a two-month notice, it could be upwards of three months before the brethren actually have a copy in their hands. Unmailed copies have been seen laying beside the Secretary's desk in some Lodges. Not only are the brethren deprived of their copy, but the cost of printing and paper can be seen as simply waste.

The high cost of postage ruled out direct mailing to every member. Therefore, the committee felt that moving to a subscription basis would resolve the problem as well as cut the cost of production. However, a prepared proposal put before the Board of General Purposes in November and again in February did not meet with their approval. Thus, Mostly Masonry maintains its status quo.

On March 16, 2006, W:B: Stuart MacDonald submitted to the Grand Master his resignation as Editor of Mostly Masonry. We thank Brother MacDonald for the dedication he has shown over the past four years and the professional way he approached the task. He will not be easy to replace. Over the next few months, we will be looking for a new editor as well as another look at printing and distribution. Quite likely there will be no new issues until the Fall at least.

The Grand Lodge Website continues to attract brethren and guest viewers. During the calendar year, January 1 to December 31, 2005,

104,303 visitors logged onto the site, for an average of 8,692 per month. A dozen or more requests from interested viewers for more information on how to become a member have been forwarded to various brethren for follow-up. The majority, so far as can be determined, went on to join a Lodge.

There may be some concern that e-mail addresses or other information of members may be accessible via the website. Let me assure the brethren this is not the case. Visible e-mails are coded so that spam harvesters cannot read them. Any registered member's details may only be viewed by the administrator or the member himself and no information is provided to anyone, including e-mail addresses, without the member's knowledge and/or permission. The website is as secure as any other site. Although a determined hacker could no doubt find a security hole, the chances of that happening are rather remote. There is simply nothing there worth their while.

I move adoption of this report and that it be printed in full in the Proceedings.

The Annual Meeting of the Masonic Grand Lodge Corporation was held at 8:30 a.m., May 13th, 2006, at the Masonic Temple, 92 Germain Street, Saint John, N.B.

The meeting was called to order by the President, William C. Boone. Those present and eligible to vote are listed in the Register of Grand Lodge.

The minutes of the meeting held on May 14th, 2005, were read and on motion moved by J. Ralph Andrews, seconded and carried, the minutes were adopted as printed in the Proceedings.

The Treasurer's Report was then presented by Robert A. Kierstead. He went on to give a detailed explanation of the important items listed in the various reports.

It was then moved by Robert A. Kierstead, seconded and carried, that the Treasurer's Report be received and laid on the table.

In the absence of the Chairman of the Finance Committee, Daryl Moore, R. A. Kierstead presented the Report of the Finance Committee on his behalf. It was then moved by R. A. Kierstead, seconded and carried, that the Report of the Finance Committee be accepted and laid on the table along with the Secretary's and Treasurer's reports.

R. A. Kierstead added that there were a few comments that the Finance Committee wanted to have made.

Investments have declined from 20 to 25% since 2001. Several long-term investments have declined significantly. Investment growth is not keeping pace with the withdrawals from the investment fund to keep up with Grand Lodge expenditures. He stated that some solutions were offered.

1. Reduce Grand Lodge expenditures.
2. Increase per capita dues.
3. Change investment advisers.
4. Balance investments.
5. More consistent monetary investments.
6. Determine covered loss exposures.

Earl Campbell expressed his concerns that a written copy of the Report of the Finance Committee was not included with the published

Committee Reports. He also stressed that there should be a representative of that committee appointed to the Board of General Purposes because of the importance of the Finance Committee to the Board.

The report of the Audit Committee was given by the chairman, Richard Whitcomb, who concluded by moving that the Audit Report be received, and that the reports of the Secretary and Treasurer be taken from the table and together with the Auditor's Report, be printed in the Proceedings of Grand Lodge.

REPORT OF THE FINANCE COMMITTEE

TO: THE MOST WORSHIPFUL THE GRAND MASTER,
OFFICERS AND MEMBERS OF THE
GRAND LODGE OF NEW BRUNSWICK, F. & A.M.

It is my pleasure to present this commentary on the financial statements of our Grand Lodge on behalf of the Finance Committee.

Our finances have not improved greatly since 1998, even though we have kept our expenses in line. Expenses in 1998 were \$103,106.00 and our budget for expenses in 2006 is \$109,252.00. This tells us we must concentrate on producing more income, in particular investment income, but still keep control of expenses.

The Grand Treasurer has presented his reports, and from them you will see the facts and figures which I will not duplicate, except for the totals for our investment accounts controlled by CIBC Wood Gundy. Total investments at December 30, 2005, were \$621,091.66, and at March 31, 2006, \$634,755.98.

The main objective of our Committee is to produce investment income and also investment growth. The Committee has made the decision to:

1. Meet on a quarterly basis to discuss our financial position and investments.
2. Make changes in our portfolio over the next two to five years.
3. Reach an agreement as to the amount of investment income required and still obtain growth.
4. Rebalance our portfolio in a regular manner according to market conditions.
5. Have each chairman keep his spending within or below budget.

Interest rates continue to be at a low, and we do not see great changes in the near future. So we must endeavour to pursue the market place, but with more leadership and communication with our advisors. We believe that we need to become more proactive to market conditions.

REPORT OF THE LIBRARY COMMITTEE

During the past year, only one request was received and approved from a subordinate lodge for the purchase of books and educational material.

The total of \$2,000, with a maximum of \$200 per lodge per year, is available to help lodges improve their libraries, and is available on a first-come first-serve basis.

The Library Committee has been working on the preparation of a list of recommended readings which could be used by lodges as a guide when purchasing material for individual libraries. It is our intention that, after a review of the list, to forward it to the lodges within New Brunswick.

A simple plan has been put together to encourage the brethren to contribute books on topics of interest to Masonry to their lodge library, and we hope this will be pursued during the up-coming year.

During the past year, no work has been done within the Grand Lodge Library although much remains to be done. This state is primarily due to the Library Committee having been denied access to the Library. As a result, no further catalogueing has been carried out. There were no acquisitions, and no further efforts put in to achieving lending-library status; and our efforts to provide computer internet access to the catalogue have ceased.

Educational study is important to our Fraternity, and such work is facilitated by the availability of suitable Masonic research material.

We must do better!

The Committee also respectfully recommended that the Lodge seriously consider the appointment of a Grand Lodge librarian and placing responsibility for the library under his direction.

I would like to thank W:B: MacDonald and W:B: Fraser for their devotion and dedication to their work on the Library Committee. Without their efforts, much of what has been accomplished would not have been possible.

REPORT OF THE DEPUTY GRAND MASTER

TO: THE MOST WORSHIPFUL THE GRAND MASTER,
OFFICERS AND MEMBERS OF THE
GRAND LODGE OF NEW BRUNSWICK, F. & A.M.

First, some bare statistics concerning my term of office: There were 90 Masonic events attended since May, 2005, covering over 38,000 kilometers not including the trip to the All Canada Conference in Winnipeg at the end of March. Of these events, I was the installing officer at five installations, shared those duties in two others, and had a minor part in a couple of others; helped organize and conduct four Training Sessions, one of them for the District Deputy Grand Masters in Fredericton. Other miscellaneous events included speaking at Friend to Friend Nights, Camp Goodtime Sponsor's Day, Board of General Purposes and committee meetings. In accordance with the Constitution, as Deputy Grand Master, I chaired four meetings of the Board of General Purposes, the activity of which is contained in a separate report. The bulk of the events attended were in support of the Grand Master during his official visits. No formal log was kept of the numerous phone calls and e-mails in response to brethren seeking advice and guidance in their Masonic activities. Suffice to say there were many.

It is encouraging to see that most, if not all Lodges, were doing degree work this past year; even those small Lodges where candidates have been scarce for a long stretch of time. While there is no supporting data, I have the distinct feeling interest in Masonry is increasing by the uninitiated. Such feeling is not only based on the amount of degree work being done, but also by the number of inquiries received via the Grand Lodge website, as well as casual conversations with friends and acquaintances who seem more inclined to ask questions about Masons in general. No doubt some of this interest stems from Dan Brown's book, The DaVinci Code, as well as the film, The National Treasure. We can only hope the interest becomes a trend.

Of the Lodges doing degree work, the quality ranges from poor to excellent with the bulk in between. This simply means that some Lodges need more help than others in their ritualistic work, from the actual mechanics of the timing and movement to learning how to memorize effectively. The Ritual Committee is an excellent resource but they cannot be everywhere at once. Perhaps a couple of sessions with only the ritual committees of the Lodges may alleviate the situation somewhat. The committees then could take the information back to their respective Lodges and give wholesome instruction to the officers.

Most Lodge officers, as well as members, can benefit from the Lodge Officers Training Program. Learning how to work with an agenda, how to conduct a crisp, effective and efficient meeting, how to plan, delegate, organize, rule and govern a Lodge will go a long way in reducing a long, boring session and leave more time for Masonic content. We realize

that in this fast-paced world today that time is a precious commodity, not to dribble away by unproductive means; but at the same time, once commitment is made, whether it is as Worshipful Master, or serving on a committee, such commitment should be honored. Moreover, that includes taking time to learn everything possible about the task at hand. It is a wonderful feeling to know that in some small way your action has advanced your Lodge and Masonry.

Thank you brethren for the warm hospitality and support you have shown me, and the Grand Officers, on our visits to your Lodge. It is truly appreciated.

It is with great pleasure that I present the Annual Report of the Masonic Charities & Housing Company Ltd. for the year 2005-2006.

At Grand Lodge in May 2005, Cheryl Robertson, past president of the Board of Directors for the Canadian Cancer Society, standing in for Betty Hoyt, Director of Community Programs, N.B. Division of the Canadian Cancer Society, was presented and accepted a cheque in the amount of \$36,088.00 to support Camp Goodtime and the Junior Leadership Program for 2005.

Fund Raising: Masons of New Brunswick again in 2005-2006 have shown their dedication and passion by providing in excess of \$33,000.00 to fund our projects. The fund raising activities by the blue lodges and concordant bodies are providing great public relations at the local level, involving many communities in New Brunswick. Total funds raised for the year 2005-2006 are in excess of \$40,000.00 from our blue lodges, concordant bodies of Masonry, individuals and corporate donations. The term "Camp Goodtime" has become well known in the Province of New Brunswick.

N.B. Masons Camp Goodtime: Approximately 34 campers, ages 7 to 12 (original Camp Goodtime) and 22 campers, ages 13 to 16 in the

Junior Leadership Program (JLP) attended an eight-day summer camp for children with a history of cancer, for a grand total of 56 kids (the largest Camp Goodtime to date.) The 2005 JLP was also a great success and the combined camp will continue in 2006.

In 2006, Camp Goodtime will again be an eight-day camp from July 15th to 22nd, with Mason's Day/Closing Celebrations on Saturday, July 22nd, at 10:30 a.m. Our usual financial support to The Deaf, Blind and Rubella Summer Camp was suspended for the year 2005, in light of the extra cost to fund our number one charity, "Camp Goodtime" and the Junior Leadership Program.

Quinn House, St. Andrews, N.B.: This is an eight-unit complex located on Queen Street, in St. Andrews, N.B., and serves as an example of Masonic dedication to our seniors in the province. A management team comprised of members of St. Mark's Lodge No. 5 supervises the daily operations. Congratulations to this group for the continuing success of this first class facility.

The Board of NBMCHCL continues to actively investigate the funding from all levels of government that may be available today for future senior housing projects of this nature. The Board of NBMCHCL have established that limited funds are available for seniors housing projects here in New Brunswick and we will be working with interested lodges and may proceed at a location to be determined at a later date.

Festival of Trees: In late November, NBMCHCL again participated in the Festival of Trees charity, a one-week public event held at the N.B. Museum in Saint John. Our committee once again trimmed the "Camp Goodtime Christmas Tree." Funds raised go to support Mind Care, Saint John Regional Hospital Foundation and the St. Joseph's Hospital Foundation.

Board of Directors: A special thank you to the Most Worshipful Grand Master and all the dedicated Director-Masons who faithfully attend our meetings. New directors to the board of NBMCHCL is a continuous process, and I thank the new Masonic brothers appointed in 2005-2006, for stepping forward. The Directors of NBMCHCL are the Goodwill Ambassadors of our registered charity and bring with them both experience and timely advice.

On behalf of these Directors, I extend our heartfelt thanks to you, the Masons of this jurisdiction, for your immense support of Camp Goodtime and our other charitable projects.

REPORT OF THE BOARD OF GENERAL PURPOSES

TO: THE MOST WORSHIPFUL THE GRAND MASTER,
OFFICERS AND MEMBERS OF THE
GRAND LODGE OF NEW BRUNSWICK F. & A.M.

The Board of General Purposes is a general committee to which shall be submitted all matters referred by Grand Lodge to committee, except in cases where a special committee is appointed. It is to assist and advise with the Grand Master in reference to the good government of the Craft and all actions and decisions taken by the Board is subject to ratification by Grand Lodge — Constitution p. 51, 15-6, 18.

The Board, in 2005-2006, consisted of 39 members, 21 of which are by appointment. The remainder retains seats by virtue of the Constitution according to their title.

Since the last Grand Lodge communication, May 2005, the Board has met four times: June, November, February and March, with average attendance of about 71%. Business transacted:

1. June 25, 2005 Meeting

a. R:W: William Boone, DGM, elected as President of the Board, with R:W: Laurie Bishop, SGW, as vice-president.

b. R:W: William Ryan, Chair of Grand Lodge Organizing Committee, reported they came in \$2,800.00 under budget of the 2005 Communication. Complaints were at a minimum.

c. On the matter of stepping down at the closing of Subordinate Lodges, noting that the matter had been referred back to the Board by Grand Lodge, moved by M:W: O. Nason, seconded by R:W: Larry Brown, that no action be taken by this Board. Motion carried.

d. Appointed by M:W: Gordon Rattray in 2004 to review the Board minutes and compile a list of Policies as adopted by the Board, R:W: William Boone presented a list of twenty-six. A complete review of the policy saw 13 rescinded as out of date, or no longer viable. A copy is attached to this report as Appendix A.

e. Moved by R:W: Fergus Price, seconded by R:W: Randall Nelson, that the Board authorize a grant of \$1,500 towards the Sound System to be installed in the Blue Room. Motion carried.

2. November 5, 2005, Meeting

a. Chair of the Constitutional Review Committee, R:W: Randall Nelson, reported that a draft of the revised Constitution, divided into two parts: Constitution and Regulations, is complete and will be presented for consideration at the 2006 Communication of Grand Lodge. In the meantime, copies will be sent to each Lodge secretary, seeking Lodge input.

b. R:W: Ralph Hatfield, Chair of the Ritual Committee, reported they were looking at the various talks given in Lodge on the presentation of Aprons or Certificates, with a view of preparing a supplement to the Ritual if Grand Lodge so desired. A lengthy discussion regarding the

memorization of Obligations did not result in any conclusive action by the Board at this time.

c. R:W: William Boone, Chair of the Public Relations Committee, which includes the publication *Mostly Masonry*, presented a proposal that *Mostly Masonry* move to a subscription basis. On a motion to this effect by R:W: Boone and seconded by R:W: David Gillrie, it was defeated. *Mostly Masonry* will continue to be printed and distributed as it is now being done.

d. In his closing remarks, M:W: Wayne McKay noted that in some Lodges ritual is being read from the book and quality work has deteriorated to a sad state. In his opinion, no open ritual books should be in the Lodge room, save that of the official prompter.

3. February 11, 2006, Meeting

a. R:W: Ralph Hatfield, Chair of Ritual Committee, presented a report with explanations, then moved that Obligations be memorized by all candidates entering Lodges in this jurisdiction. Seconded by R:W: Edward Gilks. Motion carried.

b. R:W: Kierstead, Grand Treasurer, provided some information on insurance policy and premiums paid by Lodges each year. Each Lodge is covered to \$2-million. Cost per capita is \$1.63.

c. In his closing remarks, M:W: Wayne H. McKay reminded the brethren that pictures are not to be taken by anyone during degree work. He also announced the decision of the Grand Secretary, M:W: Ralph Andrews, to retire and the matter of his replacement would be looked into.

4. March 18, 2006, Meeting

a. Moved, seconded and carried that there be two fixed dates for two of the four meetings of the Board of General Purposes: one meeting in June on a Saturday and one meeting at least 60 days prior to Grand Lodge.

b. R:W: Maurice Linkletter, Chairman of the Youth Committee, gave a verbal report on DeMolay and announced he would be retiring as Executive Director July 2, 2006.

c. The Grand Treasurer, R:W: Kierstead, provided extra information regarding Lodge insurance in response to a question about Lodges where the building is owned by a corporation. So long as the building is primarily used by the Lodge, then it is covered. But in buildings where a portion of the premise houses a commercial enterprise, such as a bowling alley, etc., this portion would not be covered. To be completely sure of what is or is not covered, submit your circumstance and questions in writing to the Grand Secretary's office.

I move that the business of the Board as outlined in numbered items 1, 2, 3, 4, including sub-items, be ratified; and further, that this report be adopted and printed in full in the Proceedings.

BOARD OF GENERAL PURPOSES POLICIES OF RECORD 1984-2006

The following Policies for the government of the Craft in New Brunswick have been duly enacted by the Board of General Purposes, ratified by Grand Lodge, and now require that all Lodges and Brethren take due notice and govern themselves accordingly.

1. Mar. 3, 1984 — That the recommendation be sent out to the Lodges that they adopt at their own discretion and put into use immediately one or the other forms of Grand Lodge Certificate presentation.

Notes: Two recommendations from Ritual Committee:

1. That the Grand Lodge certificate presentation be done by memory after the Master Mason is examined in open Lodge.

2. Recommend use of the form of presentation described in the Notice of Motion contained in the 1983 agenda of the 116th Annual Communication.

— Rescinded June 25, 2005

2. Mar. 2, 1985 — m/s/carried: Nason/Dalton that we adopt and apply a policy of charging cost plus 10 per cent for all publications except those of education nature which should be charged to the Quinn Trust Account.

3. Mar. 2, 1985 — m/s/carried: Murray/Langley that all current and future directives be printed in new issues of, or as amendments to, existing officer's manual.

4. June 11, 1988 — m/s/carried: C. Steeves/Shelton that the Grand Lodge be authorized to provide each lodge with three rituals (for education purposes).

5. June 11, 1988 — A request to use French Ritual (GL of Quebec) was received and considered but it was decided that the official Ritual Book of the Grand Lodge of New Brunswick is the only Ritual to be used in Lodges in this Jurisdiction.

6. March 11, 1989 — m/s/carried: Mayes/Whittaker that a letter be sent to each Craft Lodge calling attention to pages 55-56, section 20 of the Constitution and General Regulations and advising that should any candidate not pass satisfactory examinations and recite obligations his advancement to higher degrees should be deferred unless there are extenuating circumstances (age, sickness, extreme nervousness, etc.) which have been duly cleared by the presiding DDGM as per directive of the M:W: the Grand Master, dated Nov. 7, 1984.

7. June 10, 1989 — m/s/carried: Linkletter/Nason that the Grand Historian be invited to sit in at Board meetings as an observer only.

8. June 10, 1989 — m/s/carried: Price/Whittaker that this Board arrange a Workshop with DDGM's and all members of Committees to apprise any new appointees of their responsibilities.

9. March 10, 1990 — m/s/carried: Campbell/Lister that the Eastern Star have permission to communicate with each Lodge in this jurisdiction (through the Grand Secretary's office) advising all Lodges that the O.E.S. is currently inviting all Masons, their wives and families to seek membership in their order and outlining its aims, objectives, benefits and indirect relationship to the Masonic fraternity.

10. March 10, 1990 — Ritual committee recommended no change in:

(1) Sign of Fidelity (2) Raising Procedures (3) Closing on One Level

11. March 10, 1990 — m/s/carried: Mayes/Linkletter that an index be included in the next printing of the ritual. (Rescinded June 25, 2005)

12. Jan. 26, 1991 — m/s/carried: Robinson/Williamson that presentation of Quinn Medallions be increased to one per district per year.

13. Jan. 26, 1991 – m/s/carried: Hoar/Nason that the Lodges in this Jurisdiction be permitted to provide widows pins to widows of deceased Lodge members.

14. June 8, 1991 – m/s/carried: Mayes/Linkletter that a directive be sent from the Grand Master to all Lodges in the Districts that jewels are to be worn only when aprons are worn.

15. Oct. 26, 1991 – m/s/carried: Boone/Jefferies that each committee reporting to this Board submit their report in writing, a copy of which is to be circulated to each member of the Board.

16. March 7, 1992 – m/s/carried: Swetnam/Linkletter that 1,000 copies of (the new) Officers Manual be purchased and 11 copies be sent to each Lodge with one copy to follow each year. *Rescinded June 25, 2005 (copies available on demand)*

17. March 13, 1993 – m/s/carried: Hollett/Mason that the Credentials Committee be located on third floor of the Temple near the entrance door for registration.

18. March 13, 1993 – m/s/carried: Prescott/Haycox that when an application is received from a blind person the matter is to be referred to the Grand Master to deal with as he sees fit.

19. Jan. 29, 1994 – m/s/carried: Balsler/Healey that 60 copies of the book [The Master's Book] be purchased and the DDGM's present one copy to each master-elect after or prior to his election; also, that each DDGM receive one as his own copy. Further that the DDGM's make a report at year's end as to the books use and acceptance along with their recommendations for continuing or discontinuing the practice.

Rescinded June 25, 2005

20. June 25, 1994 – m/s/carried: Prescott/Perks that the use of Voice Mail for Lodge meeting notices should not be approved by Grand Lodge for the present time.

21. June 25, 1994 – m/s/carried: Swetnam/Prescott that Lodges, in future, shall submit a list of books to Grand Lodge for approval, as in the past. On receipt of approval they may order the books, submit a copy of the bill to Grand Lodge and be reimbursed up to \$200 in Canadian funds.

22. Oct. 22, 1994 – m/s/carried: Linkletter/Nason that copies [of the MSA booklet "A response to the critics of Freemasonry"] be obtained and sent out to the DDGM's to be given to each newly-raised Mason through the Mentor Program.

Rescinded June 25, 2005

23. Oct. 21, 1995 – m/s/carried: Mayes/Linkletter that Masonic regalia be worn at the [Demolay or Rainbow for Girls] above functions only on special occasions by permission of the Grand Master.

24. Oct. 21, 1995 – m/s/carried: Mayes/Prescott recommend that a voting card of some distinctive color be issued to each voting member of Grand Lodge when they register. When the vote is called for, those in favor of the motion will stand beginning on the left of the Grand Master, hold up the card and say one, next two, next three, and so on until all have voted in favor, then those against will do the same.

25. March 9, 1996 – m/s/carried: Balsler/Lansburg that the Board recommend to Grand Lodge that the sons of Masons received into Lodges in New Brunswick be recognized by being given a Lewis Jewel at the family's expense, if they wished to do so. No change is recommended in the age limit in which young men are received which will remain at 21 years.

26. Feb. 3, 1996 – m/s/carried: Prescott/Perks that all requests for charity be referred to Masonic Charities and Housing after approval by the Grand Secretary and Grand Master.

27. Feb. 3, 1996 – m/s/carried: Mayes/Rideout that the Board of General Purposes and the Public Relations Committee promote the use of road signs to the Lodges.

28. Feb. 1, 1997 – m/s/carried: Pelley/G.Young that the Board authorize the establishment of an Internet Web Site for the Grand Lodge of New Brunswick under the conditions outlined in Ed Armstrong's presentation to the Board.

29. March 8, 1997 – m/s/carried: Rattray/Balsler that any recommendations made by Committees be given at the end of their report so they can be discussed and voted on separately by Grand Lodge.

30. April 21, 1997 – m/s/carried: Murray/Perks that the Grand Master and Deputy Grand Master not be permitted to travel together during their term of office.

Rescinded June 25, 2005

31. April 21, 1997 – m/s/carried: Prescott/Perks that investments only to be made on the recommendation of the finance committee.

Rescinded June 25, 2005

32. April 21, 1997 – m/s/carried: Price/Shaffer that the Financial Statements be presented to the Grand Master one week prior to each Board meeting and a copy of the Annual Financial Statement and Audit Report to the Grand Master at least 14 days prior to the Annual Communication.

33. April 21, 1997 – m/s/carried: Kierstead/Johnson that the Annual Budget be reviewed and approved by the Grand Master prior to presentation at Board of General Purposes.

34. April 21, 1997 – m/s/carried: Price/Shaffer that the Financial Records to be maintained at Grand Lodge office and access be limited to the three signing officers.

35. April 21, 1997 – m/s/carried: Perks/Hollett that any two of the Grand Master, Grand Secretary and Grand Treasurer be signing officers.

36. Oct. 11, 1997 – m/s/carried: ?/? that a bar for third generation Masons be added to Lewis Jewel not be allowed.

37. Oct. 11, 1997 – m/s/carried: Swetnam Henderson that sec. 20, page 56, be amended as follows: "Nor in any case until he has passed a satisfactory examination" including the obligation "in open Lodge in such previous degree." Under exceptional circumstances, the Obligation may be heard in the Preparation Room in the presence of at least three (3) members of the Lodge.

Rescinded June 25, 2005; also defeated in Grand Lodge May 1998

38. March 11, 2000 – m/s/carried: Balsler/Pike that prior to the annual Communication (30 days) each Lodge in the District plus the presiding DDGM shall forward one nomination for the office of DDGM together with a brief Masonic history of each nominee to the Grand Secretary.

39. March 11, 2000 – m/s/carried: Rattray/Balsler that reports [at Grand Lodge Annual Communications] that do not require explanation would not be read; however, those that do require explanation would be highlighted by the presenter as required similar to last year's arrangement. If chairman insists on reading the report in its entirety, he may do so.

40. June 1, 2002 – m/s/carried: that the term of Deputy Grand Master coincide with the term of the Grand Master.

45. March 1, 2003 – m/s/carried: Balsler/A. Young that all present at Grand Master's visit, except the Grand Master, or Deputy Grand Master when in charge, will participate in Grand Honors.

46. June 21, 2003 – m/s/carried: Gardiner/McBride that the policy on Archives be accepted.

47. June 21, 2003 – m/s/carried: Gardiner/Laurie Bishop that the policy on the Library be accepted as printed. *(See Appendix A)*

48. Nov. 1, 2003 – m/s/amended/carried: Rattray/Nason that the [Guidelines] for DDGM's be accepted as written.

49. Feb. 14, 2004 – m/s/carried: Nason/Price that the videotaping of Lodge meetings not to be carried out by anyone unless Grand Lodge decides it should be done.

50. Feb. 14, 2004 – m/s/carried: Hatfield/Nason that the report on the Grand Master's Award Program be accepted as written.

51. March 13, 2004 – m/s/carried: Nelson/Pike that the [Grand] Director of Ceremonies be elevated to the rank of Very Worshipful at the time of his installation.

52. June 19, 2004 – m/s/carried: that the policy statement [Archives Policy] be accepted as printed and put into practice as of this date. [See Appendix B]

53. Nov. 6, 2004 – m/s/carried: Pelley/Young that ritual committee report be received and filed with the minutes and the recommendations be carried out as follows:

(a) That the lesser lights be lighted in the following manner: First, the Worshipful Master; second, the Senior Warden; third, the Junior Warden.

(b) The Director of Ceremonies should not pass between the Master and the Altar when lighting the lesser lights during the first degree.

(c) When introducing speakers at the close of the meeting, the Grand Master speaks last, and the incumbent District Deputy speaks next to last.

BEARDSLEY MEDALLION

The Grand Master took the opportunity to exercise his prerogative in the presenting of the Beardsley Medallion by having the Grand Director of Ceremonies conduct R:W:B: James D. McKenna to the East for the purpose of receiving the highest honour that can be awarded by the Grand Lodge of New Brunswick.

MONEY GRANTS

It was moved by R:W:B: Robert A. Kierstead, seconded and carried, that the sum of \$4,500.00 be granted to the Grand Master for travelling expenses for the ensuing year, and that the sum of \$300.00 be granted to the Deputy Grand Master, the Senior and Junior Grand Wardens, and each of the District Deputy Grand Masters for travelling expenses.

CREDENTIALS COMMITTEE

The meeting was then adjourned to allow time for arrangements to be completed for the Installation of the Officers of Grand Lodge.

A Semi-Public Installation of the Officers of the Grand Lodge then took place under the direction of M:W:B: J. William Murray, assisted by members of Grand Lodge.

The soloist was R:W:B: James D. McKenna.

Following the Installation, the Grand Lodge was closed in Ample Form by the Grand Master.

REPORT OF THE GRAND HISTORIAN

TO: THE MOST WORSHIPFUL THE GRAND MASTER,
OFFICERS AND MEMBERS OF THE
GRAND LODGE OF NEW BRUNSWICK, F. & A.M.

With permission, I present my fifth annual report as Grand Historian.

A cliché of history says "history belongs to the victor"; another cliché refers to "history is not a tale of the past, but rather a story for the future."

Since originally assuming the role of Grand Historian, I have advocated the writing of the histories of the subordinate Lodges of this jurisdiction, as have all past Grand Historians. Currently in my possession are several historical papers and pamphlets of the Lodges currently active, and histories of Lodges which might be considered to historically only recently closed the Volume of the Sacred Law and dimmed the lights of the lodge.

I have in my possession a history of Howard Lodge edited by M:W:B: Gordon Rattray; a collaboration by M:W:B: Hitchcock and W:B: Stuart MacDonald reviewing the history of Colebrooke Lodge No. 39. Several have been placed on paper by various brethren of lodges; some have been researched by this Grand Historian, and some by W:B: MacDonald of Albion Lodge.

Bethel Lodge, now in darkness, had its life recorded up to 1992, even though existing records and its charter were not to be found until 2002 and it is understood that the Lodge's minute books are still missing. A statement was made in a postscript that there were no known brothers affiliating with another lodge, two affiliated with Hiram Lodge. In 2004, word was received that a brother of that lodge, who had not affiliated after the lodge closed, was interested in joining his grandson's lodge, Chukuni Lodge 660 of the Grand Lodge of Canada in Ontario, 12 years after Bethel closed.

On the Miramichi, we have Blackville Lodge No. 43, who petitioned in 1920. However, it was not until 1922 that its warrant was received. The short troubled and confused history of this lodge has been captured within 19 small pages.

W:B: MacDonald took the initiative and created a written history of Hartland Lodge No. 46, a lodge which after 80 years, entered into darkness. One of the interesting items in this history is the membership of W:B: Alden Nowlan, New Brunswick's poet and author, Master of the Lodge in 1962. Thanks to W:B: MacDonald's efforts, histories at times short have been compiled of the early lodges of the province. Beginning with St. George Lodge No. 19 of Maugerville and those early lodges of the Miramichi, Richibucto, Hopewell and Saint John.

Research into the minutes of Granite Lodge No. 54 and Alexandria Lodge No. 33 will lead to updated and recorded histories of those lodges. There is a possibility there are other lodge histories written! The question has to be asked, how many of the lodge members have read the history of their lodges? How many even know that there is a history of their

lodges prepared? How many lodges are there who have brethren who could and would write their lodge's history if only asked? The anecdotes and memories of the older brothers are priceless.

Other historical sources exist. The old issues of the Canadian Masonic Research Association have articles on Masonry in New Brunswick and the lodges within the jurisdiction. Newsletters published periodically by lodges, when celebrating special occasions, even copies of lodge notices or communications are a source of knowledge, membership figures are available from the Grand Lodge Proceedings. In some cases, though possibly not recently, membership lists of the lodges in the jurisdiction have been published in the Proceedings, those who attend Grand Lodge Communications are listed, and the name of the current Masters and Secretaries are in the Proceedings.

Currently, the history of the Grand Lodge is being researched and compiled. To date, most of it has been put to paper around 1950, only 56 more years to go. Regretfully, some lodges have lost records due to fires or other causes. In some cases lack of interest, possibly an attitude of "those records are boring, who wants them" has caused records to disappear.

The future can be made from past mistakes which were made. Only historical records can assist in seeing those mistakes not repeated. Currently a concern is the number of suspensions, demits and deaths that we can't do anything about. The history of this Grand Lodge is replete with times of excess suspensions, demits and withdrawals. A study of those might help devise a solution to our modern day problems and show how past mistakes can lead to solutions.

History can be a guide or a tool to help with the problem. However, the history has to be there for the craft to read and to discover the mistakes of the past to help in ensuring they are not repeated in our future. As Grand Historian, I urge all lodges to update their lodge histories and if there isn't one, appoint a committee and write one. Then read and learn the lessons they contain.

The Grand Master has referred to the \$5,000.00 US that this jurisdiction had raised and contributed to Katrina Relief. It is interesting to note that following the Great Fire of Saint John of June 1877, that a report at the 1879 Communication of this Grand Lodge, a total of \$8,408.23 was reported as having been donated to the relief of New Brunswick Brethren who had suffered losses from that fire. Of that amount, \$3,368.01 was recorded as having been received from the lodges and Masonic brethren of the United States. All donations received from the United States were reported to have been in gold at the then current rate of exchange. That is a historical fact of brother helping brother.

I attended installations at various Lodges, taken a part where I was requested, and other Masonic functions on your behalf, which was my pleasure to do so. Attached is a list of my official visits.

Of course, we mourn the loss of R:W:B: George Ingersoll, who was so proud to be the DDGM for District No. 5; a diligent worker and dedicated member of the craft, he will be sadly missed throughout our fraternity. To the other DDGM's, I want to say to each one of you my heartfelt thanks for the many hours you have been giving to this fraternity in the past 12 months. We bid a fond farewell to R:W:B: Ed Gilks, DDGM District No. 3, who has completed his two-year term with dedication and I offer him, on behalf of the fraternity, our heartfelt thanks for a task well done. To the two new DDGM's and the ones continuing on, I am confident you will continue with your challenges in the coming year. Thank you.

State of the Craft

I am encouraged by the increased interest of the new members coming to our fraternity. They are young, knowledgeable, interested in what our great fraternity is all about. We must endeavour on their behalf to meet that need or in the very near future they will be gone. We are still not out of the woods in membership. We continue to face an uphill struggle to overcome this problem, and we must continue, each and every one of us to see, that as we look around us in every day life, in our communities, in our daily work places, in our churches, to find good men and invite them to our fellowship seminars in our local lodges.


At the District visits, which I completed this week, I was very pleased to have members of this Grand Lodge accompany me and show their support of the local lodges in their respective areas. I will state that I am most pleased with the detailed reports presented to me by the Worshipful Masters of their lodges. I have had the opportunity on my visits to witness degree work conferred on the candidates in a most satisfactory manner. Continue to keep and improve this standard of ritual.

Conferences

I attended the Grand Masters Conference of North America in Nashville, Tennessee, February 18-21, 2006. It has been a few years since this Grand Jurisdiction was represented at this conference. The Canadian delegation at this conference was well represented, from our brothers in Newfoundland to Alberta in the west, and we took our place at the table and were warmly received and accepted by our American brothers.

A presentation was given by D:G:M: Rex Hutchins on "sowing the seeds of change", a very informative presentation on the many aspects of our fraternity. I attended the breakout sessions which took place over the next day and a half which covered a wide spectrum of Masonic interest. It enabled me to gain an insight into how other jurisdictions are implementing various programs and the many aspects this great fraternity has to offer. I was humbled to be selected to chair the "Time and Place Committee" for 2007. I personally found this conference to be informative, and it afforded me the opportunity to be able to meet and discuss Masonry with my brethren from across North America.

The All Canada Conference was held in Winnipeg from March 31st to April 1st, 2006. Your Grand Master and Deputy Grand Master, R:W:B: William Boone, attended. The conference opened on Friday afternoon with three papers, one of which was delivered by R:W:B: Boone, and was well received by the group. We reconvened in the evening to discuss how we would continue to fund this conference. After much discussion, it was agreed to charge three delegates from each jurisdiction the sum of \$650.00/delegate. This would amount to an increase to this jurisdiction of approximately \$580.00. We felt this to be a fairer cost sharing arrangement to all jurisdictions concerned.



Saturday morning we had reports from the various conferences held in Western Canada, Conference of Grand Masters in North America, and Conference of Grand Secretaries in North America. This was followed by a paper on membership problems and the need for change, presented by R:W:B: Larry Grandy, Grand Secretary (NF&L). In the afternoon, we held our business meeting. I was nominated to be Vice-Chairman for the year 2007, and was elected as such. Chairman was G:M: Gary Atkinson of Ontario.

The conference was informative regarding our Brethren in our Sister Jurisdictions and we parted on the level until next year.

Jurisprudence

This Grand Lodge was requested by Albion Lodge No. 1, following charges being brought by the District Deputy Grand Master for District No. 1 after consultation with the Grand Secretary, to adjudicate three charges of unmasonic conduct against a Worshipful Brother, from 2003-2005. Since one of the charges was the election of the Grand Master for 2005 of which I had been a candidate, I decided to step aside to let justice be done in the fairest manner to all parties concerned.

I requested P:G:M: William Balsler to preside at the trial, which he agreed to do. I thank him for taking on this most unpleasant duty. The trial was held at the Masonic Temple in Saint John on April 27, 2006. Present were myself as observer, the Junior Grand Warden, acting Grand Secretary, acting Grand Director of Ceremonies, acting Grand Deacon, chairman of the Jurisprudence Committee, and four Past Grand Masters. The Deputy Grand Master was requested to be a witness, although he was not required to give evidence. The Senior Grand Warden was required to present evidence. Each side presented evidence to support and defend the charges as presented.

After deliberation, members of the trial board found Worshipful Brother Stuart MacDonald guilty on the first charge by majority, guilty on the second charge unanimously, not guilty on the third charge. As a result of being found guilty on the first two charges, Worshipful Brother Stuart MacDonald was placed on indefinite suspension.

Brethren: Since I was an observer at this trial board and after reviewing the evidence as presented and after great consideration and deliberation on my part and as *unity* is essential throughout the whole Masonic fraternity, it is therefore my decision that the sentence imposed

on Worshipful Brother Stuart MacDonald be reduced to a letter of reprimand and time served from April 27, 2006, to this day, May 13, 2006, and that he be reinstated with full Masonic privileges as of this date. Brethren, I would ask that you ratify this decision.

(At this time, the Grand Master directed the Deputy Grand Master to have the above decision ratified. A vote was called resulting in a large majority approval. The assembled Past Grand Masters and the Grand Secretary then retired from the Lodge room.)

Acknowledgements

I wish to say thank you to the members of the Board of General Purposes and to each of the chairmen and members of the committees for the services you have rendered on behalf of this Grand Lodge. Many thanks are given to each one of you.

To the Brethren of this Grand Jurisdiction, you have earned my heartfelt gratitude for the support you have given me over the past 12 months. Your faith and dedication will serve to inspire me to work to the best of my abilities for the welfare of this society we are so proud of. Brethren, as a Mason we must stand ready with all sincerity to give our wholehearted assent to its teaching and principles, obedience to its laws and regulations and observance to its landmarks.

We must work constantly to extend the hands of brotherly love in our lodges, in our homes and in our daily lives so that we can take pride in our fraternity and be a just and upright Mason.

Brethren, as I said before, we must redouble our efforts to support our fraternity in its endeavours so that it may continue long into the future. *Brethren you are the fraternity.* Thank you.
