I don't think that it comes the news cast or comes from the government, I think peace comes from you and I as God directs us where we believe that he is the Great Architect Of The Universe and he directs day by day to put that peace into action. Our order and our fraternity strives for peace but we don't strive for it necessarily with our lips, but it's in our lives that its extended to one another in brotherhood. 



Visitations

During the past year I am pleased to report that I have completed Official visits to half of the lodges in the jurisdiction, District meetings in each of the seven districts and numerous informal visitations throughout the province. Of special note was the celebration by Miramichi Lodge # 18 on their 150th anniversary on June 27 and Sussex Lodge # 4 commemorating the 225th anniversary of Freemasonry in New Brunswick with a special celebration, both of which were well attended. I have continued the format of the District Meetings where each lodge in the district made a presentation (5-7 minutes in length) on a subject of a Masonic nature. Interesting and informative presentations were received from each of the lodges. This format was intended to add some variety to the meetings, shift the focus to that of education and possibly influence the content and programs being implemented in the regular lodge meetings to make them more interesting and informative for the membership. This has been occurring in a number of the lodges with positive results. I also had the opportunity and pleasure of attending a number of installations throughout the jurisdiction in which I took part in a number of them.

I received many invitations from concordant bodies to attend their annual and special communications. I attended all that I could and in a few cases had the Deputy Grand Master, Senior Grand Warden or Junior Grand Warden attend on my behalf. Thanks to each of you for the warm welcome and many courtesies extended to me and my representatives.

This year I had the opportunity of attending nine of our neighbouring jurisdictions and was well received at each of them. My thanks go to the Deputy Grand Master for representing me and this Grand Lodge at the Grand Lodge of Newfoundland during their annual session.

District Deputy Grand Masters

I began my term of office with six new District Deputy Grand Masters who I had the honour of installing into their office and one returning District Deputy Grand Master from District 5. I am pleased with the work and support of these Brethren, my representatives in the Districts for it is through them that I am kept informed of what is taking place. To Right Worshipful Brother Philip Hartford of District 5, who is retiring I thank you on behalf of this Grand Lodge and all the Lodges in your District for your dedication to the craft during the past two years.

All Canada Conference

In March the Deputy Grand Master, Grand Secretary and I attended the All Canada Conference of Grand Lodges in Canada in Winnipeg. The Theme of the conference this year was "Visibility – Making the Best of Our Opportunities". This conference is an excellent forum in which the representatives of the Grand Lodges in Canada are present to share ideas, experiences and opportunities and we find that there are many similarities in the challenges that we all face. In addition to the input and reports from each of the jurisdictions there was an excellent panel discussion with four speakers presenting their views on the visibility of our order within our communities and the importance of a positive image and how we as masons are perceived in our communities- Are we honest, upright, outstanding citizens? One very interesting presentation given was a retrospect on the first meeting of this conference which was held in 1947 – surprising the similarities in the agenda and many of the discussion items.

Public Relations

W.B. Macx MacNichol continues to perform an excellent job as editor of Mostly Masonry in the accumulation of data, formatting and electronic distribution of this document via email and posting to the web site. He was also instrumental in having a number of articles published in area newspapers which has contributed to raising the awareness of our fraternity in the eye of the public and providing a better understanding of what we do.

State of the Craft

The state of the Lodges throughout the jurisdiction has been for the most part positive with many of the lodges receiving new petitions and they are busy in the performance of the ritual work associated with each of the degrees and it appears that most candidates have done their homework on the internet, etc. and are knowledgeable regarding various aspects of the fraternity. There are a few lodges which continue to struggle with an aging and declining membership.

It is with regret that I must inform you that in December 2009 The Deputy Grand Master received the Charter of Sunset Lodge # 56 in Campobello which was returned with dignity and concern for the brethren present.

Many of the lodges are making adjustments in their meetings to place greater emphasis on programs of an educational, general interest or of a training nature with a reduced focus on the business meeting. This is an attempt to generate interest among the brethren to foster and develop attendance and visitation within the lodges. This appears to be having a positive result and should complement the work currently in progress on **Our Five Year Strategic Planning Committee** chaired by Right Worshipful Brother Ed. Burrige. This is a work in progress and is now posted on the GLNB website and has been distributed to each of the Lodge Secretaries. Much of the data compiled in this document consists of input received from many of you at presentations given at various lodges over the past few months, at District Council meetings and one on one discussion.

The lodges must now develop meaningful action plans and targets for their lodges and their membership. Brethren let's all work with this to create an atmosphere within our lodge for success. We are here to assist but this must come from the individual lodges and its membership – Not from Grand Lodge.

Brethren we are now better positioned on a financial basis with our per capita dues and we expect that after this year the requirement to continue to draw on our capital to cover our expenses will cease.

Acknowledgements

My brethren, to be elected and installed as Most Worshipful Grand Master has to be one of the top highlights of any Brother's Masonic career. With it comes responsibilities and dedication to the craft. Much time is spent travelling about this jurisdiction and beyond. The rewards associated with serving as Grand Master are immeasurable and unforgettable and will forever be treasured.

The list of those who contributed to making this year a success is extensive and I trust that all will continue to labour for this great fraternity and that you will assist me throughout the coming year.

ANNUAL REPORT Of the N.B. MASONIC CHARITIES & HOUSING COMPANY LTD.

To: The Most Worshipful the Grand Master, Officers and Members of the Grand Lodge of New Brunswick, F & A.M.

It is my pleasure to present the Annual Report of the New Brunswick Masonic Charities & Housing Company Ltd. for the year ended December 31, 2009.

In November, we celebrated twenty years of operation of Quinn House in St Andrews. On November 5, the Board of General Purposes held its quarterly meeting at St. Mark's Lodge #5, followed by a special lunch attended by various members of our Board of Directors and previous officers and directors of the company, including Don Gruchy, our original president, PGM J. William Murray, PGM Wayne Hitchcock, and Morton Mitchell, all of whom spoke about different aspects of Quinn House development and operations. All of the speakers expressed great praise to Frank Langley, who had been its leader over this period of time in the management of the complex. The event was well publicized in the "St. Croix Courier" and "Mostly Masonry."

The Board of Directors would welcome recommendations for the construction of another Seniors complex within our jurisdiction, which could be managed by a local lodge. We have experience and a good "track record."

Earlier in the year, Camp Goodtime commemorated over twenty years of Masonic support when the Canadian Cancer Society, New Brunswick Division, planted two apple trees at the camp on Grand Lake. Taking part in cutting a ribbon at this event were Ms. Betty Hoyt, representing the Cancer Society, Miles Graham and Jim McKenna. The camp this year had a record number of campers.

The camp was made possible with the reception of a cheque for \$35,000 during the 142nd Annual Communication of this Grand Lodge. Ms. Betty Hoyt, Director of Prevention and Support, received the cheque on behalf of the Canadian Cancer Society. Camp Goodtime is a seven day summer camping experience operated by the Cancer Society, for children aged 7 to 16, with, or having had a history of, cancer.

We are pleased to say that we are again able to support this camp in 2010, but that it will increase in cost to \$35, 770, the increase due to increase in cost of staff. The closing day for the camp, to which all Masons in New Brunswick have been invited, is Saturday, July 17, with exercises beginning at 10:30 a.m. The camp location is at the Rotary International Camp for Children with Disabilities on Route 690, on the north side of Grand Lake, and near Douglas Harbour.

We again supported the Canadian Deaf Blind and Rubella Association in support of their children's summer camp program.

Financial support continued into the third year for the Scottish Rite Foundation's Moncton learning centre for dyslexic children. We are committed for one more year in this project.



For the rest of you who want to know about the new Alumni Chapter, it is for Master Masons who may not have had the opportunity to Join DeMolay as a young man and now wish to capitalize on an opportunity. I have handouts for those of you interested in making application to join. Please see me after.

You witnessed the youngest member of Phil Drader Coronation Chapter, obligate the new alumni members. Youngest, as in 12 years old, a member

for 5 months, and was able to properly pronounce two words in the Initiatory degree obligation, Defiles and Debauches,

You witnessed, and equally became an integral part of, the DeMolay experience for those young men. Notice the word Experience, because that is exactly what DeMolay is. It is an experience. Actually not just an experience, but many many many positive experiences which help the young men of today, become the leaders of tomorrow.

DeMolay is structured to give young men a safe place to learn extremely important life lessons, without them even realizing they are learning. We provide an environment for a positive adult youth association. Big words to say, young men, involved with members of the Fraternity, in a positive way. The importance of this can never be overstated.

DeMolay is not a junior Masons group, but Masons do sponsor and support DeMolay because it's the right thing to do for their community. Some important facts you should be aware of; Most DeMolay who join the fraternity, go on to leadership roles in their lodge. Most lodges that sponsor a DeMolay Chapter see an increase in their membership. About 25% of the members of DeMolay actually join the fraternity. Many new parents and relatives are introduced to the Masonic Fraternity through DeMolay. For every 100 DeMolay members, Masons will recruit 75 new members. I, as well as many other masons in this room, can attest to the many new members in the fraternity that never would have joined had it not been for their association with DeMolay.

I refer you to Bro. Dave Evans, Senior Warden of his lodge and past Jurisdictional Master Councilor of Atlantic Canada, Reid Allen and my son Alex Millett, both fellow craft masons, and both past Jurisdictional Master Councilors, as well as several other young men who have joined the fraternity. I refer to Dad Wilf Richter, Dad Charles Cormier, and many other masons, who made application to join after their son's became involved in DeMolay. I don't have fingers and toes enough to count all the members of the fraternity I know directly resulted from their involvement in DeMolay and for no other reason than their exposure to the ideals demonstrated by the Masons who cared enough to volunteer their time.

I have heard the phrases, "I am too old" or "I am too busy, to become involved with the youth." said by people who have been asked to become involved. I disagree on both counts. The older the leader the more knowledge and experience we may be able to share with our young members. Too Busy? Young people need one hour of your time more than a dollar of your money. So, if we feel we are too busy, then perhaps we should re-examine our priorities. It would be irresponsible of us to idly stand by and let subversive and other undesirable influences dominate the thoughts of our young men. If you're not part of the solution, you are part of the problem.

Recently I was making a request for some financial support for the boys, and I got a question asked of me that I found difficult to answer, so I made it my business to find an answer. I was asked if I really thought the DeMolay program was worth it. Of course my immediate answer was yes, but how could I quantify it? Now I can. This is based on studies done by the Conference board of Canada, on the lifelong value of education, youth and future of Canada, the cost of early high school dropout, and the benefit of post secondary education. Their findings showed that the average youth who drops out of high school, will on average cost the Canadian taxpayer over \$800,000 over his or her lifetime, made up of lost revenue from taxes for salaries not earned, legal system and jail time, and excessive health care expenses. Conversely, every student who stayed in school, and completed even two years of post secondary education, over the course of their lifetime contributed an average of 1.2 million dollars to the economy of Canada. So the math says, every one youth that goes from a high school drop out to only 2 years of post secondary education is almost 2 million dollars. That means so far in my DeMolay career, I have helped contribute over 10 million dollars to the economy of Canada, and those are just the ones I have specific knowledge of, not the ones that might have been sitting on that fence able to go either way.

You owe it to your sons, grandsons, nephews, even your neighbors to introduce them to DeMolay. You owe it to your lodge, your neighborhood, your community, our society; you even owe it to yourself.

So in answer to the question, why do I do this, Ill refer to the slogan that keeps coming back to me time and time again; A hundred years from now it won't matter what kind of car I drove, what my house was like, or what my bank account was, but the world may be a better place because I made a difference in the life of a boy.

It is my pleasure to once again submit the annual report of the Grand Lodge Library committee. The work associated with the library is by its very nature an ongoing affair as acquisitions received continue to be catalogued and placed on the library shelves. Our Grand Lodge library continues to grow with the holdings of our library currently standing at approximately 1500 titles and we continue to add to our collection. We would encourage our membership to take advantage of this valuable resource.

Historically we have all faced the difficulty of finding quality Masonic books on the stacks of our local book stores, whether they be national chains or locally owned. This has presented a particular challenge to the newly minted Mason who is eager to continue his Masonic journey through further study and who is desirous of starting his own Masonic library. With this in mind your committee approached the InPrint Book Store located at 16 King Street, Saint John with the suggestion that they carry a selection of Masonic books. (The InPrint Book store is an extension of the UNBSJ Book Store.) The management of the book store has responded favorably to the suggestion. To: The Most Worshipful Grand Master, Officers and Members of the Grand Lodge of New Brunswick, F. & A.M.

It is my pleasure to submit to this Most Worshipful Grand Lodge the annual report of your Grand Historian.

Since the last annual communication of this Grand Lodge we once again find ourselves faced with the closure of another subordinate lodge. In December 2009 the brethren of Sunset Lodge No. 56, located on Campobello Island, voted to surrender their charter. Present at that meeting was the Deputy Grand Master, RWB Peter Whittaker who accepted the charter on behalf of the Grand Master. A small membership, divided in sense of purpose, brought about this unhappy termination. Erected in 1997 the membership of the lodge had been struggling over the past few years to keep themselves afloat, but to no avail.

Progress continues to be made on the completion of lodge histories, albeit slowly. Over the past year we have received the printed copy of the history of Tweedie Lodge which has been placed in the Grand Lodge library.

The secretary of Sunbury Lodge No. 42, WB Phil Nason, has completed the history of that lodge. His work, which is to be commended, will add to our knowledge the development of the craft in Sunbury County.

The History of the Union Lodge of Portland has also been completed. This lodge had its beginnings as the Portland Union Lodge No. 324 (Irish Registry) in 1842 and relinquished their charter in December of 2004. For many years this interesting lodge was vital part of the Masonic scene in the City of Saint John and from its loins sprung many highly respected Masonic leaders.

One important aspect of Masonic history that should always be considered is the number of significant people who have been members of the craft. With this in mind I offer for your review a short biography of one of our more colorful past Grand Masters, John Valentine Ellis.

**John Valentine Ellis
1835-1913
Editor, Senator, Freemason**

The Hon. John Valentine Ellis was born in Halifax of Irish parentage on February 14, 1835. After an education in the public schools he went to work as a printer at the Halifax *Morning Chronicle* and then moved on to brief stints in New York and in Montreal as a reporter with the *Montreal Herald*. In 1857 he arrived in Saint John and found work as a printer, first with Edward Willis and then at George Edward Fenety's *Morning News*. Fenety appreciated Ellis's potential and before long the young man was writing occasionally for the *News*. In 1861 Ellis formed a partnership with Christopher Armstrong and bought the floundering *Daily Evening Globe*. Under their direction the *Globe*—renamed the *Saint John Globe* in 1867—flourished and became one of the leading Liberal newspapers in the city.

Ellis was fearless in his reporting, having no fear of status or position when taking a stand on the issues of the day. Through its editorial pages, Ellis was to make his political views abundantly clear. He was deeply committed to the principles of British liberalism and, although a supporter of the Liberal party, he felt no obligation to toe the party line. Ellis was considered by friends and foes alike to be an independent thinker and once confided to Wilfred LAURIER that he thought he might be "too radical" for Canadian politics. He advocated such progressive measures as labour unions and a broader franchise which included women's suffrage.

As the turbulent 1860's began in New Brunswick, Ellis put pen to paper and addressed the issues of the day in his bold and pithy style. Unlike the majority of Maritimers, he supported the North during the American Civil War because he felt that the South posed a threat to human liberty. More important to Ellis, however, was the burning issue of confederation. He saw little merit in the idea of the Maritime Provinces joining with Canada and instead supported annexation to the United States. The confederation scheme of 1865, he stated, would only make the Maritimes a "tributary to Canada, and will grind us down to pay her debts." After it was adopted, Ellis became one of the leaders in 1868 of the newly formed New Brunswick League, which lobbied for repeal of the union.

Ellis's secessionist and annexationist views led him to run as a federal candidate for Saint John City and County in 1874. His decision to stand split the Liberal party and he was defeated. Two years later he was named postmaster of Saint John by the Liberal government of Alexander Mackenzie, a post he retained until he was removed by the Conservatives in 1879.

In 1887 he became involved in a famous federal election in Queen's County when George C. King was the Liberal candidate, George Baird was the Conservative candidate and John R. Dunn the returning officer. When the ballots were counted, King had a majority of sixty-one votes, but on Declaration Day, Dunn announced that Baird was elected by acclamation as he claimed King's lawyer, Mr. Wetmore, handed him the documents a moment or two before John McLean was announced as King's official agent. Nevertheless he had accepted the papers and deposit, gave a receipt for them, appointed deputy returning officers, sent out ballot boxes, collected them after the voting was finished and counted the ballots and only after he was aware that King had the majority of votes did he decide that there had been no election.

King applied to Judge Steadman for a recount and the Judge granted it. Mr. Justice Tuck of the Supreme Court overruled Judge Steadman, he said there could be no ballots to recount because there had been no election. It was then that Ellis wrote an editorial in his newspaper, the *Saint John Globe*, entitled "Government by Fraud", in which he accused Judge Tuck of partisanship.

Baird asked the New Brunswick Supreme Court to censor Ellis for his editorial. They did and cited Ellis for contempt of court.

The matter was passed back and forth between the Supreme Court of New Brunswick and the Supreme Court of Canada and on technicalities permitted to lie dormant for the next six years. The whole matter would have probably died a slow death from lack of attention if Ellis had not written another editorial. On that occasion he wrote an editorial critical of the way Judge Palmer had handled the Park's Cottonmill case when it came before him in the

Court of Equity. The New Brunswick Supreme Court jumped on Ellis and sent him to jail for one month, plus heavy fines and costs; not for what he had written about Judge Palmer, but for what he had written about Judge Tuck six years earlier.

When Ellis came out of jail, he was met at the Saint John railway station by two brass bands playing martial music and 5,000 grits carrying torches.

He was prominent in every progressive movement in the community, identifying himself with several charitable and benevolent organizations. In public life he was elected in 1882 as a Liberal candidate to the Provincial Legislature where he held the seat for Saint John for five years. In 1890 he was elected to the House of Commons holding a seat there for two periods, 1890-1891 and 1896-1900 when he was called to the Senate of Canada. He served as a Senator until his death in 1913, during which time he served as chairman of the debates committee. He was distinguished for his clearness of intellect, independence of views and unfaltering adherence to his convictions.

For some time, besides his newspaper work, he was postmaster for Saint John and served on the Saint John School Board. His services were in demand in the business world as well where he was elected director of many companies. In 1897 the University of New Brunswick conferred an honorary Doctor of Laws upon him

MASONIC CAREER

Ellis began his Masonic career in the Lodge of Social and Military Virtues, Montreal (now Lodge of Antiquity) when he was initiated on April 3, 1856 from which Lodge he demitted on August 4, 1859. On removing to Saint John he first affiliated with Hibernia Lodge and would later affiliate with Carleton Union Lodge, in Carleton, what is now West Side Saint John. He would serve this Lodge as Worshipful Master.

CONCORDANT BODIES

Ellis was very active in both York and Scottish Rites where his intellect and devotion to Masonic principles would lead him to serve in no less than six Grand East's.

In York Rite he served as Grand High Priest (1st Grand Principal) Grand Chapter of Royal Arch Masons of New Brunswick in 1887 and 1891. In 1892 and 1894 he served as Most Puissant Supreme Grand Master, Supreme Grand Council Eastern Jurisdiction of Canada, Royal and Select Masters. Supreme Grand Master Sovereign Great Priory of Canada, Knights Templars Grand High Priest of the Grand Chapter of New Brunswick (1894-98); as Grand Master of the Grand Council (1892-94); as Supreme Grand Master of the Knight Templar

Order in Canada (1890-1900); as Provincial Grand Master of the Royal Order of Scotland (1895-1913), as well as numerous lesser honours and distinctions.

As a member of the Ancient and Accepted Scottish Rite he served as Thrice Puissant Grand Master, 1878-86, Saint John Lodge of Perfection; Most Wise Sovereign, 1889-95, Harrington Chapter Rose Croix and Commander-in-Chief, 1897-1900, of the New Brunswick Consistory. On the national level his dedication and leadership abilities were readily recognized. He served as Grand Chancellor, 1874-80; Lieutenant Grand Commander, 1880-89 and as Sovereign Grand Commander from 1886 to 1892.

He was coroneted an Honorary 33° in 1872 and an active 33° in 1874. He served as Deputy for New Brunswick from 1880 to 1883.

He represented the Supreme Council at two international Conferences at Brussels in 1907 and Washington in 1912. He was a frequent visitor to the Supreme Councils in the United States where he was held in the highest esteem and regard. He rarely missed a meeting in 39 years and that in spite of failing health in his declining years

GRAND LODGE OF NEW BRUNSWICK

Ellis was active in the erection of the Grand Lodge of New Brunswick in 1867. In 1868 he was appointed as the Grand Director of Ceremonies as well as to the Board of General Purposes. At the third annual communication of the Grand Lodge of New Brunswick held in September of 1870 he was elected as Deputy Grand Master, to which office he was re-elected in 1871. In 1872 he was elected as the Grand Master, an office he would hold for the next three years (1872-1874). In 1884 he was re-elected to the Grand East and would once again hold this office for a period of three years. (1884-1886)

During his first term of office Ellis would extend fraternal relations with the Grand Lodges of Scotland, New Jersey, Michigan, British Columbia and Utah. The establishment of fraternal relations with the Grand Lodge of Scotland was a significant event, as this avenue of discourse had been sought by the Grand Lodge of New Brunswick for the previous five years. On January 6th, 1873 the Grand Master constituted St. Martins Lodge No. 30 and installed the officers.

The first year was not void of problems requiring the Grand Masters attention. Ellis temporarily suspended the labours of Hibernia Lodge No. 3 pending final settlement of certain charges preferred against the Worshipful Master elect of the Lodge and arising out of a pernicious system of canvassing for office which appeared to prevail in that Lodge. A letter was also received from the Grand Lodge of Maine complaining that citizens of that state were being made Masons in Alley Lodge.

The Grand Master was also called upon to rule on an application to publicly install officers, which application was denied. In his address to Grand Lodge, Ellis stated "I know of no power possessed by the Grand Master to enable him to issue a dispensation to legalize such a public installation."

The second year brought forth an interesting query to the Grand Master. Twice during the year informal application was made to determine if the Grand Master would be in favour of the establishment of a Lodge in the city consisting exclusively of men of colour. There was residing in the city men of colour who had been regularly made Masons in Halifax as well as men of colour who claimed to have been made Masons in the United States under an authority not known to or recognized by the Grand Lodge of New Brunswick (These were most likely Prince Hall Masons)

The Grand Master did not think it advisable to establish a Lodge composed exclusively of men of any sect, colour, opinion or nationality as such, it is (Masonry) to unite men of all kinds in the broad principles of human brotherhood.

In the Grand Masters second address he speaks to the dispute that had been ongoing between the Grand Lodge of Canada and the recently formed Grand Lodge of Quebec. The resolution of the dispute between these two Grand Lodges having recently taken place, the Grand Master makes comments on the use of the title "Grand Lodge of Canada" by the brethren in Ontario.

In part the Grand Master stated " On the other hand this Masonic separation of the old province of Canada appears to make it a matter of fact, that the Masons in each province of the Dominion will have their own Grand Lodge and in view of this the Grand Lodge of Canada will, I have no doubt, find it more convenient for herself, as well as more correct, and more courteous to her sister Grand Lodges in the Dominion to adopt a style and title that will clearly express her territorial bounds. For many reasons, the strongest of them connected with old associations of memory, I should part with deep regret with the name of the Grand Lodge of Canada, but the change, it appears to me, is inevitable."

In view of the resolution of difficulties between Ontario and Quebec formal recognition was extended to the Grand Lodge of Quebec.

During the Grand Masters last year in office (during his first triennial service) he had the pleasure along with a suite of Grand Lodge officers to consecrate the newly formed Grand Lodge of Prince Edward Island and install the Grand Master and other officers. In reporting this event in his address he was of firm confidence that the recognition requested by that new Grand Body would be readily extended.

In the first year of his second triennial term there were no events of particular importance to report as indicated by Ellis in his address to Grand Lodge in April of 1885. What is of interest was his recommendation that the system of District Deputy Grand Masters be adopted by this jurisdiction. This recommendation was heartily endorsed in the Report of the Committee on the Grand Master's Address. Contained within that report were the following motions; "Resolved, That Grand Lodge does approve of the creation of officers of this Grand Lodge to be styled District Deputy Grand Masters; and further, Resolved, That the Board of General Purposes be directed to take the matter into consideration and prepare and submit to Grand Lodge at the next Annual Communication the necessary constitutional regulations to carry the above into effect."

In his address to Grand Lodge in 1886 the Grand Master expressed concern with the number of withdrawals (demits) and suspensions taking place throughout the jurisdiction. It was also at this communication that we find District Deputies installed into their respective offices for the first time.

At what would be his last meeting of Grand Lodge in his capacity as Grand Master, M:W:B: Ellis was unable to attend due to pressing duties in the Senate in Ottawa.

Ellis fell ill during the spring session of parliament in 1913 and therefore his death was not unexpected. In the days that followed, the widespread recognition and respect he had achieved were evident in the outpouring of remembrances from editors and politicians all over the country. Perhaps the most concise and fitting tribute came from James Alexander Macdonald, the editor of the *Toronto Globe*, who described him as "a man of unblemished character, and high standing in the community, and the editor of a newspaper highly esteemed for its moderation and independence."

In the History of the Ancient and Accepted Scottish Rite of New Brunswick the author, M:W:B: Reginald Harris 33°, had this to say of Ellis; "In deliberative work he never jumped to conclusions. His well-balanced mind always strove after that which was right and prudent. Concise in the expression of his views, he seldom failed in securing concurrence. A man distinguished for his devotion to duty, his profound knowledge of Masonry, his sterling character, and his broad culture.

He died at Saint John on July 10, 1913, in his 79th year. Scores of tributes emphasized his devotion to duty, his profound knowledge of Masonic questions, and his sterling character. "

REPORT OF THE FINANCE COMMITTEE

To: The Most Worshipful the Grand Master, Officers and Members of the Grand Lodge of New Brunswick, F. & A.M.

The 2009 operating expenses were maintained within budget allowing us to lessen our dependence on investment income and helping toward restoring our investment portfolio to previous years' levels. The operating loss shown in our statement is attributed to two primary items; the first is the paper loss on our election to write down our inventory. As much of our inventory is distributed at no charge, this was done to more accurately reflect the realizable value of the inventory on hand at year end. The second item is the loss realized on sale of the investments we converted to meet cash flow needs. We have also reflected an unrealized gain on our investment portfolio in 2009. Finally, after two years of downward movement in the equity markets, we have seen recovery and some of the previous deterioration in our portfolio has been restored.

A couple of items of significance on the balance sheet are reflected in the Other Asset section. We assisted the Saint John Masonic Temple Limited and the Moncton Masonic Temple Limited by providing financing for building renovations they carried out during the year. These are both interest bearing notes, well above the current GIC rates. At the same time we consolidated a Saint John Temple loan that was previously advanced by the Benevolent Fund investment portfolio. We will repay the benevolent fund as the Temple Loans are repaid to us.

Our 2010 budget includes a \$10.00 increase in the per capita assessment. This increase will allow us to finally discontinue using the capital from our investment portfolio to support the operating expenses of Grand Lodge. We may also be able to retain some of our investment income this year to be added back to the investment portfolio. Now that we are realizing some market recovery in our investment portfolio we will be exploring opportunities to move toward a more conservative investment strategy. This should help us prevent the severity of future declines in our investment portfolio as a result of global market declines.

REPORT OF THE PUBLIC RELATIONS COMMITTEE & MOSTLY MASONRY

To: The Most Worshipful the Grand Master, Officers and Members of the Grand Lodge of New Brunswick, F. & A.M.

The past Twelve months for Mostly Masonry was positive in regards to getting Freemasonry greater exposure to the General Public.

Not wanting to take credit for the work of author Dan Brown but his last work "The Lost Symbol" has created some active discussions about the masonry in general and his well publicized support from many Masonic spokesmen may eventually create interest in the Fraternity itself.

Within the jurisdiction of New Brunswick there have been many published newspaper articles reporting on Masonic activities.

There have been articles on the seniors complex Quinn House in St. Andrews; on the successful fund raising event involving lodges Keith # 24; Coverdale # 52 and Acacia # 49 and the 170th Anniversary Special Communication of Freemasonry in New Brunswick held by Sussex Lodge # 4 in Dorchester while previously recorded interview with a Grand Master continues to be presented periodically on the Rogers network. We understand there may have been more but they were never brought to the attention of the Public Relations section of Grand Lodge.

Again Camp Goodtime 2009 received good coverage for Masons being the sole supporters of this endeavour through the New Brunswick Cancer Association.

The attempt to initiate the "History and Civics Challenge" involving the youth in grades eleven and twelve created very little interest amongst the brethren of this jurisdiction. Another option is being prepared in the hope of succeeding with this endeavour. The Board of General Purposes supported the concept wholeheartedly and it is for that reason I am exploring another avenue which may be more successful.

In the future more awareness will be directed to the scholarship distribution done through Grand Lodge each year which in most cases are seldom announced outside the Fraternity.

It is imperative the Public Relations section of this jurisdiction receives all newspaper articles which make reference to Freemasonry in the least way. By receiving that published material the Public relation section will be better informed of what is taking place throughout the province and be better equipped to inform others on a wider scale.

Remember we can only work with the information we are provided with from all lodges.

REPORT OF THE FOREIGN RELATIONS COMMITTEE

To: The Most Worshipful the Grand Master, Officers and Members of the Grand Lodge of New Brunswick, F. & A.M.

This report is an attempt by the Foreign Relations Committee to rectify discrepancies within the Grand Representative program and to bring up-to-date and accurate all of the information in the Grand Lodge Proceedings and the data sent to Masonic Services.

Notes:

Recognition Chart: Annually The Masonic Services Association Lodge of Research #1949 prepares a Recognitions Chart which lists all the foreign Grand Lodges recognized by the Grand Lodges of Canada. Statistics on this chart are collected from information supplied to the Research Lodge by each Grand Lodge jurisdiction.

Commission Annual Report: Annually a booklet is received in the Office of The Grand Secretary from the Commission on Information for Recognition of the Conference of The Grand Masters of Masons in North America. "This Commission neither advises nor recommends that recognition be given to any Grand Lodges, but merely indicates whether or not it considers that a Grand Lodge in question satisfies the conditions of regularity." The Foreign Relations Committee of the Grand Lodge of New Brunswick uses this Commission Report as the main reference when considering the request for recognition from a foreign lodge.

Requests for Recognition

The Most Worshipful Prince Hall Grand Lodge F&A Masons, Jurisdiction of North Carolina, Inc.

A request for recognition was received in October 2008. According to the 2003 Report from the Commission on Recognition: "It has become generally accepted that Prince Hall Freemasonry is regular in form and practice. Therefore, the question of regularity does not seem to be an issue any longer...We continue to be of the opinion that establishment of fraternal relationships with Prince Hall Grand Lodges remains the prerogative of each individual Grand Lodge." **It is hereby proposed by the Committee on Fraternal Relations** that full Masonic recognition of this Grand Lodge be granted and an exchange of Grand Representatives be recommended at the 2010 Grand Lodge.

Grand Lodge of Cyprus AF&A Masons

A request for the establishment of fraternal relations was received in December 2006. According to the Commission of Recognition in the 2007 and 2009 Report "there are now operating lodges under three Masonic obediences" within the nation of Cyprus which has given rise to some confusion and question regarding co-existence. Until these issues are settled according to the Commission Report the Committee is hesitant to extend fraternal relations at this time and a letter explaining this decision was sent to their Grand Secretary for External Affairs.

The Sovereign Grand Lodge of Malta AF&A Masons

A request for Masonic recognition was received in July 2009. The 2005 Report from the Committee for Recognition states: "The Sovereign Grand Lodge of Malta was constituted on November 18, 2004 by the Grand Lodge of Ireland. The new Grand Lodge consists of four craft lodges formerly under the Grand Lodge of Ireland and one formerly under the United Grand Lodge of England. The Sovereign Grand Lodge of Malta states that the principles of the Ancient Landmarks, usages and customs are strictly observed. The Commission is of the opinion that this Grand Lodge complies with all the required standards for recognition." **It is hereby proposed by the Committee on Fraternal Relations** that full Masonic recognition of this Grand Lodge be granted and an exchange of Grand Representatives be recommended at the 2010 Grand Lodge.

Grand Lodge of Slovenia

A request for official recognition was received in April 2007. According to the 2000 Report from the Committee on Recognition; "Freemasonry was sponsored in Yugoslavia, including Slovenia by the Grand Lodge of Austria. When Yugoslavia as a country was dissolved in 1991, the Grand Lodge of Austria continued its sponsorship of the Lodges in Slovenia and Croatia. The Commission is of the opinion that the Grand Lodge of Slovenia is regular and entitled to recognition." **It is hereby proposed by the Committee on Fraternal Relations** that full Masonic recognition of this Grand Lodge be granted and an exchange of Grand Representatives be recommended at the 2010 Grand Lodge.

Grand Lodge of Croatia of AF&A Masons

A request for formal Masonic relationship was received from this Lodge in November 2008. Like Slovenia, Croatia was sponsored by the Grand Lodge of Austria. Again in the 2000 Report from the Committee on Recognition it states: "The Grand Lodge of Austria chartered Lodges in Croatia which served as the founding Lodges for the Grand Lodge of Croatia when it was set to work by the Grand Master of Austria on November 7, 1997. The Grand Lodge of Croatia adopted the regulations, constitutions and ritual of the Grand Lodge of Austria. The Commission is of the opinion that the Grand Lodge of Croatia is regular and entitled to recognition." **It is hereby proposed by the Committee on Fraternal Relations** that full Masonic recognition of this Grand Lodge be granted and an exchange of Grand Representatives be recommended at the 2010 Grand Lodge.

Grand Lodge of Ukraine

We received a request for the establishment of fraternal relations in August 2007. In 2006 the Report from the Commission of Recognition stated: "The Grand Lodge of Ukraine was consecrated on September 24, 2005 by the Grande Loge Nationale Francaise and the Grand Lodge of Austria. This Grand Lodge was constituted from four Lodges previously constituted by the GLNF and one Lodge constituted from the Grand Lodge of Austria. The Commission is of the opinion that the Grand Lodge of Ukraine meets the standards for recognition." **It is hereby proposed by the Committee on Fraternal Relations** that full Masonic recognition of this Grand Lodge be granted and an exchange of Grand Representatives be recommended at the 2010 Grand Lodge.

Grand Lodge of Moldova

In April 2010 we received a request for recognition from the Grand Lodge of Moldova, a country in Eastern Europe. The 2010 Report of the Commission of Recognition states "since they are regular in all aspects of Masonic practice, they can now be considered to have met the standards for recognition." The Grand Lodge of England recognized Moldova in March 2010. **It is hereby proposed by the Committee on Fraternal Relations** that full Masonic recognition of this Grand Lodge be granted and an exchange of Grand Representatives be recommended at the 2010 Grand Lodge.

Grand Lodge of Iran (In Exile)

In 1981 at Grand Lodge, the Report of the Committee on Relationships with Foreign Lodges "recommended that the Grand Lodge of New Brunswick withdraw all recognition with the Grand Lodge of Iran. (It being noted all Lodges under the Grand Lodge of Iran have closed.)" The 2006 Recognition Commission Report writes the following: "During and following the revolution of 1978-79, the government banned the activities of the Grand Lodge within the country and all of the lodges were closed. A large number of brethren, including a great majority of the Grand Lodge officers and members of the Grand Committee, left the country, and thus the activities of the Grand Lodge

continued outside Iran...In 1985, The Grand Lodge of Massachusetts granted approval for the Grand Lodge of Iran (In Exile) to 'reestablish and continue, for the time being within the commonwealth of Massachusetts...' In the past, the Commission has never sanctioned recognition of any Grand Lodge in exile; however this Grand Lodge has six working lodges in the city of Boston, and has fraternal relations with forty Grand Lodges in this Conference, and many others around the world. The Commission is of the opinion that the Grand Lodge of Iran (In Exile) practices regular Masonry, and meets the standards for recognition." **It is hereby proposed by the Committee on Fraternal Relations** that at the 2010 Grand Lodge it be proposed to re-establish full fraternal relations with the Grand Lodge of Iran (In Exile) including an exchange of Grand Representatives.

Further Review of Foreign Lodges

In the 1958 Grand Lodge Proceedings, the Report of the Committee on Relations with Foreign Grand Lodges submitted a list of 35 foreign lodges and indicated whether or not they were worthy of Recognition. This list appears to be a direct result of a book published the same year by the Commission on Recognition which gave an extensive overview of Freemasonry around the world. It seems the Committee studied the book and reported a summary of the findings to the 1958 Grand Lodge.

The difficulty we now face lies in the fact that in several cases it is indicated on the Recognition Chart that New Brunswick recognizes a foreign lodge, and while the lodge is listed as worthy of Recognition based on this 1958 list, the Office of the Grand Secretary has no correspondence indicating a formal request for recognition was received from the foreign lodge.

Grand Lodge of Honduras (Founded 1922)Gran Logia Simbolica de Nicaragua A.F.&A.M. (Founded 1907)

Honduras and Nicaragua have not been reviewed in many years by the Commission. The advice from the Commission is that if a Lodge has not been recently reviewed or listed in the index, it is considered that the situation within the country is stable and the Lodge is assumed to be considered worthy of Recognition. **It is hereby proposed by the Committee on Fraternal Relations** a letter from the Office of the Grand Secretary be sent to the Grand Lodges of Honduras and Nicaragua indicating favourable consideration if a formal request to establish fraternal relations were to be received. The Recognition Chart has been corrected until such time as official fraternal relations are established.

Gran Logia de los AA. LL. y AA. MM. del Ecuador (Grand Lodge of Ecuador) (Founded 1921)

The situation in Ecuador is different. From the 2005 Commission Report "There are still two Grand Lodges in Ecuador that claim to be the legitimate authority for Masonry in that country. Last October, the Grand Masters of the two Grand Lodges signed a compromise that they will regularize the situation

by April 15, 2005. Until that occurs, the Commission is of the opinion that recognition of any Masonic organization in Ecuador should be delayed. If the compromise is achieved, the issue of regularity will then be addressed by the Commission." (There has been no further indication that this situation has been resolved.) The Committee on Fraternal Relation corrected the Recognition Chart to indicate that the Grand Lodge of New Brunswick does not recognize the Grand Lodge of Ecuador.

Grand Regular Lodge of Kingdom of Morocco (Grande Loge Reguliere due Royaume du Maroc) (Founded 2000)

The Commission Report writes in both 2003 and 2005 that while there are two Grand Lodges in Morocco there is an effort to unite the two bodies "but until that is accomplished, the Grande Loge Reguliere de Royaume du Maroc is still considered to be the recognized Grand Lodge in that country." Based on this information **it is hereby proposed by the Committee on Fraternal Relations** a letter from the Office of the Grand Secretary be sent to the Grand Regular Lodge of Morocco indicating favourable consideration if a formal request to establish fraternal relations were to be received. The Recognition Chart has been corrected until such time as official fraternal relations are established.

It is with pleasure that I submit this, my first, annual report as District Deputy Grand Master for District #2. First, I express my gratitude and pleasure at being entrusted with this responsibility. It certainly has been a worthwhile and rewarding learning opportunity during this first year. I have been impressed with the cooperation and courtesy extended to me by Masters, Wardens and members of the lodges in District #2 as well as the officers of the Grand Lodge of New Brunswick.

During the year, I have completed official visits to all lodges within the District with varying levels of participation. I am grateful to the brothers who have accompanied me to those visits. I have also attended most of the regular communications in both Districts 2 & 7. I have been pleased to participate in the presentation of long service recognition and other forms of recognition to many brothers. Keith Lodge and Westmorland Lodge have each scheduled emergent meetings to deal with installations and degree work and it has been my pleasure to participate in each as requested.

R:W:B: Ted White, DDGM for District #7, and I have continued the recent pattern of Joint District Council meetings and have found them to be highly productive and creative. Through these meetings, we continue to modify the Travelling Gavel process so that each lodge now has the opportunity to deliver the Gavel to another lodge in one of the two districts and to offer Masonic Education as a part of that event. The lodges have reacted very positively and it has generated an increased level of interest. R:W:B: White and I have also begun a series of Masonic Learning in regular lodge communications. Upon the invitation of the lodge, we will offer Masonic Education, Training and Officer Training as a part of the regular communication. To date, we have offered a session at Harmony Lodge #20 in the fall and Coverdale Lodge #52 in the winter. We also have another scheduled for May at Keith Lodge #23. These have been very well attended and the participation of the brethren in attendance has been impressive. A lot of Masonic Learning occurs. The feedback has been very positive with Worshipful Masters expressing interest in hosting a session. The focus has been on Floor Work and Ritual, Effective Meetings and open discussions on points of Masonic interest. The events have been structured and well planned. The floor has been open for feedback throughout the sessions. I believe that one of the significant factors in success is this openness rather than strictly lecture or presentation mode.

The lodges in District #2 have been active in fundraising and charity functions. All participate in supporting Camp Goodtime through special events such as Keith, Coverdale and Acacia in their joint dinner/dance, Westmorland

with the Danny Allen breakfast and Zetiand, Lodge St. Andrew and Sussex holding dinners and/or breakfasts. Most of the lodges are on solid, if not affluent, financial footing although there are concerns about buildings, regalia replacement and other routine financial matters. Three lodges have held Church Parades. Lodges honor the widows of departed brethren in a variety of ways, usually at Christmas time through cards and/or flowers/gifts.

I am concerned about three lodges and declining participation and new members. Although getting new members does not necessarily mean increased participation, our aging membership demands that new members join the fraternity and continue the work. We need to focus as much on getting more Masons attending regular communications as in getting new members to join. It is my hope that all lodges will enthusiastically adopt the GLNB 5 Year Plan and adapt the targets to meet their needs. Without this type of commitment, some of our lodges will have to seriously assess their viability.

In closing, I once again, express my gratitude for the trust placed in me and reiterate that I have undoubtedly gained more from this experience than I have given. Thank you for the support and hospitality. I look forward to the next year.

**REPORT OF THE DISTRICT DEPUTY GRAND MASTER
DISTRICT NO. 3**

To: The Most Worshipful the Grand Master, Officers and Members of the Grand Lodge of New Brunswick, F. & A. M.

The 2009/2010 year had accomplishments which enhanced and advanced Masonry in the district.

The reintroduction of the "travelling Gavel" brought about an increase in visitation among the lodges as did the introduction of the practice where the gavel of a lodge may be confiscated by a visiting sister lodge within the district if the visiting lodge has at least five brethren in the visiting group. In order to retrieve their gavel the lodge whose gavel has been confiscated must pay a return visit with at least five brethren and reclaim their gavel.

Since my installation in October 2009 I visited all the lodges in the district. I attended all the meetings with the exception of two and have completed two official visits. The remaining two official visits will be completed in April 2010.

I attended all the installation of officers including two very impressive semi-public installations in Campbellton and Northumberland Lodges.

Campbellton Lodge # 32 held two emergency meetings to confer an entered apprentice and Master Mason degree on two candidates. These degrees were performed with exceptional and flawless ritual work from which the candidates received without question the best information and degree work possible.

A district meeting was held on November 5, 2009 in Bathurst with the Most Worshipful the Grand Master in attendance. Several informative and well delivered Masonic educational presentations highlighted a well attended and successful meeting.

The two lodges in the Miramichi area, Miramichi Lodge # 17 and Northumberland Lodge # 18 received most positive news as they learned that a building in Douglstown is available at no cost for maintenance or operation to both lodges for lodge rooms and meetings. This resolved the financial problems facing Miramichi Lodge # 17.

Lodge St John #27 suffered extensive humidity damage to the banquet room and experienced financial delays to complete repairs. At the time of this report financing has been resolved and the repairs and renovations are now underway. The hall will soon be back and running and there are many events planned. The lodge has initiated Wednesday lunches which have an average attendance of ten brothers and guests and are creating more fellowship within the lodge.

Campbellton Lodge # 32 is a very active lodge with wonderful fellowship as is demonstrated by the many banquets and take-out meals prepared and served by the brethren. This is the main fund raising activity which is necessary to offset the cost of operating and maintaining the lodge building.

I observed degree work in all lodges and it is very well done as most officers doing the work are well experienced veterans of ritual work. Campbellton Lodge #32 have two exceptional officers, W B John Wood and W B Brian Firth who have performed the first and third degree ritual and lectures without prompting whatsoever and is truly an unbelievable experience for any mason to observe. It should be noted here that all lodges have first-time officers who are doing excellent work.

All Masters are knowledgeable in ritual and show dedication to their lodges, officers and brethren.

One observation concerning the district and finding candidates. The lack of meaningful employment causes most young men to leave the district to seek employment therefore suitable candidates for freemasonry are few and far

between. Despite this most lodges in the district have managed to initiate suitable young masons.

A meeting is in the planning stages for the month of May. The purpose of this meeting will be to discuss the five year plan, to share ideas on what is being sought from the lodges to understand the five plan document. All masters and officers of the four lodges in the district will be asked to be present as well as any of the brethren who are interested may attend. Although nothing is final, a meal and an evening of entertainment supplied by musicians who are lodge brothers is planned.

I had the pleasure and privilege to present two fifty year pins and certificates as well as a sixty year pin to three brothers of the district. Outstanding landmarks which are difficult to attain, again congratulation brothers.

In summary, many changes took place in the district. Some created problems which were resolved and some were welcomed. Fellowship has increased dramatically both at the district level and within the lodges and should continue as such.

I would like to acknowledge all the brethren of the district and Grand Lodge Officers who supported me in my first year as DDGM. It is indeed a pleasure working with you.

REPORT OF THE STRATEGIC PLANNING COMMITTEE GLNB 5-YEAR PLAN

To: The Most Worshipful the Grand Master, Officers and Members of the Grand Lodge of New Brunswick, F. & A.M.

Preamble

The following submission is the result of many visits to lodges throughout the jurisdiction and the input from lodges and individual masons. I have attended lodge meetings in all districts in the jurisdiction as well as District Council Meetings in three districts (my own included). I have spoken with very many masons after meetings during refreshment and have received written input from 11 lodges. I believe that this submission represents the general consensus of Masons in New Brunswick.

It should be pointed out that the input from lodges and individuals addressed various aspects of a strategic plan. For that reason, I will briefly outline the format of a plan that seems to have received general agreement.

It is also important to acknowledge the considerable input and advice received from the members of the committee who volunteered their participation at various points throughout the process and whose input, especially in the developmental stages, was vital to this product.

Format for Strategic Plan

1. **Mission and/or Vision Statement**
2. **Goals/Objectives**
3. **Strategies**
4. **Tactics**
5. **Timelines/Accountabilities**

This submission

The mission of the GLNB has been previously established and it was not the objective of this project neither to review it in depth nor to recreate it.

The overall goals and objectives will be identified, as specifically as possible and are recommended for inclusion in this 5-year plan.

Some overall strategies are recommended that deal with the goals/objectives.

If accepted, this document must provide the underlying foundation for the development of this fraternity for the next 5 years. It should be reviewed and reported on annually the Grand Master, his designates and to Grand Lodge. Blue Lodges should be held accountable for the development of tactics that will support the Goals/Objectives of the GLNB. Also Blue Lodges should report through their DDGM, their progress to achieving their targets.

Working together with all lodges contributing to all strategies, the goals may indeed prove to be modest. The 5-year plan, on its annual review may be extended for another year which would make it a living document that is always a 5-year plan that will not require major adjustment (maybe a major review every 5 years.).

The Timelines and Accountabilities are built into the Tactics. The Tactics will be developed at the Grand Lodge, District and Lodge levels to deal with issues within each of their purviews. The Grand Lodge Tactics are intended to facilitate the tactics of the districts and lodges and, likewise, the District Tactics are intended to facilitate the tactics of the lodges. Suggestions will be offered at the conclusion of this document. It will be the challenge (and opportunity) for lodges to be specific as to how their tactics will address the needs of their lodge and, subsequently, the Grand Lodge of New Brunswick. For example, the target growth of 10% translated to some lodges will be ridiculously low. In that case, set the target higher so that you likewise contribute even more to the overall growth. Even for small rural lodges a 10% growth is a reasonable target with effort and commitment. For example, a lodge starts with 50 members. A 10% growth represents 5 additional

members over 5 years. Factoring in deaths, it will likely mean more but there is a way to address the issues of demits, suspensions and new members that will work in that locale. We will offer some suggestions. The suggestion list is certainly not intended to be restrictive nor exhaustive. Nor is it a suggestion that these ideas are the "best" or most effective ideas.

It is also a recommendation that an ongoing accountability be assigned at the Grand Lodge level to oversee the ongoing development of the Strategic Plan and report back to the Grand Master and Grand Lodge with respect to development and achievement. Possibly, establishing and achieving targets related to the GLNB 5 year plan could be factors in the Grand Master's Award program.

GLNB 5 Yr Plan

To improve life by improving the men who live it while never losing sight of the need to preserve the past, serve the present and prepare for the future.

Vision Statement of the Grand Lodge of New Brunswick

To create a strong and viable Fraternity made up of men who practice the principles of Freemasonry, who have a strong desire for self-improvement, thus making a positive difference in the quality of life in New Brunswick.

Mission Statement

To provide a strong and visible leadership to the Masons of New Brunswick, by developing and initiating programs which will enhance leadership, knowledge, member satisfaction, communication and cohesion among the constituent Lodges of the Grand Lodge. We will strive to maintain our status as the Fraternity of choice for men in New Brunswick. We will continue to actively promote and preserve Brotherly Love, relief, truth, morality and friendship among our membership.

Goals/Targets

1. To increase membership in GLNB by 10% by 2015.
2. To increase attendance at blue lodges by an average of 25% by 2015.
3. To develop regular programs for inclusion at Lodge Communications that focus on the proper use of Masonic ritual and protocol, Masonic education and Masonic training.

Strategies

Strategies will be the overall systems put into place that will address the Goals/Targets. Strategies will not be specific in terms of the actions/tactics that need to be put into place.

1. Each lodge will establish and implement a structure to address the issue of attracting new members.
2. Grand Lodge will establish and implement communication and promotional programs that will support the lodges in attracting new members.
3. Lodges will establish programs to increase attendance at regular communications.
4. Lodges will design regular meetings that will make effective use of time and include, as a primary component, education and training.
5. Grand Lodge will develop a monitoring and accountability system for the implementation and evaluation of this plan.

Actions/Tactics (The "Tool Kit")

The following are suggestions for consideration. The list is not intended to be exhaustive. These are ideas that many lodges are considering and/or implementing. Lodges will develop tactics based on their individual needs and abilities. It is important that each lodge develop tactical plans that include timelines and accountabilities. The overall topic of Tactical/Action Plan Development may, in fact, be a good part of a program in a regular communication. However, the development of the plan in its specifics should not occur at regular communications. It is suggested that committees/groups of individuals be given responsibility for the development and recommendation of tactical/action plans and that plans be completed and ready for implementation in 2011.

Some tactics will fit into more than one category. This is intended as a "Tool Kit" from which lodges may select the most appropriate in their situation.

A. Membership Tactics

- a. Promotional programs in local papers, newsletters, etc. This can be done at the Grand Lodge, District and Lodge level.
- b. Informational sessions designed to inform the public on the nature of Freemasonry.

- c. Active support and involvement in Demolay and Rainbow groups. We know that many Demolay members and family members become Masons.
- d. Active involvement in community activities and community support. Lodges can become involved as lodges and be noticeable in that involvement. Camp Goodtime, Haitian relief, etc.
- e. What Can I Say? What Should I Say? Grand Lodge can provide leadership in the development and distribution of information concerning what should and could be said in talking to a person about becoming involved in Freemasonry.
- f. Distribution of Mostly Masonry beyond the bounds of the fraternity. Identify key target groups for distribution.
- g. Develop formal processes to be implemented prior to the issuance of a demit or the suspension of a member.
- h. Become involved in local Lifestyle shows.
- i. "Friend to Friend" nights.
- j. Opening the lodge building for public tours and information sessions.
- k. GLNB become active and regular contributors to provincial media. Local lodges become likewise involved in local media.
- l. Improve internet access by establishing lodge webpages with links and information re contacts on the GLNB site.
- m. Ensuring that information about local lodges, meeting dates and times, contact persons, etc. is prominent in municipal information packages, telephone directories, etc.
- n. Establish Masonic book lending programs to which interested persons may have access.
- o. Ensuring that Masonic information and contact information is available at fund raisers.
- p. Post information on outside of lodge door that identifies contact persons, meeting times, etc.

B. Attendance

- a. Establish a Master Mason's Rookie Award (Districts 2 & 7 are experimenting with this.)
- b. Establish a visitation and contact plan that ensures that every lodge member is contacted regularly concerning lodge activities, etc.
- c. Design effective meetings that consider the attendance of visitors and the needs/interests of members.
- d. Design and implement improved lodge bulletins that are invitational and that reflect the nature and content of the lodge meetings.
- e. Develop and implement websites that are prominent and accessible. The Websites should be maintained and current and inform visitors as to contact information, meeting information and sources of Masonic information. The websites should also clearly identify the role of the local lodge, GLNB and Freemasonry in community.
- f. Training and information with respect to the roles of officers.
- g. A well governed lodge is an enjoyable lodge. Masters need to understand and implement meeting procedures that maintain a pleasant, informative and enjoyable atmosphere.
- h. Effective use of Mostly Masonry for the distribution of Masonic information, lodge information and education.
- i. Implementation of the mentor program.
- j. Poll members to determine interests, concerns, etc.
- k. Ensure that rehearsals and practices are regularly held even for routine matters so that all attendees can be satisfied that ritual will be well conducted.
- l. Consider various forms for handling of minutes either by summary, pre-distribution, minute writing training so that the reading/confirming of minutes can be handled in the minimal amount of time.

- m. Conduct recognition ceremonies for long service, etc. at times and places where families and friends can participate.
- n. Attempt to address accessibility issues.
- o. Establish and implement telephone committees to inform members of upcoming events, meetings and changes.
- p. Establish programs that recognize and honour the families of departed brethren.
- q. Implement re-training programs such as the "Rusty Nail" ritual for the re-integration of members who are not comfortable with their knowledge of Masonic ritual.
- r. Establish regular lodge dinners for members.
- s. Redesign post-meeting refreshment so that it is more organized (sit down) and greetings, announcements, etc may be a part.
- t. Implement a transportation system that arranges for brethren to be transported to and from lodge if required.

C. Program

- a. Become acquainted with and use Grand Lodge Training and Education resources.
- b. Establish an annual plan for lodge program.
- c. Actively recruit involvement from members in the planning and implementation of program. Pay special attention to new members but don't forget the more seasoned and experienced members.
- d. Arrange for Guest Speakers on topics of current interest.
- e. Establish District Degree Teams.
- f. Ensure that adequate and appropriate rehearsals and practices take place.
- g. Ensure that ritual work is conducted well and with appropriate support.

- h. Use the Officers' Manual as a resource for training programs.
- i. Assign a lodge responsibility either through committee or individuals for the development and implementation of a program. Clearly, the Master must be an integral part of this process.
- j. Ensure that the lodge program is well and timely advertised throughout the membership of the lodge and district.
- k. Schedule degree work so that it is not the only activity that occurs in a lodge. The judicious use of emergent meetings is recommended when lodges have many new members.
- l. Use the Travelling Gavel as a program opportunity.
- m. Table Lodge.

Summary

This plan can be effective in achieving the established goals. However, that will only happen with the active participation and commitment of local districts, lodges and individual masons. While GLNB can and must provide the support for these things to happen through the development and improvement of resources, it is only at the local lodge and district levels that most of the initiatives can occur. For this plan to be effective, the GLNB must be insistent on the participation of individual lodges. The accountabilities that are established must be clear and unambiguous.

This plan is the result of considerable input from individual masons and lodges throughout the province. It should not be permitted to become just one more approved document with no active reinforcement and expectation. This document cannot be seen as restrictive but as liberating. Lodges must feel the freedom to address the 3 Goals/Targets and the Strategies in a manner that is most effective for them. I believe that each lodge should establish challenging targets together with indicators and "measurables" on an annual basis and that GLNB should have annual targets associated with the goals/targets. It may be that we will fall short of some of the annual targets but if our commitment is firm, we will develop tactics to adapt and achieve the overall goals/targets.

REPORT OF THE GRAND LODGE ARCHIVE COMMITTEE

To: The Most Worshipful Grand Master, Officers and Members of the Grand Lodge of New Brunswick, F. & A.M.

I beg leave to submit the annual, though somewhat short, report of the Grand Lodge Archive Committee.

The cataloguing of archival materials is an ongoing project with no definitive conclusion. When a lodge goes dark, such as in the case of Sunset Lodge in Campobello, there is a requirement to catalogue the records of the lodge and place them in our archives.

In addition to the regular cataloguing of records there are also special projects to be undertaken. One such project is the creation of a database of all those who have been members of the craft in this province. From the time of the arrival of the Loyalists through to the current day there have been approximately 33000 Masons in the Province of New Brunswick. To facilitate the commencement of this project RWB Ches Piercey has designed a database format to be used in recording the basic information of each brother. Given the sheer magnitude of the project it should come as no surprise that it will require several years of ongoing effort to complete. When the project is completed the information contained within the database will be of a particular benefit when fielding genealogical inquiries.

Several months ago Mrs. Jayne Jones of the Grand Secretary's office discovered several wrapped packages in a storage cupboard. The packages contained the minute books of the Board of General Purposes dating back to 1868. Previously thought to have been lost, these valuable records have now been catalogued and placed in the Grand Lodge vault.


